An act relating to the regulation of toxic substances and hazardous materials

The Senate concurs in the House proposal of amendment with the following proposal of amendment thereto:

<u>First</u>: By striking out "<u>Intergovernmental</u>" wherever it appears in the bill and inserting in lieu thereof <u>Interagency</u>

<u>Second</u>: In Sec. 1, 10 V.S.A. § 6633, in subsection (b), after the word "following" by striking out "nine" and inserting in lieu thereof eight

and by striking out subdivisions (b)(1) and (2) in their entirety and renumbering the remaining subdivisions in subsection (b) to be numerically correct

and by striking out the period after the renumbered (b)(7) and inserting in lieu thereof a new semicolon

and by adding a new subdivision (b)(8) to read:

(8) the Secretary of Transportation or designee.

<u>Third</u>: In Sec. 1, 10 V.S.A. § 6633, in subdivision (f)(2), after "<u>July 1</u>,", by striking out "<u>2017</u>" and inserting in lieu thereof <u>2018</u>

<u>Fourth</u>: In Sec. 2 (Intergovernmental Committee on Chemical Management report), in the first sentence, after "<u>February 15</u>," by striking out "2018" and inserting in lieu thereof 2019

<u>Fifth</u>: In Sec. 4 (ANR groundwater source testing rule), in the first sentence, by striking out "2017" where it appears and inserting in lieu thereof 2018

and in the second sentence, by striking out " $\underline{2018}$ " where it appears and inserting in lieu thereof $\underline{2019}$

Sixth: In Sec. 9 (Effective Dates), by striking out subsection (b) in its

entirety and inserting in lieu thereof the following:

- (b) Sec. 3 (groundwater source testing) shall take effect on July 1, 2019, except that 10 V.S.A. § 1982(e) shall take effect on passage.
 - (c) All other sections shall take effect on July 1, 2018.

Rep. Grad of Moretown, for the Committee on Judiciary, recommends that the House propose to the Senate that the bill be amended as follows:

<u>First</u>: In Sec. 1, 13 V.S.A. § 4053, in subdivision (c)(2)(A)(ii), by striking out "<u>intended to place</u>" and inserting in lieu thereof "<u>placed</u>"

Second: In Sec. 1, in 13 V.S.A. § 4053, in subdivision (e)(1), by striking out "at the time of the hearing"

<u>Third</u>: In Sec. 1, in 13 V.S.A. § 4053, in subdivision (e)(2), by striking out "60 days" and inserting in lieu thereof "six months"

<u>Fourth</u>: In Sec. 1, 13 V.S.A. § 4054, in subdivision (a)(1), at the end of the subdivision, by striking out "<u>filed</u>" and inserting in lieu thereof "<u>submitted</u>"

<u>Fifth</u>: In Sec. 1, 13 V.S.A. § 4054, in subdivision (b)(1), at the end of the subdivision, after the word "<u>title</u>" by inserting ", and the court shall deliver a copy to the holding station"

<u>Sixth</u>: In Sec. 1, 13 V.S.A. § 4054, in subdivision (b)(2)(A)(ii), by striking out "<u>intended to place</u>" and inserting in lieu thereof "<u>placed</u>"

<u>Seventh</u>: In Sec. 1, in 13 V.S.A. § 4055, in subdivisions (b)(1) and (b)(2), by, in each instance, striking out "<u>60 days</u>" and inserting in lieu thereof "<u>six</u> months"

<u>Eighth</u>: In Sec. 1, in 13 V.S.A. § 4056, in subsection (a), in the second sentence, after the word "<u>service</u>" by inserting "<u>, and shall deliver a copy to the holding station</u>"

Ninth: In Sec. 1, 13 V.S.A., after § 4060, by inserting a § 4061 to read as follows:

§ 4061. EFFECT ON OTHER LAWS

This chapter shall not be construed to prevent a court from prohibiting a person from possessing firearms under any other provision of law.
