House concurrent resolution congratulating 2018 Winter Olympics gold medal winners Jessie Diggins, Amanda Pelkey, and Mikaela Shiffrin

Offered by: All Members of the House

Whereas, although the sport of cross-country skiing has long been a centerpiece of Winter Olympics' lore, until 2018, no American women cross-country skiers had ever won a medal, be it gold, silver, or bronze, in this event, and

Whereas, in 2018, Jessie Diggins, who resides and trains in Stratton, was a member of a two-person cross-country ski team that corrected any false impressions of the sport's American competitors' skills, winning the gold medal in the women's team sprint freestyle, and she was especially honored to be named as the United States flag bearer for the closing ceremonies, and

Whereas, Montpelier's Amanda Pelkey is a University of Vermont graduate who set the school's women's ice hockey team's records for goals (49), assists (56), and points (105), and

Whereas, Amanda Pelkey was a member of the 2015–2016 National Women's Hockey League's Boston Pride that clinched the League's inaugural championship, and

Whereas, she was a proud member of the 2018 U.S. Olympic gold medal women's ice hockey team, the first in 20 years, that defeated Canada in a thrilling 3–2 overtime contest, reversing the outcomes of the 2010 and 2014 gold-medal games, and

Whereas, as a student at Burke Academy, Mikaela Shiffrin demonstrated her alpine skiing prowess in 2013, becoming the fourth youngest woman to win a World Cup title, the first American World Cup slalom champion since 1983, and has continued to excel in World Cup competition, and

Whereas, at the 2014 Winter Olympics in Sochi, Russia, Mikaela Shiffrin won the gold medal in the women's slalom, and

Whereas, Mikaela Shiffrin was a medal favorite at the 2018 Winter

Olympics in PyeongChang, South Korea, and departed for home with both a gold medal in the women's giant slalom and a silver in the alpine combined competition, and

Whereas, these women were great representatives of Vermont and demonstrated why the Green Mountain State is a center of winter athletic competition, now therefore be it

Whereas, since 1964, the VGA Scholarship Fund has awarded in excess of \$1.3 million to graduates of Vermont high schools who are pursuing a college education, and

Whereas, in 1930, the Vermont State Women's Golf Association was created to encourage women to play the game of golf and sponsors events for women golfers, and

Whereas, the Vermont chapter of the Professional Golfers Association of America was organized in 1965 and in 1982 became a chartered member of the New England Professional Golfers Association, and

Whereas, the Vermont Senior Golf Association represents the interests of Vermont's senior golfers, and

Whereas, in 1977, the Vermont Golf Course Superintendents Association was founded to promote the art and science of golf course management, and

Whereas, the golf courses in Vermont annually generate revenue in excess of \$61 million, are responsible for over 1,850 jobs representing \$28 million in wages, and raise more than \$2 million for charitable purposes, and

Whereas, approximately 90 elementary schools and Norwich University participate in the First Tee National School Program for aspiring young golfers, and

Whereas, today, April 19, the economic and historic importance of golf in Vermont is being celebrated at the State House, now therefore be it

Whereas, his leadership was essential for the Council's restoration of and relocation to a Victorian mansion in Montpelier for its headquarters in 2005, and

<u>Whereas</u>, the First Wednesdays series, which Peter Gilbert created, offers prominent authors, journalists, and other speakers in exciting presentations at selected public libraries, and

Whereas, he started the Vermont Reads program in which children and adults throughout the State read the same book, and

Whereas, from 2010 to 2015, during the sesquicentennial observance of the Civil War, the Council offered the Civil War Book of Days e-mail series, and

<u>Whereas</u>, Peter Gilbert is a frequent Vermont Public Radio commentator, the author of the book *I Was Thinking*, *Travels in the World of Ideas*, the executor of the Robert Frost Estate, and has served on the Board of the Federation of State Humanities Councils, and
