#### H.C.R. 361.

House concurrent resolution congratulating the 2017 West Rutland High School Golden Horde Division IV girls' championship softball team

Whereas, the 2017 West Rutland High School softball team included a contingent of outstanding senior athletes, who, despite competing together for four years in several varsity sports, had never won an athletic championship, and

Whereas, not surprisingly, as the top-seeded team in the 2017 Division IV softball playoffs, the Golden Horde secured a berth in the championship game, played in Poultney against the third-seeded Whitchester Mountaineers (the recently formed joint team representing Whitcomb and Rochester high schools), and

Whereas, the Mountaineers opened the fifth inning with the game's first three runs, the Golden Horde responded with four runs, and, with the game tied in the bottom of the sixth at six-all, West Rutland scored the tie-breaking run, winning a 7–6 game victory and the 2017 Division IV title, and

Whereas, the winning West Rutland players were Brooke Raiche, Katie Callahan, Lauren Harvey, Julia May, Kelsey Wedin, Abby Kukene, Maddison McGuiness, Robyn Bradley, Shelby Grabowski, Rebecca DeKalb, Isabella Turner-Burrell, Lily Turner-Burrell, Deanna Kenyon, Bailey Sevigny, Becky Sanderson, Alana Raymond, and Kiera Pipeling, and

Whereas, coaches Carl Serrani and Laurie Serrani were superb team strategists, and student manager Kaylee Svitak was a valued team resource, now therefore be it

House concurrent resolution congratulating the Migrant Justice organization on the progress achieved with its Milk with Dignity Program

Offered by: Representatives Morris of Bennington, Gonzalez of Winooski, Ancel of Calais, Botzow of Pownal, Briglin of Thetford, Buckholz of Hartford, Burke of Brattleboro, Chesnut-Tangerman of Middletown Springs, Christie of Hartford, Colburn of Burlington, Copeland-Hanzas of Bradford, Gardner of Richmond, Haas of Rochester, Head of South Burlington, Hooper of Montpelier, Jessup of Middlesex, Krowinski of Burlington, Lippert of Hinesburg, Masland of Thetford, Ode of Burlington, O'Sullivan of Burlington, Partridge of Windham, Scheu of Middlebury, Squirrell of Underhill, Stevens of Waterbury, Sullivan of Dorset, Sullivan of Burlington, Toleno of Brattleboro, Weed of Enosburgh, and Yantachka of Charlotte

Whereas, Migrant Justice, an organization established to empower Vermont's migrant farm workers, who are predominately undocumented, from Mexico, and work on dairy farms, has established the Milk with Dignity Program and its complementary Code of Conduct (Code), and

Whereas, under the Code, participating farms are required to: abide by all applicable laws, codes, and regulations regarding working conditions; have zero tolerance for forced labor, unlawful child labor, sexual or physical assault, and retaliation against workers for employment-related advocacy activities; and limit the discharging or disciplining of workers, except for just cause and through a process that is fair to the employee, and

Whereas, among the Code's provisions are: dignified wages that at least equal the statutory minimum wage, even if farm workers are exempted; dignified schedules that include time for rest and leisure; dignified housing, meaning that any housing provided must comply with all housing laws, be voluntary, and afford the workers full tenants' rights, and

<u>Whereas</u>, the Code also requires healthy, safe, and secure workplaces, including workers' compensation; a minimum of five paid sick days per year; protective equipment; and health and safety training that is presented in a manner migrant workers can comprehend, and

Whereas, the Code requires that worker–employee relations be conducted in a cooperative and transparent manner and that a process for resolving Code violations be established, and

Whereas, on October 3, 2017, after two years of negotiations, Ben & Jerry's signed an agreement with Migrant Justice requiring that milk in the ice cream producer's supply chain be from dairy farms that provide their workers one full day off each week; a minimum of eight hours between shifts; and housing that includes electricity, running hot water, and real beds, and

Whereas, the Code will continue to be developed over time through a detailed dialogue between migrant farmworkers and farmers, and it is intended to ensure the fundamental conditions that all workers, regardless of their status, should expect, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the Migrant Justice organization on the progress achieved with its Milk with Dignity Program, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Migrant Justice and Ben & Jerry's.

#### H.C.R. 363.

House concurrent resolution honoring Vermont high school students who have achieved fluency in world languages other than English, and welcoming the establishment of a Vermont Seal of Biliteracy

Offered by: Representatives Kimbell of Woodstock, Beck of St. Johnsbury, Juskiewicz of Cambridge, and Toll of Danville

Offered by: Senators Baruth, Clarkson, and Kitchel

Whereas, the study of world languages should be encouraged because it contributes to a pupil's cognitive development, advances our place in our interconnected world, and represents a rigorous academic standard for every Vermont student, and

Whereas, maintaining proficiency in a child's native language is crucial for a student's academic success, and

Whereas, beyond maximizing a student's native language skills, developing fluency and literacy in a second or even a third language is a worthy academic challenge, and

Whereas, the benefits to employers whose staff is bilingual or multilingual are many, including an easier ability to expand into and transact business in

international markets and work with staff members from abroad, and

Whereas, in collaboration with the Vermont Foreign Language Association, schools and school districts across the State are planning to establish, in the 2018–2019 school year, a Vermont Seal of Biliteracy to recognize students who demonstrate proficiency in English and at least one other language, and

Whereas, the criteria to determine eligibility for this recognition include: achieving a designated scoring threshold on either an Advanced Placement or Scholastic Aptitude II subject examination; earning a proficiency level score on an American Council on the Teaching of Foreign Languages Assessment of Performance Toward Proficiency in Languages or on another internationally recognized language proficiency test; achieving a specified cumulative grade point average in a sequence of foreign language and English courses that a local school board approves; and completion of a portfolio project consisting of a student presentation, an interview, and a writing sample, and

Whereas, the proposal envisions that those schools and school districts participating in the Vermont Seal of Biliteracy program would be entirely responsible for the implementation of the program in their respective jurisdictions, now therefore be it

## Resolved by the Senate and House of Representatives:

That the General Assembly honors Vermont high school students who have achieved fluency in one or more world languages, other than English, and welcomes the establishment of a Vermont Seal of Biliteracy program, and be it further

## H.C.R. 364.

House concurrent resolution congratulating the Clemmons family of Charlotte and its A Sense of Place project on winning a National Creative Placemaking Fund grant

Offered by: Representatives Morris of Bennington and Yantachka of Charlotte

Whereas, for half a century, Dr. Jackson and Lydia Clemmons of Charlotte have been one of the few African-American farm owners in Vermont, and

Whereas, with their daughter, Lydia, serving as executive director, they are planning *A Sense of Place*, a project celebrating the family's African-American heritage and the farm's agricultural setting, and

Whereas, ArtPlace America (ArtPlace), a collaborative endeavor of foundations, federal agencies, and financial institutions utilizes a creative process known as placemaking to include arts and culture as a core element in community development, and

Whereas, ArtPlace's National Creative Placemaking Fund (Fund) awards grants that finance arts and cultural components in community development projects, with an emphasis on cultural, physical, and social identities that define a place, and

Whereas, of the nearly 1,000 applicants that the Fund's reviewers considered in 2017, the Clemmons Family Farm and its idea for *A Sense of Place* project was one of the 23 grant winners, and

Whereas, A Sense of Place will collaborate with local organizations including: Burlington City Arts, serving as the project's fiscal agent and financial manager; Building Heritage, preserving and upgrading the farm's historic barns; Champlain College, developing on-site African-American literature, spoken word, media, and communication programs; INSPIRIT, A Dance Company, presenting and choreographing African-American dance, theatrical, and community engagement programs at the farm, and

Whereas, A Sense of Place will offer "rich multicultural experiences and quality interactions among" the farm's artists and visitors, and

Whereas, the Clemmons Family Farm will become an African-American cultural center integrated into a distinctive Vermont agricultural milieu, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the Clemmons family of Charlotte and its *A Sense of Place* project on winning a National Creative Placemaking Fund grant, and be it further

House concurrent resolution congratulating Cadence Wheeler of Springfield on his jumping achievements at State and New England indoor track and field championship meets

Offered by: Senators Clarkson, McCormack, and Nitka

Whereas, as a student at Springfield High School, Cadence Wheeler's achievements as a jumper at the past two Vermont high school track and field indoor state championship meets, held at the University of Vermont's Gutterson Fieldhouse, have been notable, and

Whereas, in 2017, when only a freshman, Cadence Wheeler introduced himself to the Vermont's track and field community, winning the Division II triple jump competition, and

Whereas, in 2018, as a sophomore, the more experienced Cadence Wheeler returned to Gutterson Fieldhouse, and he scored even more significant victories, and

Whereas, he won top honors in the Division II long jump competition, with his best distance of 19' 7.5"; a mark that ranked second among both Division I and Division II competitors and that earned him a berth at the New England interscholastic indoor track and field championship meet in Boston, where he recorded a jump of 19' 0.25", and

Whereas, in the 2018 State meet's triple jump competition, not only did Cadence Wheeler repeat as the Division II winner, but he also set an indoor Division II record with a distance of 40' 5.5", and

Whereas, at only the midway point of his high school track and field career, Cadence Wheeler has already demonstrated his skill as a jumper and has the potential to earn more victories during his junior and senior years, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates Cadence Wheeler of Springfield on his jumping achievements at State and New England indoor track and field championship meets, and be it further

#### H.C.R. 366.

House concurrent resolution honoring former South Burlington Fire Captain Gary Rounds for his exemplary municipal public service

Offered by: Representatives Head of South Burlington, LaLonde of South Burlington, Pugh of South Burlington, and Townsend of South Burlington

Whereas, at 17 years of age, Gary Rounds followed his father into the

South Burlington Highway Department, extending his family's municipal service into a second generation, and

Whereas, when the South Burlington Fire Department was organized in the early 1970s, many Highway Department personnel served as volunteer firefighters, including Gary Rounds, who was appointed a captain of the on-call firefighters, and

Whereas, Gary Rounds found great satisfaction in performing his firefighting duties, and in 1985, his quest to become a full-time member of the city's firefighting service was realized, and

Whereas, Gary Rounds' firefighting skills and commitment to duty earned him the senior leadership assignment of Shift 2 Captain, and

Whereas, one of his enduring accomplishments was the establishment of the South Burlington Fire Department's junior firefighter program that enables high school students to provide assistance to professional firefighters, serve their community, and be introduced to a career option, and

Whereas, he originated the annual 9/11 Memorial Service, conducted in South Burlington's Overlook Park, as a tribute to the 412 brave first responders who sacrificed their lives on that fateful day at New York City's World Trade Center, and

Whereas, after 47 years and one day as a highly respected South Burlington city employee, including 32 years as a superb full-time firefighter, Captain Gary Rounds has responded to his department's fire alarm for the final time and looks forward to new life adventures, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors former South Burlington Fire Captain Gary Rounds for his exemplary municipal public service, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Gary Rounds and the South Burlington Fire Department.

#### H.C.R. 367.

House concurrent resolution commemorating the 80th Anniversary of the Castleton Colonial Day Historic House Tour

Offered by: Representatives Helm of Fair Haven and Canfield of Fair Haven

Whereas, in 1761, New Hampshire Governor Benning Wentworth granted a charter to Samuel Brown and 40 other proprietors for the town of Castleton,

making this Rutland County municipality one of the oldest in Vermont, and

Whereas, in May 1775, Ethan Allen and approximately 250 American troops, including Green Mountain Boys as well as the later infamous Benedict Arnold, encamped in the center of Castleton on the property of Richard Bentley, in preparation for their assault on Fort Ticonderoga, and

Whereas, in the early 19th century, Castleton village, at the town's center, prospered from milling, slate production, and stagecoach commerce, and

Whereas, a number of beautiful homes featuring spiral staircases, vaulted stair-and-entrance combinations, and decorative friezes were built under the guidance of joiners or woodcrafting specialists such as Thomas Dake, and

Whereas, Thomas Dake's custom-designed pulpit at the Castleton Federated Church is considered his construction masterpiece, and

Whereas, in 1938, the Ladies Aid Society of the Castleton Federated Church conducted the first Castleton Colonial Day Historic House Tour, and

Whereas, a few years after the tour's inauguration, the Castleton Woman's Club assumed responsibility for this annual event that now includes over 20 homes, commercial buildings, and historic sites, and

Whereas, proceeds from ticket sales are applied to community improvement projects, such as the planting of fruit trees on Main Street in Castleton, the awarding of college scholarships, and the restoration of period clothing, and

<u>Whereas</u>, Castleton Village Historic District is now on the National Register of Historic Places and encompasses the trail of the blue cat of Castleton that Catherine Cate Coblentz describes in her children's book, *The Blue Cat of Castle Town*, and

Whereas, recent past Castleton Woman's Club presidents Linda Pritchard, JoAnn Riley, Deborah Hadeka, and Holly Hitchcock were instrumental in the continuation and promotion of the Castleton Colonial Day Historic House Tour, and the club's acting president, Joan Chader, has continued this wonderful tradition that benefits the community, now therefore be it

## Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the 80th anniversary of the Castleton Colonial Day Historic House Tour, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Joan Chader, acting president of the Castleton Woman's Club.

House concurrent resolution congratulating the 2018 Essex High School Vermont-NEA Scholars' Bowl championship team

Offered by: Representatives Myers of Essex, Bancroft of Westford, Dunn of Essex, Giambatista of Essex, and Houghton of Essex

Whereas, the Vermont-NEA College Bowl tests high school students' broad academic knowledge and ability to exercise quick recall, and

Whereas, Essex High School entered the year-long 2017–2018 competition as the defending champion and winner in four of the prior five years, and

Whereas, competition consists of regional tournaments in the fall and playoffs that start with a qualifying day in January, and

Whereas, Essex High School, to no one's surprise, was one of the 13 teams welcomed into the final day's competition conducted on March 24 at the University of Vermont, and

Whereas, Essex began the day with quarterfinal and semifinal match victories over Lyndon Institute and Middlebury Union High School, and

Whereas, the decisive championship match between Essex High School and Hanover High School could not have been more riveting as the lead changed 13 times before Essex took command during the match's final round to emerge with a 415–355 victory, a second Vermont-NEA championship, and an all-expenses-paid trip in June to the Washington, D.C. area to represent Vermont at the PACE National Scholastic Championship, and

Whereas, team members Nick Norton, Alex He, Sam Feehan, Grace Lu, Henry Wu, and Nathan Wu, and proud coach David Rome are all anticipating the challenge of participating in the national competition, now therefore be it

House concurrent resolution congratulating Carl Fung on winning the National 2017 LEGO REBRICK SuperBots Contest

Offered by: Representatives Myers of Essex, Bancroft of Westford, Dunn of Essex, Giambatista of Essex, and Houghton of Essex

Whereas, LEGO REBRICK, an organization the Denmark-based LEGO Group created to conduct LEGO-centered competitions, sponsored the 2017 LEGO REBRICK SuperBots contest, challenging contestants "to construct a robot that helps its operator complete some task," and

Whereas, the judges reviewed 82 entries from throughout the United States before awarding first place honors to an Essex High School senior, Carl Fung, for his adeptly named Gauntl3t (Gauntlet), a four-fingered arm that wraps around the operator's hand, and

Whereas, the Gauntlet includes a sophisticated electrical control system, enabling the operator to perform different functions, including opening a door, lifting an eight pound weight, and even safely lifting an egg from a carton, and

Whereas, Carl Fung developed the Gauntlet while "fiddling around in school," with no initial knowledge of or intent to enter the LEGO REBRICK SuperBots contest, and

Whereas, a challenging moment in the Gauntlet's development occurred when he employed a death grip, his terminology for attempting to direct the Gauntlet's thumb and forefinger to "reach their maximum rotation levels when gripping onto an object," and

Whereas, in recognition of his achievement, LEGO REBRICK sent Carl Fung a congratulatory card and a custom-mini figure, one of only approximately 100 in existence, and

Whereas, these small awards supplemented Carl Fung's primary prize, an all-expense paid trip to Copenhagen, Denmark, to attend the 2018 LEGO WORLD event, and the extraordinary opportunity to demonstrate the Gauntlet's amazing powers before potentially thousands of spectators, and

Whereas, Carl Fung first experimented with LEGOs as a young boy, and his subsequent participation in robotics clubs enabled him to appreciate the fantastic applications that can result when motorized technology is added to LEGO creations, and

Whereas, this talented budding engineer hopes to continue his education at the University of Vermont, focusing on robotics and possibly mechanical engineering as well, now therefore be it

<u>Whereas</u>, in three exciting games featuring national television coverage on ESPN, the Essex Junction all-stars performed their best, but despite a solid 7–5 win over the Holden, Massachusetts, all-stars, the regional championship proved elusive, and

#### H.C.R. 371.

House concurrent resolution designating Wednesday, June 27, 2018 as Post-Traumatic Stress Injury Awareness Day

Offered by: Representatives Copeland-Hanzas of Bradford, Dunn of Essex, Haas of Rochester, Houghton of Essex, Jickling of Randolph, McFaun of Barre Town, Mrowicki of Putney, Pajala of Londonderry, Pugh of South Burlington, Rosenquist of Georgia, Troiano of Stannard, and Wood of Waterbury

Whereas, in 1980, the American Psychiatric Association created the term Post-Traumatic Stress Disorder (PTSD) to describe the severe combat stress that Vietnam veterans were experiencing, and

Whereas, since 1980, technological advances in electromagnetic imaging have documented that severe post-traumatic stress can cause physical changes within a person's brain, and

Whereas, it is more accurate to describe these physical changes as an injury rather than a disorder or, in other words, as a wound and not a weakness, and

Whereas, the word "disorder" conveys a negative image that can discourage some individuals from seeking treatment and others from caring about those who are injured, and

Whereas, equally important, the use of the term "disorder" in relation to combat stress assails the sense of honor that should be associated with any member of the U.S. Armed Forces injured in combat, and

<u>Whereas</u>, beyond those injured in military combat, using the term is demeaning to first responders, abuse and crime victims, witnesses and survivors of life-threatening accidents and natural disasters, and their family members, and

Whereas, the American Psychiatric Association's *Diagnostic and Statistical Manual of Mental Disorders*, Fifth Edition, distinguishes between common post-traumatic stress, resulting in a traumatized but uninjured brain, and the more debilitating and longer-lasting form of stress that does involve a brain injury, and

Whereas, an alternative description for the more debilitating form of post-traumatic stress is Post-Traumatic Stress Injury (PTSI), and

Whereas, the term PTSI preserves the medical distinction between the short and long-term types of post-traumatic stress while removing the unjustified stigma associated with the term disorder, and

Whereas, the Honor for ALL organization, with the support of the National

Guard and mental health advocacy and veterans groups, is working to encourage a national awareness of the extreme importance of replacing the term PTSD with PTSI for describing post-traumatic stress resulting in a brain injury, and in 2017, 34 states and the U.S. House of Representatives acknowledged the importance of this effort, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates Wednesday, June 27, 2018 as Post-Traumatic Stress Injury Awareness Day, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Honor for ALL organization in Royal Oak, Michigan.

Whereas, National History Day is a nonprofit educational organization that offers students the opportunity to engage in original historical research, and

Whereas, its largest program is the National Contest, in which over one-half million students from around the world prepare projects of their choice on the annually designated topic, and

Whereas, for the 2017–2018 academic year, the topic is Conflict and Compromise in History, and

Whereas, middle and high school students compete on the local and affiliate levels, and the nearly 3,000 affiliate winners represent their respective jurisdictions at a week-long competitive event held in June on the campus of the University of Maryland, and

Whereas, on Saturday, April 7, at Montpelier High School, the Vermont Historical Society hosted Vermont History Day, the national contest's affiliate event in Vermont, and

Whereas, over 300 students presented their documentaries, exhibits, papers, performances, and websites, and

Whereas, 89 volunteer judges carefully reviewed the students' creations, assessing both their academic quality and effectiveness conveying the theme, and

Whereas, 49 students, who were responsible for the development of 31 of

the projects, were selected to represent Vermont at the University of Maryland event, and

Whereas, the large number of Vermont History Day participants and the excellence of the winning projects attest to a vibrant interest in the study of history among the State's students in grades 5–12, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the 2018 Vermont History Day winners, and be it further

Whereas, the Hinesburg Selectboard appointed Charlie LaBelle as the first chief, and the Department's original truck was an old Chevrolet with a 55-gallon drum that when loaded with baking soda triggered a single hose, and

Whereas, in 1967, Bernard Giroux became chief, and his 32-year tenure featured the construction of a new fire station, funded and built through volunteer efforts, and

Whereas, later in the 1970s, the first of two additions was added to the building, and a second more extensive expansion occurred in 2001, and

Whereas, also in the 1970s, the Department and interested residents of Williston and St. George established Iroquois First Response for medical emergencies, and the service continued until 2000 when the Department assumed first response responsibility for both Hinesburg and St. George, and

Whereas, the Department offers community CPR trainings and fire safety education sessions in local schools, and

Whereas, since 1999, Chief Alton Barber's dynamic leadership has ensured that the Department has kept apace with the latest firefighting and first response practices and technology, now therefore be it

Whereas, pursuant to 1 V.S.A. § 372, the first Friday in May is Arbor Day in Vermont and is a great occasion to celebrate Vermont's forests, and

Whereas, 75 percent of the State, or 4.6 million acres, is forested, and

<u>Whereas</u>, forests provide clean water for drinking, recreation, and habitat and in some instances can eliminate expenditures would have been needed to develop manmade infrastructure to ensure clean water, and

Whereas, each acre of forestland stores 107 metric tons of carbon, the equivalent of annual emissions from 83 vehicles, and Vermont forests store approximately 480 million metric tons of carbon, and

Whereas, forests provide the habitat for a large number of wildlife species

and are either the home of or closely associated with 75 percent of Vermont's native species, and

Whereas, forests and forestry-related industries are critical to the economic vitality of Vermont, and

Whereas, annualized economic data from the Department of Forests, Parks and Recreation document this statement, and

Whereas, the basic forestry industry, including logging and trucking, generates \$45 million in output and the full-time equivalent of 875 jobs, and

Whereas, wood product manufacturing injects \$239 million into the State's economy and is responsible for over 2,300 jobs, and

Whereas, the comparable figures for the wood energy industry are \$60 million and 300 jobs, and

Whereas, the quintessential Vermont art of maple sugaring results in 46 percent of U.S.-produced maple syrup originating in our State, equaling two million gallons of syrup annually, and

Whereas, forestry-centered recreation supports 10,050 jobs, with a 158-million-dollar payroll and revenues of \$1.9 billion, and

Whereas, fall foliage sparks \$460 million in tourists' expenditures on food, lodging, and other purchases, slightly over 25 percent of Vermont's tourism revenue, and

Whereas, it is undeniable that forests are an environmental and economic linchpin of Vermont, now therefore be it
