# Second Reading; Bill Amended; Third Reading Ordered

#### H. 552

**Rep. Lewis of Berlin**, for the committee on Government Operations, to which had been referred House bill, entitled

An act relating to approval of the adoption and codification of the charter of the Town of Ferrisburgh

Reported in favor of its passage when amended as follows:

In Sec. 2, 24 App. V.S.A. chapter 119, in section 2, by striking out subsections (c) and (d) in their entirety and inserting in lieu thereof the following:

- (c) Unless otherwise provided in this charter:
- (1) the particular powers in this charter shall not be exclusive or restrict the scope of powers that the Town would otherwise have under State statutes or rules; and
- (2) this charter shall not limit powers conferred by general or special enactment of State statutes or rules, including those conferred upon the Selectboard or other Town officers.

The bill, having appeared on the Calendar one day for notice, was taken up, read the second time, report of the committee on Government Operations agreed to and third reading ordered.

# Committee Bill; Second Reading; Bill Amended; Third Reading Ordered

#### H. 691

**Rep. Brennan of Colchester** spoke for the committee on Transportation.

Having appeared on the Calendar one day for notice, was taken up, read the second time.

Pending the question, Shall the bill be read a third time? **Rep. Haas of Rochester** moved to amend the bill as follows:

By striking out Sec. 4, 23 V.S.A. § 1217, in its entirety and inserting in lieu thereof the following:

Sec. 4. 23 V.S.A. § 1217 is added to read:

# § 1217. PERSONS UNDER 21 YEARS OF AGE; OPERATING A VEHICLE WHILE UNDER THE INFLUENCE OF A DRUG; CIVIL PENALTIES

- (a) A person under 21 years of age shall not operate, attempt to operate, or be in actual physical control of a vehicle on a highway while under the influence of a drug.
- (b) A violation of subsection (a) of this section shall be a civil offense subject to the jurisdiction of the Judicial Bureau and subject to the following sanctions:
- (1) For a first violation, the Commissioner shall suspend the person's license to operate a motor vehicle for a period of six months.
- (2) For a second or subsequent violation, the Commissioner shall suspend the person's license to operate a motor vehicle for a period of one year or until the person reaches 21 years of age, whichever is longer.
- (3) Any suspension imposed pursuant to this section shall run concurrently with any suspension imposed pursuant to section 1205, 1206, 1208, or 1216 of this title, any suspension imposed by another jurisdiction under comparable statutes, or a suspension resulting from a conviction for a

violation of section 1091 of this title if it arose from the same incident. A person shall receive credit for any elapsed period of a suspension served in Vermont against a later suspension imposed in Vermont.

- (c) No fine shall be imposed and no points shall be assessed for a violation of this section.
- (d) Any civil penalty imposed by this section shall not bar prosecution for any crime arising out of the same violation, including a prosecution under section 1201 of this title.
- (e) As used in subsection (a) of this section, "under the influence of a drug" shall have the same meaning as in subsection 1201(h) of this title.

Which was agreed to.

Pending the question, Shall the bill be read a third time? **Rep. Van Wyck of Ferrisburgh** moved to amend the bill as follows:

In Sec. 6, 23 V.S.A. § 1259, by inserting the following after the ellipsis and before subsection (e):

- (b) A person is required to be restrained in a safety belt system unless:
- (1) the person is a rural mail carrier of the U.S. Postal Service operating a motor vehicle in the performance of employment;
- (2) the person is a driver or passenger frequently stopping and leaving the motor vehicle or delivering property from the motor vehicle, if the speed of the motor vehicle between stops does not exceed 15 miles per hour;
  - (3) the person is the operator of any farm tractor;
- (4) the person is a member of the emergency personnel of an emergency motor vehicle and finds it necessary to be unrestrained in order to perform his or her duties;
  - (5) the motor vehicle the person is occupying is a bus or taxi;
- (6) the person is required to be restrained under section 1258 of this title; or
- (7) the person has been ordered by an enforcement officer, a firefighter, or an authorized civil authority to evacuate persons from a stricken area; or
- (8) the speed of the motor vehicle does not exceed 15 miles per hour and the period of continuous operation of the vehicle is less than one minute.

Which was disagreed to. Thereupon third reading of the bill was ordered.
