S. 221

Senate bill, entitled

An act relating to establishing extreme risk protection orders

On motion of **Rep. Masland of Thetford**, the following remarks by the Speaker, **Rep. Johnson of South Hero** were ordered printed in the Journal:

"Madam Speaker:

I have a secret. Sometimes in thinking about my remarks for page graduation,

I have to really search for something that made a page class' 6 week block of time unique. I had no trouble with that for today.

You all started your jobs here on February 13<sup>th</sup>. Devastating events that weekin our nation and our beloved state, shaped legislative conversations here in ways none of us could have predicted. And you've been here with us throughout that time, watching it unfold, and managing it with us from the inside.

The country's founders struggled mightily with the necessary tension between liberty and justice. Between the individual freedom and liberties they were denied under colonial rule, and the necessary standard of laws that form the foundation of a just and stable society. This tension between individual freedom and common good- of freedom and unity- is the core question of a truly free democracy.

We have not struggled with a question as deeply or with as much public engagement, in at least 9, and maybe 20 years. It is remarkable- and it is the hallmark of true democracy. As pages, you have played a vital role in connecting Vermonters with their government. Each of those many, MANY messages that you delivered are Vermonters reaching out to their elected officials so that their views can be heard. Outside the statehouse, you and your peers have stepped up to not only participate, but to re-shape a public conversation in a way I have never seen before in my lifetime. And I could not be more proud of Vermont's youth.

We hope that in your time with us, you've gained an appreciation for the care and feeding required to make a living democracy successful. Democracy requires a lot ofenergy and engagement, but it is well worth the nurturing and the investment.

We have lived and worked through a lot together over these six weeks, in this building, which is the heart of Democracy in Vermont. Our shared service and time together makes you a part of this family. Please stay in touch with usand with each other. Come back soon, to check up on your successors – I'm sure they would appreciate your tips!- to visit with rest of us, maybe to testify, to lend your voice to the issues you care about on the statehouse steps, and hopefully, one day to fill these seats or the corner office. You never know where your journey will lead you, but we hope that in due time it leads you back here.

We thank you for your service and with you as the future of our state, Vermont is in excellent hands."
