We're sure many Vermonters will be letting these lawmakers know how this budget proposal fails to address some of the largest challenges we face – and we need to make sure they hear that the budget must include climate action.

Richard,

The state budget is a reflection of our values in dollars and cents, putting forth a vision and a plan for how we will move forward. Despite the fact that Vermont is falling radically short on meeting our state's climate and energy goals, the [Governor's budget proposal fails](#) to include meaningful action to address carbon pollution and develop Vermont's economy for the 21st century.

The House and Senate Appropriations Committees are seeking public input on the budget proposal and will be holding public meetings this upcoming **Monday, February 12th** at six locations throughout the state.

Can you attend the public hearing near you and make a brief comment in favor of including a study of carbon pricing in the budget?

- **Rutland:** Longfellow School Building, 6-7pm
- **Springfield:** Springfield Town Hall, 5:30-6:30pm
- **St. Albans:** St. Albans City School, 6-7pm
- **St. Johnsbury:** St. Johnsbury House, 6-7pm
- **Winooski:** Room 401 at the Community College of Vermont Winooski Campus, 6-7pm

And **Tuesday, February 13th in Montpelier** in Room 11 of the State House, 6-7pm. You'll remember that this past fall, hundreds of Vermonters asked the governor's own hand-picked climate commission to recommend a price on carbon pollution. The commission didn't go that far – but they did recommend the governor support an independent, non-partisan study of carbon pricing.

Well, the governor rejected that recommendation. He won't even study the issue – he is choosing to remain willfully ignorant.

Fortunately the legislature could move ahead on a study without him. But they'll only do so if constituents like you take action and demand it.

Please tell the Appropriations Committees to include a full and fair study of carbon pricing in the budget at a public meeting near you this upcoming week:

Monday, 2/12 — Johnson, Rutland, St. Johnsbury, St. Albans, Winooski, and Springfield

Tuesday, 2/13 — Montpelier

A well crafted carbon pricing plan is extremely effective in reducing carbon pollution, bolstering the local economy, growing jobs, and protecting the most vulnerable Vermonters — the very criteria that the administration seeks to fulfill in the proposed budget. We have done our homework and are confident that an impartial study will make clear that carbon pricing can in fact accomplish all of the Governor's priorities.

Governor Scott claims to want to address global warming, but fails to put forth any plan that will have a meaningful impact on reducing our climate pollution. The administration should be willing to explore carbon pricing — a climate action and economic development policy proven effective across the globe in nearly 50 jurisdictions worldwide.

Frankly, this story of failing to act is getting old — and dangerous. The impacts of climate change are only getting more severe, and the fossil fuel economy continues to disproportionately harm low-income and rural communities. We must see a plan for action in Vermont's budget.

Please speak up for carbon pricing and the necessity for a full and fair study this Monday at a public hearing near you:

Monday, 2/12 — Johnson, Rutland, St. Johnsbury, St. Albans, Winooski, and Springfield

Tuesday, 2/13 — Montpelier
