2013-2014

House & Senate Education Committees both included language in the Misc. Ed Bill that charged the PreK-16 Council with creating an Expanded Learning Opportunities (ELO) Working Group to "review and evaluate issues of equity in and access to Vermont's Expanded Learning Opportunities, including afterschool and summer programs" (H.876). Unfortunately, the Misc. Ed. Bill was not enacted that year, but the PreK-16 Council decided to do this work anyway, given that the legislature had intended to make the request.
