7	Equity Standards Advisory Board
8	Statement of purpose of bill as introduced: This bill proposes to require the
9	Agency of Education to adopt ethnic studies standards into statewide
10	educational standards, and the Vermont School Board Association to develop a
11	model policy on ethnic and social equity in schools for public schools and
12	approved independent schools. This bill proposes to establish the Ethnic and
13	Social Equity Standards Advisory Board to assist the Agency of Education in
14	developing the ethnic studies standards and the Vermont School Board
15	Association in developing the model policy. This bill also proposes to require
16	the Secretary of Education to publish, to the extent permitted by applicable
17	confidentiality laws, statewide educational assessment results showing the
18	results for certain categories of students.

An act relating to the adoption of ethnic studies standards into statewide
educational standards and a policy on ethnic and social equity in schools by
public schools and approved independent schools

1	It is hereby enacted by the General Assembly of the State of Vermont:
2	Sec. 1. ETHNIC AND SOCIAL EQUITY STANDARDS ADVISORY
3	BOARD
4	(a) Definitions. As used in this act:
5	(1) "Ethnic groups" means nondominant racial and ethnic groups in the
6	United States, including people who are indigenous and people of African,
7	Asian, Pacific Island, Chicanx, Latinx, or Middle Eastern descent.
8	(2) "Ethnic studies" means the instruction of students in kindergarten
9	through grade 12 in the historical contributions and perspectives of ethnic
10	groups and social groups.
11	(3) "Social groups" means females, people with disabilities, immigrants,
12	refugees, and individuals who are lesbian, gay, bisexual, transgender, queer,
13	questioning, intersex, or asexual.
14	(b) Creation and composition. The Ethnic and Social Equity Standards
15	Advisory Board is established. The Board shall comprise the following 13
16	members:
17	(1) a representative from the Native American community;
18	(2) a representative from the Black and African American community;
19	(3) a representative from the Latinx community;
20	(4) a representative from the disability rights community;

1	(5) a representative from the lesbian, gay, bisexual, transgender,
2	intersex, and queer community;
3	(6) a representative from the Asian and Pacific Islander community;
4	(7) a representative from the Middle Eastern community;
5	(8) a Vermont-based, college-level faculty expert in ethnic studies;
6	(9) the Secretary of Education or designee;
7	(10) the Executive Director of the Vermont-National Education
8	Association or designee;
9	(11) an Assistant Attorney General in the Office of the Vermont
10	Attorney General with experience working with the Agency of Education on
11	racial and social justice issues in schools;
12	(12) the Executive Director of the Vermont School Boards Association
13	or designee; and
14	(13) a representative for the Vermont Principals' Association with
15	expertise in the development of school curriculum.
16	(c) Appointment and operation.
17	(1) The Vermont Coalition for Ethnic and Social Equity in Schools
18	(Coalition) shall appoint the Board members identified under subdivisions
19	(b)(1)-(8) of this section in consultation with the Vermont School Boards
20	Association. Appointments of members to fill vacancies to these positions
21	shall be made by the Coalition, in consultation with the Vermont School

1	Boards Association, and the member filling a vacancy shall represent the same
2	community or area that was represented by the vacated member.
3	(2) A minimum of 80 percent of the members on the Board identified
4	under subdivisions (b)(1)-(7) of this section shall:
5	(A) be people from ethnic minority groups who have a background in
6	advocacy for the group they represent; and
7	(B) as a group, represent the breadth of geographic areas within the
8	State.
9	(3)(A) The Coalition shall call the first meeting of the Board to occur on
10	or before January 1, 2019.
11	(B) The Board shall select a chair from among its members at the
12	first meeting.
13	(C) A majority of the membership shall constitute a quorum.
14	(D) Members of the Board who are not State employees or whose
15	participation is not supported through their employment or association shall
16	receive per diem compensation and reimbursement of expenses pursuant to
17	32 V.S.A. § 1010, to be provided by the Agency of Education. The Board may
18	meet up to ten times per year.
19	(E) The Board shall cease to exist on June 30, 2022.
20	(d) Duties of the Board.

1	(1) The Board shall identify current statewide standards that fail to
2	recognize the history, contribution, and perspectives of ethnic groups and
3	social groups and shall develop ethnic studies standards for adoption into
4	existing statewide educational standards for public school students and
5	approved independent school students in kindergarten through grade 12 that:
6	(A) increase cultural competency of public school students in
7	kindergarten through grade 12;
8	(B) increase attention to the history, contribution, and perspectives of
9	ethnic groups and social groups;
10	(C) promote critical thinking regarding the history, contribution, and
11	perspectives of ethnic groups and social groups;
12	(D) commit the school to eradicating any racial bias in its curriculum;
13	(E) provide, across its curriculum, content and methods that enable
14	students to explore safely questions of identity, race equality, and racism; and
15	(F) ensure the basic curriculum and extracurricular programs are
16	welcoming to all students and take into account parental concerns about
17	religion or culture.
18	(2) The Board shall propose a model policy on ethnic and social equity
19	in schools for adoption by public schools and approved independent schools
20	that includes minimum standards for a school environment that:

1	(A) promotes an overarching focus and participation in the racially,
2	culturally, and socially diverse global community;
3	(B) ensures every student a safe, secure, and welcoming learning and
4	social environment in which every act or attitude of implicit or explicit racial,
5	sexual orientation, gender, cultural, or ability bias is acknowledged and
6	addressed appropriately;
7	(C) challenges any racist, sexist, gender, or ability assumptions,
8	attitudes, and behaviors when they occur using principles and practices of
9	restorative justice methods;
10	(D) provides parents a welcoming means of raising any concern
11	about their child's experience as it bears on race or social identity at school;
12	(E) ensures that the school provides all its personnel training in how
13	best to address racial incidents;
14	(F) specifies prohibited conduct as it relates to racism, sexism,
15	ableism, and other social biases, and refers to the process through which
16	alleged misconduct will be addressed, including disciplinary action as
17	appropriate; and
18	(G) establishes disciplinary responses to racial incidents that include
19	the increased utilization of restorative practices where appropriate.
20	(3) The Board shall, on or before June 30, 2020, submit:

1	(A) a report that, at a minimum, proposes the ethnic studies standards
2	developed under subdivision (1) of this subsection (d), to the Agency of
3	Education; and
4	(B) the model policy developed under subdivision (2) of this
5	subsection (d) to the Vermont School Boards Association.
6	(e) Duties of the Agency of Education. The Agency of Education shall, on
7	or before June 30, 2021, adopt ethnic studies standards into existing statewide
8	educational standards for public school students and approved independent
9	school students in kindergarten through grade 12. The Agency shall consider
10	the report submitted by the Board under subdivision (d)(3)(A) of this section
11	when determining the standards to adopt.
12	(f) Duties of the Vermont School Boards Association. The Vermont
13	School Boards Association shall, on or before June 30, 2021, develop a model
14	policy on ethnic and social equity in schools for public school students and
15	approved independent school students in kindergarten through grade 12. The
16	Vermont School Boards Association shall consider the model policy submitted
17	by the Board under subdivision (d)(3)(B) of this section when developing the
18	model policy.
19	(g) Duties of school districts. School districts and approved independent
20	schools shall, for the 2021-2022 school year, implement the ethnic studies
21	standards adopted by the Agency under subsection (e) of this section and adopt

1	a policy on ethnic and social equity in schools that takes into consideration the
2	model policy developed by the Vermont School Boards Association under
3	subsection (f) of this section.
4	(h) Report to General Assembly. On or before December 15, 2021, the
5	Agency of Education shall submit a report to the General Assembly on the
6	status of implementation by school districts and approved independent schools
7	of the ethnic studies standards and the policy required under subsection (g) of
8	this section.
