5	(a) State Treasurer; review and recommendations. The State Treasurer shall consult
6	as applicable with the Office of Attorney General; the Departments of Human Resources,
7	of Public Safety, of Corrections, and of Children and Families; the Vermont Criminal
8	Justice Training Council; the Vermont Troopers Association; and the Vermont State
9	Employees Association on the following issues regarding the Vermont State Retirement
10	System:
11	(1) Group C members. The Treasurer shall review the current employees
12	classified as Group C members pursuant to 3 V.S.A. § 455(a)(9)(B) and (11)(C) in order
13	to perform the following analyses:
14	(A) whether the requirements of Group C membership, including the
15	requirement in 3 V.S.A. § 455(a)(9)(B) that specified employees "are required to perform
16	law enforcement duties as the primary function of their employment," are appropriate;
17	(B) whether the requirement that a Group C member retire at age 55 as set forth
18	in 3 V.S.A. § 459(a)(2) may violate federal age discrimination laws for any of the types
19	of employees in Group C membership;
20	(C) a review of the job description of each type of employee in Group C
21	membership, and whether those job descriptions conform to the standards described in

1	(D) whether there are any other types of State employees that should be

3	(2) Other high stress positions. The Treasurer shall determine whether there are

13	actuarial analysis performed in accordance with this subsection.
