This email is to follow up on my testimony on the Vermont Medicaid Next Generation ACO Contract.

What I am Sending You

- I attached three documents:
 - Slide deck with minor modifications. Specifically, I added language indicating that the prospective payment includes hospitals and hospital owned physician practices. Also, I added language trying to make clear that DAs and SSAs are part of the ACO network, and may help care for a beneficiary, but that DVHA did not convert any of its present DA and SSA payments into ACO payments. I apologize if this is overly confusing.
 - A one page contract overview.
 - A two pager with the contract details. Essentially, it is a condensed version of the slide deck.

I was mistaking this number for the approximately 160 CRT (Community Rehabilitation and Treatment Program) participants in the ACO population. I take great care in making sure I am being accurate on the record, and I apologize for mixing up these numbers.
