Dear Rep. Lippert, Senator Ayer, Ms. Starr, Ms. Gihuly and Members of the House Health Care Committee,

I am writing to encourage your committee to consider the Universal Primary Care bill (H248) expected to become law on January 1, 2019. There can be no debate that affordable healthcare availability (or lack of it) affects all Vermont families. Every family has either directly or indirectly been affected by the inadequacies of a health care system that at best is struggling to keep up with needs.

I would like to explain why I feel this bill would be a good starting place for laying the foundation for responsible healthcare.

In addition to providing medical care by primary care doctors and those with specialties such as pediatrics, gynecology and internal medicine, this bill also includes outpatient mental health services and substance abuse providers. As a veteran public school teacher, I can attest to the wide spread need for affordable mental health services. Children mirror the health crises and challenges their families face, whether these be addiction issues, financial insecurity, or chronic illnesses that go undiagnosed and untreated. Primary care professionals are the healthcare providers that first encounter mental health issues in families. With the opiate crisis our state faces, it's imperative that people be able to access the help they need before their health issues deteriorate. Addiction issues strain VT. communities on all levels including an educational system struggling with how to financially provide school based mental health services to children who have witnessed trauma, an unstable workforce, an overtaxed judicial system, hospital emergency rooms and most importantly, the fabric of family life. UPC would allow

people to get the care they need through primary care which includes mental health services. Currently, we are at risk of having a large percentage of these people loose coverage for these services. Vermont is really in the infancy stage of addressing the substance abuse issues and we can't afford a setback.

Access to Primary Care will reduce the need for expensive hospitalizations and costly emergency room visits. Diabetes is prevalent in my family. My siblings, father and maternal and paternal grandparents have all been afflicted with this disease with far ranging consequences. Luckily for my siblings they now receive Medicare and although they struggle with the costs of insulin and prescription costs they can see their doctors regularly to monitor and treat this potential life threatening disease. The medicare single payer system has allowed them to continue to be relatively healthy adults. My sister (now 69) had limited healthcare coverage although she worked for years as a registered nurse at Rutland Hospital for most of her working life. As a result of high deductibles, her diabetes went untreated for years. Eventually she was eligible for Medicare and was able to receive the medical care that she had needed years before. Of course it was at a cost to her and the medical system that had to respond with necessary medical interventions that could have been prevented if she had had affordable access to primary care. I believe that it's critical that VT. step up to the plate and ensure that all Vermonters receive primary medical care.

We can't wait for the federal government to come up with a plan that will predictably have high deductibles, an ineffective, costly paperwork bureaucracy with multiple insurance plans, coverage that is constantly changing, exclusions and roadblocks at every turn. Governor Scott committed VT to providing health care in his inaugural address. If Vermont adopts a UPC program we will be on our way to realizing this commitment.

I strongly urge you to consider H248.

I represent the Board of Directors of the Vermont Alliance for Retired Americans (VT ARA), as Board Secretary; and myself as a concerned citizen.

My name is Walter Carpenter and I live in Montpelier, Vermont. I am writing to thank the House Health Committee for taking up H 248, the Universal Primary Care bill. This bill has been sponsored by two dozen representatives, including three members of the House Health Committee: Representative Betsy Dunn, Representative Brian Cina, and ranking member, Representative Timothy Briglin. Due to conflicting schedules with work, I will be unable to be at Friday's introduction to H 248, though I definitely will be there in spirit and in future work on H 248.

By now, we all know that what is coming out of the unpredictable morass of Washington, D.C. on the horizons in health care is most likely not going to be good. Universal Primary Care (UPC) was needed years ago, never mind in the present and the immediate future. As someone who nearly died for want of a primary care physician ten years ago, I know in a personal sense what it means that H 248 will help to save lives. The lives that it spares are our own. Access to primary care is so often blocked by insidious deductibles, co-pays, and network problems. All of these dogged me a decade ago. The end results of these barriers placed in my way to primary care were that, when I finally did get to a primary care physician, it did not look like my future would be ten months, never mind ten years. There was a point where my survival for the next ten weeks was in doubt. One doctor pronounced to me that I had entered “ the prayer phase.” I am sixty-one now and still consider it a miracle of the first magnitude that I can attend the committee meetings on health care like I have been for so long to promote health care reform and stop more Vermonters from going through what I did back then. All of the mental and physical trauma I went through during that ordeal could have been avoided if only I had been able to access primary care at the outset of the disease.

Having health insurance is not enough. At the time I was lucky enough to have employer-sponsored insurance. This insurance, however, did its best to block me from primary care. The Affordable Care Act has all but done the same thing for many Vermonters, stopping access with co-pays and high deductibles while ensuring vast profits for insurance companies. Universal primary care is desperately needed in Vermont and, as someone with my history with primary care can attest, I cannot emphasize this fact any more than to say that UPC is much more than whether it involves taxes or fees, or that Vermont can afford it. Even though this bill contains no appropriations, it should be remembered by all of us involved in working for health care reform that Universal Primary Care is ultimately about lives, our lives, the lives of every Vermonter.

I wanted to express my sincere thanks for the House Health Committee taking it up, the sponsorship of the three representatives on the committee, and the interest in this awfully important issue by the House Health Committee.

He returned the following week feeling much improved after adjusting his medicines. Fortunately both Charlotte's and Cullen's primary care visits were covered respectively by Doctor Dynasaur and Medicare.

Presently as esteemed members of the Vermont legislature, you have the opportunity to pass the Universal Primary Care bill H248 and S53. This legislation does not involve raising funds but asks the joint fiscal office to generate a detailed cost plan for universal primary care. I ask you to please pass the Universal Primary Care bills H248 (House) and S53 (Senate). The current bill asks the joint fiscal office to generate financing options for universal primary care. This legislation will not cost any money, so there is no reason to delay.

My husbands health care premium is low cost but the family plan is outrageously expensive. We used to be subsidized by the Green Mountain Care Board but those subsidies were cut once the ACA was enacted because of what is referred to as the family glitch in the ACA making me ineligible to shop on the open market and receive subsidy. At our income, we are not able to cover the cost of my husbands family plan and I have been without medical insurance from the time the Green Moutnain Care Board cut subsidies nearly two years ago.

I have been unable to find a job offering health care. During a spell of unemployment I received a patient assistance program from NVRH at 100 percent coverage when I was unemployed. I had

some pulmonary function tests done and had to pay for the specialist to evaluate them at another hospital. I was also charged equipment rental fees. Next, I received a part time job which elevated some of our financial stress. My patient assistance program was immediately cut back significantly. I have been told that I need to get a skin cancer screening done due to an unusual mole. I have not done so due to costs. I feel that I live on a wing and a prayer, definitely a second class citizen given my health care situation. I am sure there are numerous stories like my own and because I am so aware as to what life is like without health care I beg that you pass these bills that would at least allow access to all in my situation to primary care. My understanding is that these bills would have a extremely low cost to Vermonters. Please address this crucial matter during this legislative session.

The League of Women Voters does not jump on bandwagons.

While continuing to pursue that goal, the League recognized that the individual states could provide models for the nation.
