I was present for some of the meeting this morning in Room 47. I would like to tell you about my 20 years as a sheep farmer in South Strafford, Vermont. In all those 20 years we never lost a sheep.

We had a guard dog and a guard llama with the flock at all times. But, more importantly, we took care of our animals. At lambing time all the ewes were kept in small pens near the house, with high electric and wooden fencing around the pens. They would then be put out into a field right next to the house until the lambs were weaned.

All our fields had excellent fencing and we constantly patrolled all the boundaries to check that it was in good condition. At night, all the year round, all the flock would be brought up to the barn and its outside enclosure and not released until morning.

Many nights we would hear the coyotes howling as the pack raced through the woods beyond our farm but - and I repeat - we never lost an animal. Coyotes are extremely clever and will take advantage of any chance to get a good meal. The way to defeat them is NOT to kill them - especially in wanton killing contests - but to be good, caring, active and hardworking husbanders.

Please vote to end the open killing season and wildlife killing contests. Coyotes are a necessary part of our environment and need our protection, as does all wildlife.
