I understand that you are the Fish and Wildlife Committee's assistant. Please forward this request to  
*stop the open season on coyote hunting and ban coyote killing contests* to your committee.

I live in Craftsbury, Vermont and have been a resident here for nearly 35 years. During that time I've seen many coyote bodies hanging in trees and garage doorways and have heard gun shots during the late evening hours at times other than the regular hunting season. One evening last spring I saw lights in a field about 1/4 mile from my house. I wasn't sure what was happening but after a short time I heard gun shots. The next day I heard (rumor mill) that my neighbor had been baiting coyotes to kill them. This was very upsetting to me.

Additionally I have learned through a Public Broadcast show on VPBS that killing coyotes does NOT reduce the population. That the coyote population grows based on the amount of food available in an area. If a number of coyotes are murdered and the environment can sustain more, than Mother Nature just produces larger litters. It seems we might make more headway in reducing the coyote population if we were to educate people regarding food waste disposal and the like. Or maybe there is no way to reduce the coyote population in this evolutionary world we live in. But an open season on coyotes is not the answer.

Please stop the open season on coyote hunting and ban coyote killing contests.

**Subject:** Unregulated coyote killing in Vermont

Hello,

I was unable to attend the committee meeting last week with testimony from the Vermont Fish and Wildlife (VF&W) commissioner, regarding the open season on coyote hunting and killing contests in our state. I want to start out by saying that whatever vendetta this agency has against

coyotes is unfortunate for Vermont, and is reminiscent of the uninformed mentality that has extirpated other predatory species including our state's catamounts and wolves.

I ask that you forward this email to the VF&W commissioner and the legislature's Fish and Wildlife Committee making decisions about managing our state's wildlife. It includes my own story about the impacts of allowing a 365 day-per-year, open season on coyotes:

I was visiting Craftsbury last winter and while driving along a dirt road I had to stop because a pick-up truck was stopped in the middle of the road, engine still running and doors wide open. After a minute of waiting I saw a man emerge from brush along the road with a rifle, he gets into the truck and starts driving like a maniac. Unfortunately I had to follow him while he swerved and drove too fast for the conditions. When I caught up with him, he had pulled his truck over to the left side of the road and with the rifle was shooting at something in the woods along the road. He then got out and starting shooting again, then ran into the woods. I was stunned at what I was seeing and drove up along side the truck's passenger side, asked a man sitting in the passenger seat what was going on, and he said they were shooting coyotes. These two people were not the owners of the land they were hunting on. Again stunned, I asked why and he said because they can. When I was able to get cell service I pulled my car over, looked up the phone number for the local game warden and called. They said to call the state police, which I did, and then explained to a dispatcher that I just saw a man shooting at coyotes with a rifle from the side of a road. She said it is "open season" on coyotes in Vermont and people can hunt them any time. Guess what my reaction was after a state police dispatcher brushed off my report of witnessing a man shooting a gun into the woods from the side of a public road.

My story is just one example of the results of an unregulated, open season on a predatory and beneficial wild animal species: Crazy people shooting at wild animals along public roads because they think they have a right to. I can only imagine the harassment and horrible treatment these animals are experiencing when no one else is watching.

There are many ways that predators can be excluded from domestic animal stock (it is being done successfully in African countries where the predators are much larger and dangerous). Between open season coyote hunting and the torture being inflicted upon our states' animal species (wild and domestic) from trapping, I am losing confidence in VF&W's ability to manage our state's wildlife intelligently. Vermont is better than this and our state government agencies that oversee agriculture and wildlife should provide more information and support to livestock owners about nonlethal solutions to control coyotes and other predators.

Also, is the department considering that as areas of Vermont become more suburbanized, and climate change makes our state less habitable for species moose but more habitable for deer, that a healthy population of predators is going to be critical in controlling the deer herd population?

Therefore, I am recommending that the Fish and Wildlife Committee introduce a regulated coyote hunting season and ban coyote killing contests. And while I potentially have someone's attention, I also want to recommend that Vermont prohibit the absolutely cruel and inhumane practice of animal trapping.

Dear Fish & Wildlife Committee,

I would like you to introduce legislation to ban the open coyote killing season. I am also completely against wildlife killing contests.

Coyotes each eat about 2,000 mice and other rodents every year, which is of huge concern to Vermont as the mice they eat are the ones that spread Lyme disease through the ticks they carry. Lyme disease is a huge public health concern and is spreading throughout VT. We have one of the highest per capita rates of Lyme disease in the country.

Allowing anybody with a gun to kill any coyote they see any time of the year is irresponsible. They are not killing the coyotes to eat, as nobody eats coyotes. Most of the time they just leave the bodies to rot in the woods. And killing contests just leave piles of dead coyotes to rot in the aftermath. Another problem is that we do not know how many coyotes live in Vermont or how many coyotes hunters and trappers kill each year.

Coyotes are family oriented animals and form close bonds with their mates and their offspring. Killing a coyote during breeding season leaves the pups to starve to death. When the family has been disrupted by the death of the adults in the family, the breeding rate of juveniles increases to make up for this threat. So killing coyotes increases the number of young to take their place.

Coyotes do not pose any threat to humans. The hatred against them by hunters is completely irrational. Some hunters like to kill coyotes because they think they are competition for deer which the hunters would prefer to kill themselves. Coyotes do not ordinarily kill deer because they are too big.

There are many non-lethal ways to discourage coyotes and protect livestock. But most coyote killers are not trying to protect livestock or anything else.

As a long time resident I want the Fish and Wildlife Department to protect our wildlife in Vermont, not let anybody with a gun or trap exterminate our animals.
