4	control" recommends that the House propose to the Senate that the bill be
5	amended by striking out all after the enacting clause and inserting in lieu
6	thereof the following:

8	Sec. 1. REPORT ON IMPLEMENTATION OF THE GENERAL PERMIT
9	FOR NONCHEMICAL AQUATIC NUISANCE AND RAPID
10	RESPONSE CONTROL ACTIVITIES
11	On or before January 15, 2019, the Secretary of Natural Resources shall
12	submit to the House Committee on Natural Resources, Fish, and Wildlife and
13	the Senate Committee on Natural Resources and Energy a report regarding the
14	implementation in 2018 of the general permit for the use of nonchemical
15	aquatic nuisance and rapid response control activities issued under 10 V.S.A.
16	§ 1455(m) and 2017 Acts and Resolves No. 67, Sec. 9. The report shall
17	include a summary of the implementation of the general permit, the process for
18	approval of notices of intent for coverage under the general permit, the number
19	of persons who applied for coverage under the general permit, the number of
20	persons who were approved for coverage under the general permit, and any
21	recommendations to improve the implementation of the general permit.

5	(x)(1) No permit or permit amendment is required for the construction of
6	improvements for any one of the actions or abatements authorized in this
7	subdivision:
8	(A) a remedial or removal action for which the Secretary of Natural
9	Resources has authorized disbursement under section 1283 of this title;
10	(B) abating a release or threatened release, as directed by the
11	Secretary of Natural Resources under section 6615 of this title;
12	(C) a remedial or removal action directed by the Secretary of Natural
13	Resources under section 6615 of this title;
14	(D) a corrective action authorized in a corrective action plan
15	approved by the Secretary of Natural Resources under section 6615b of this
16	title;
17	(E) a corrective action authorized in a corrective action plan
18	approved by the Secretary of Natural Resources under chapter 159,

8	Sec. 3. WAIVER OF BEVERAGE CONTAINER REDEMPTION
9	REQUIREMENTS
10	After consultation with interested parties, the Secretary of Natural
11	Resources shall submit to the House Committee on Natural Resources, Fish,
12	and Wildlife and the Senate Committee on Natural Resources and Energy
13	recommended changes to the standards or criteria by which the Secretary of
14	Natural Resources authorizes a retailer who sells beverage containers to refuse
15	to redeem beverage containers. The Secretary shall submit the
16	recommendation changes as part of the report required under 10 V.S.A.

13	container redemption"
