- (a) Creation. There is created a the Clean Water Fund Board which shall
 recommend to the Secretary of Administration expenditures from the Clean
 Water Fund. The Clean Water Fund Board shall be attached to the Agency of
 Administration for administrative purposes.
 - (b) Organization of the Board. The Clean Water Fund Board shall be composed of:
 - (1) the The Secretary of Administration or designee;
- 17 (2) the <u>The Secretary of Natural Resources or designee</u>;
- 18 (3) the <u>The Secretary of Agriculture</u>, Food and Markets or designee;
- (4) the <u>The</u> Secretary of Commerce and Community Development ordesignee; and.
- 21 (5) the <u>The</u> Secretary of Transportation or designee.

1	(6) Four members of the public to be appointed as follows:
2	(A) The Speaker of the House of Representatives shall appoint two
3	members of the public, one of whom shall be a municipal official.
4	(B) The Committee on Committees shall appoint two members of the

4	(g) Terms; appointed members. Members who are appointed to the Clean
5	Water Fund Board shall be appointed for terms of three years, except initially,
6	appointments shall be made such that one member appointed by the Speaker
7	shall be appointed for a term of two years, and one member appointed by the
8	Committee on Committees shall be appointed for a term of one year.
9	Vacancies on the Board shall be filled for the remaining period of the term in
10	the same manner as initial appointments.
