14	It is hereby enacted by the General Assembly of the State of Vermont:

18	(i) The Secretary shall not process an application for which the applicable
19	fee has not been paid unless the Secretary specifies that the fee may be paid at
20	a different time or unless the person applying for the permit is exempt from the

1	permit fee requirements pursuant to 32 V.S.A. § 710. Municipalities shall be
2	exempt from the payment of fees under this section except for those fees
3	prescribed in subdivisions $(j)(1)$, (7) , (8) , (14) , and (15) of this section for
4	which a municipality may recover its costs by charging a user fee to those who
5	use the permitted services. Municipalities shall pay fees prescribed in
6	subdivisions (j)(2), (10), (11), (12), and (26), except that a municipality shall
7	also be exempt from those fees for stormwater systems prescribed in
8	subdivision $(j)(2)(A)(iii)(I)$, (II) , or (IV) and $(j)(2)(B)(iv)(I)$, (II) , or (V) of this
9	section for which a municipality has assumed full legal responsibility under
10	10 V.S.A. § 1264. An air contaminant source shall be exempt from the fees
11	required under subdivisions (j)(1)(A) and (B) when the source of the emissions
12	is the anaerobic digestion of agricultural products, agricultural by-products,
13	agricultural waste, or food waste.
14	(j) In accordance with subsection (i) of this section, the following fees are
15	established for permits, licenses, certifications, approvals, registrations, orders,
16	and other actions taken by the Agency of Natural Resources.
17	(1) For air pollution control permits or registrations issued under
18	10 V.S.A. chapter 23:
19	(A) Any persons subject to the provisions of 10 V.S.A. § 556 shall
20	submit with each permit application or with each request for a permit
21	amendment, a base service fee in accordance with the base fee schedule in

1	subdivision (i) of this subdivision (1)(A). Prior to taking final action under
2	10 V.S.A. § 556 on any application for a permit for a nonmajor stationary
3	source or on any request for an amendment of a permit for such a source, the
4	Secretary shall assess each applicant for any additional fees due to the Agency,
5	assessed in accordance with the base fee schedule and the supplementary fee
6	schedule in subdivision (ii) of this subdivision (1)(A). The applicant shall
7	submit any fees so assessed to the Secretary prior to issuance of the final
8	permit, notwithstanding the provisions of subsection (i) of this section. The
9	base fee schedule and the supplementary fee schedule are applicable to all
10	applications on which the Secretary makes a final decision on or after the date
11	on which this section is operative.

5	pound of such emissions except that a plant producing renewable energy as
6	defined in 30 V.S.A. § 8002 shall pay an annual fee not exceeding \$64,000.00.
