5	Statement of purpose of bill as introduced: This bill proposes to amend the
6	Secretary of Agriculture, Food and Markets' authority to administer and
7	enforce requirements for the growing, harvesting, packing, and holding of
8	produce for human consumption. The bill would also clarify what constitutes
9	arrival of the conveyance onto facility property for the purpose of the transport
10	of livestock and poultry to slaughter.

12	It is hereby enacted by the General Assembly of the State of Vermont:

14	Sec. 1. 6 V.S.A. § 21(b) is amended to read:
15	(b) The Secretary shall have the authority to:
16	(1) respond to and remediate incidences of mass animal death,
17	agricultural structure fires, or other emergencies on a farm in order to prevent a
18	public health hazard;
19	(2) condemn, confiscate, or establish restrictions on the use, sale, or
20	distribution of adulterated raw agricultural commodities or animal feed; and

1	(3) cooperate with the Department of Health and other State and federal
2	agencies regarding:
3	(A) the prevention or remediation of the adulteration of raw
4	agricultural commodities, food, or animal feed on farms; and
5	(B) application of the FDA Food Safety Modernization Act,
6	21 U.S.C. §§ 2201-2252 Pub. L. No. 111-353, to farms, farm products, or
7	value-added products produced in the State.

9	§ 852. AUTHORITY; ENFORCEMENT
10	(a) The Secretary may enforce in the State the requirements of:
11	(1) the rules adopted under the federal U.S. Food and Drug
12	Administration Food Safety Modernization Act, Public Law No. 111-353, for
13	standards for growing, harvesting, packing, and holding of produce for human
14	consumption Standards for Growing, Harvesting, Packing, and Holding of
15	Produce for Human Consumption, 21 C.F.R. part 112; and
16	(2) rules adopted under this chapter.
17	(b)(1) The Secretary may issue administrative orders necessary to
18	implement the purposes of this chapter, including orders for the stop sale,
19	recall, embargo, destruction, quarantine, and release of produce. The Secretary
20	also may take any action authorized under chapter 1 of this title.

1	(2) An administrative order issued under this section shall include:
2	(A) a statement of the legal authority and jurisdiction under which
3	the hearing is to be held;
4	(B) a statement of the matter at issue, including reference to the
5	particular statute allegedly violated and a factual description of the alleged
6	violation;
7	(C) the proposed administrative action;
8	(D) a statement that the administrative order is effective upon receipt
9	unless stayed by a request for a hearing filed within 15 days from the date the
10	order was issued.
11	(3) A person who receives an administrative order pursuant to this
12	section shall be deemed to have waived the right to a hearing, unless within
13	15 days of the receipt of the administrative order, the person requests a hearing
14	in writing.
15	(4) A person aggrieved by an administrative order may request a hearing
16	before the Secretary in accordance with 3 V.S.A. chapter 25.
17	(5) A person aggrieved by a final decision of the Secretary may appeal
18	de novo to the Civil Division of the Superior Court within 30 days of the final
19	decision of the Secretary.
20	(c) The Agency may collaborate with the Vermont Department of Health

8	rules adopted thereunder;
9	(2) monies appropriated to the Agency by the State for the purpose of
10	administering this chapter; and
11	(3) other gifts, bequests, and donations by private entities for the
12	purposes of administering this chapter.

14	§ 853. FARM INSPECTIONS
15	(a)(1) The Secretary may inspect a produce farm during reasonable hours
16	for the purposes of ensuring compliance with:
17	(A) the federal standards for growing, harvesting, packing, and
18	holding of produce for human consumption, as adopted under 21 C.F.R.
19	part 112; or
20	(B) the rules adopted under this chapter.

1	(2) This section shall not limit the Secretary's authority to respond to an
2	emergency in order to prevent a public health hazard under section 21 of this
3	title.
4	(b) After inspection, the Secretary may issue an inspection certificate that
5	shall include the date and place of inspection along with any other pertinent
6	facts that the Secretary may require.
7	(c) The Secretary may coordinate with other State agencies and
8	organizations to carry out inspections at or near the same time on a given
9	produce farm.
10	* * * Livestock and Poultry Transport for Slaughter * * *
11	Sec. 4. 6 V.S.A. § 1461a(c) is amended to read:
12	(c) Livestock and poultry that are transported to a commercial slaughter
13	facility within the State shall not be removed from the facility without the
14	facility's owner first obtaining written permission from the State Veterinarian.
15	For purposes of this section, arrival of the conveyance onto facility property
16	and the offloading of livestock or poultry constitutes transport to a slaughter
17	facility, regardless of whether the animals have been offloaded or presented for
18	antemortem inspection. The State Veterinarian may require inspection and
19	testing prior to issuing consent for removal.
