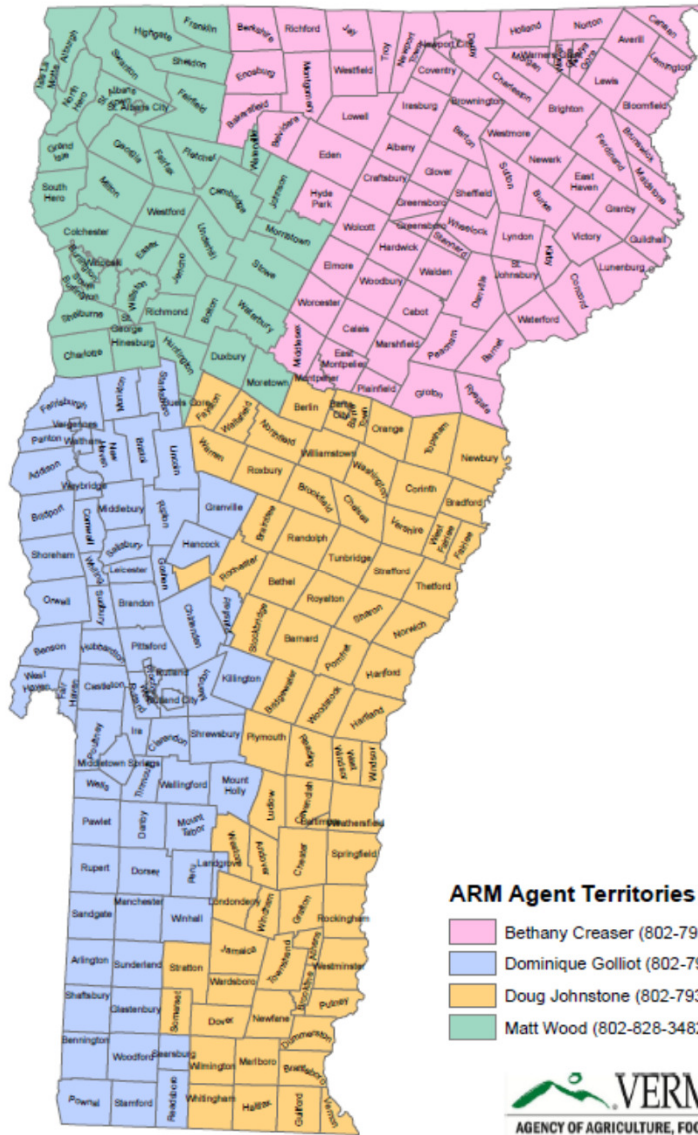

Four field agents for the State

- Animal feed
- Seed
- Fertilizer
- Hemp
- Water Quality
- Nursery
- Pesticide Regulations
 - Permitting (golf course, right-of-way, aerial, animal)
 - Marketplace Inspections
 - Private, commercial, non-commercial, government applicators
 - Agricultural, forestry, turf, ornamental, aquatic, structural, institutional, food processing, mosquito, ticks and research
 - Trainings (attended 40, presented at 31)
 - Wastes/proper disposal
 - Outreach to municipalities for ROW treatment
 - Federal Inspections
 - Field sampling; groundwater/surface water
 - Worker Protection

FIFRA-Federal Insecticide Fungicide Rodenticide Act- State Role

- Economic analysis component
 - Risk vs. Cost
- Protect Human Health and the Environment
 - Primacy over use
 - Permits, State restrictions
- Consumer Protection
 - Did you get only what you paid for
 - Does it work?
- Ensure availability of effective pesticides
 - State Registrations
 - Emergency Exemptions
 - Special Local Needs
- Enforcement

Program Prioritization

- Use Cases: Drift, food tolerance concerns (fruit, corn), misuse on/near schools (right-of-way, athletic fields),
- Inspection and review of all golf course permits, compliance with Act 64
- Chlorpyrifos-?
- Hemp; medical dispensaries (WPS, nursery)
- EAB, FTC, armyworm
- Trainings, assistance
- Research for regulatory decisions

- Never reviewed for cost
- No resources assigned

Unintended Consequences

- Non-ag. Fertilizer tonnage tax
 - Directs consumers away from specialty fertilizers
 - Increase in phosphorus use on turf
 - Directing sales out of state
- 2,4-D Drift-Bedstraw control
 - Aminopyralid restrictions
- Neonic usage spike
 - Bifenthrin in sediments
