RE: Vermont State Library Grant with Vermont Law School: Year End Report

Dear Ms. Reid,

This correspondence provides a year-end summary of expenditures and activities for the 2015-2016 Grant Agreement #11300-16-VLS-01 from the Vermont Department of Libraries to the Vermont Law School. Our inaugural year has been a success. As the word spread about CLIC (Community Legal Information Corner,) the usage continued to increase. After Natalia May arrived in late December 2015, she implemented formal statistic gathering as of January 1, 2016. As you will see from the attached Gimlet report covering January 1 – June 30th, we logged 328 reference transactions. Together with Natalia, my reference colleagues and I worked with attorneys, self-represented litigants, inmates and other members of the public to provide legal information and research guidance.

During the period January 1, 2016 – June 30, 2016, the Vermont Law School library documented the following work in satisfaction of the grant:

- Answered 328 reference and directional questions from the public
 - o 59 via the Ask a Law Librarian Line
 - o 52 via direct Email
 - o 117 via walk in patron
 - o 100 inmate requests for legal materials
- Identified 117 visitors. We do not ask visitors to check in, so the actual number of visitors is likely higher.
- Logged 4,800 transactions, on Westlaw public access legal research terminals (August 1, 2015 – June 30, 2016)
- Community Legal Research Corner (CLIC) Coordinator Salary and Benefits December 17, 2015 – June 30, 2016 = \$14,799.13.

In addition to the Gimlet report, attached please also find a spreadsheet itemizing expenditures. In the final months of the grant, we purchased a much needed scanner and a printer/fax for use by public legal researchers. In addition to other supplies, we allocated remaining funds to overhead implementation costs including work completed by VLS IT, Human Resources and Buildings and Grounds departments. Our 2015-2016 grant expenditures totaled \$67,308.56. I am happy to answer questions about any of the expenses listed.

Please let me know what you need from me to move ahead with the 2016-2017 grant funding. Thank you for your continued support of this program. We look forward to continuing to serve the State of Vermont this year.
