14	(I)(i) In the case of police officers, rescue or ambulance workers, or
15	firefighters, post-traumatic stress disorder that is diagnosed by a mental health
16	professional shall be presumed to have been incurred during service in the line
17	of duty and shall be compensable, unless it is shown by a preponderance of the
18	evidence that the post-traumatic stress disorder was caused by nonservice-
19	connected risk factors or nonservice-connected exposure.
20	(ii) A police officer, rescue or ambulance worker, or firefighter
21	who is diagnosed with post-traumatic stress disorder within three years of the

1	last active date of employment as a police officer, rescue or ambulance worker,
2	or firefighter shall be eligible for benefits under this subdivision (11).
3	(iii) As used in this subdivision (11)(I):
4	(I) "Firefighter" means a firefighter as defined in 20 V.S.A.
5	§ 3151(3) and (4).
6	(II) "Mental health professional" means a person with
7	professional training, experience, and demonstrated competence in the
8	treatment and diagnosis of mental conditions, who is certified or licensed by
9	this State to provide mental health care services and for whom diagnoses of
10	mental conditions are within his or her scope of practice, including a physician,
11	nurse with recognized psychiatric specialties, psychologist, clinical social
12	worker, mental health counselor, or alcohol or drug abuse counselor.
13	(III) "Police officer" means a law enforcement officer who has
14	been certified by the Vermont Criminal Justice Training Council pursuant to
15	20 V.S.A. chapter 151.
16	(IV) "Rescue or ambulance worker" means ambulance service,
17	emergency medical personnel, first responder service, and volunteer personnel
18	as defined in 24 V.S.A. § 2651.
19	(J)(i) A mental condition resulting from a work-related event or
20	work-related stress shall be considered a personal injury by accident arising out

1	of and in the course of employment and be compensable if it is demonstrated
2	by the preponderance of the evidence that:
3	(I) the work-related event or work-related stress was
4	extraordinary and unusual in comparison to pressures and tensions experienced
5	by the average employee across all occupations; and
6	(II) the work-related event or work-related stress, and not some
7	other event or source of stress, was the predominant cause of the mental
8	condition.
9	(ii) A mental condition shall not be considered a personal injury
10	by accident arising out of and in the course of employment if it results from
11	any disciplinary action, work evaluation, job transfer, layoff, demotion,
12	termination, or similar action taken in good faith by the employer.
