

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Commerce and Economic Development to which was
3 referred Senate Bill No. 135 entitled “An act relating to promoting economic
4 development” respectfully reports that it has considered the same and
5 recommends that the House propose to the Senate to amend the bill by striking
6 out all after the enacting clause and inserting in lieu thereof the following:

7 * * * Vermont Employment Growth Incentive Program * * *

8 Sec. A.1. 32 V.S.A. chapter 105 is amended to read:

9 CHAPTER 105. VERMONT EMPLOYMENT GROWTH

10 INCENTIVE PROGRAM

11 * * *

12 § 3332. APPLICATION; APPROVAL CRITERIA

13 (a) Application.

14 (1) A business may apply for an incentive in one or more years of an
15 award period by submitting an application to the Council in the format the
16 Council specifies for that purpose.

17 (2) For each award year the business applies for an incentive, the
18 business shall:

19 (A) specify a payroll performance requirement;

20 (B) specify a jobs performance requirement or a capital investment
21 performance requirement, or both; and

1 (C) provide any other information the Council requires to evaluate
2 the application under this subchapter.

3 (b) Mandatory criteria. The Council shall not approve an application
4 unless it finds:

5 (1) Except as otherwise provided for an enhanced incentive for a
6 business in a qualifying labor market area under section 3334 of this title, the
7 new revenue the proposed activity ~~generates~~ would generate to the State
8 ~~exceeds~~ would exceed the costs of the activity to the State.

9 (2) The host municipality welcomes the new business.

10 (3) ~~The~~ Pursuant to a self-certification or other documentation the
11 Council requires by rule or procedure, the business attests to the best of its
12 knowledge:

13 (A) the business is not a named party to an administrative order,
14 consent decree, or judicial order issued by the State or a subdivision of the
15 State, or if a named party, that the business is in compliance with the terms of
16 such an order or decree;

17 (B) the business complies with applicable State laws and
18 regulations; and

19 (C) the proposed economic activity ~~conforms~~ would conform to
20 applicable town and regional plans and with applicable State laws and
21 regulations.

1 (4) If the business proposes to expand within a limited local market, an
2 incentive would not give the business an unfair competitive advantage over
3 other Vermont businesses in the same or similar line of business and in the
4 same limited local market.

5 (5) But for the incentive, the proposed economic activity:

6 (A) would not occur; or

7 (B) would occur in a significantly different manner that is
8 significantly less desirable to the State.

9 * * *

10 § 3334. ENHANCED INCENTIVE FOR A BUSINESS IN A QUALIFYING
11 LABOR MARKET AREA

12 (a) The Council may increase the value of an incentive for a business that is
13 located in a labor market area in which:

14 (1) the average annual unemployment rate is greater than the average
15 annual unemployment rate for the State; or

16 (2) the average annual wage is less than the average annual wage for the
17 State.

18 (b) In each calendar year, the amount by which the Council may increase
19 the value of all incentives pursuant to this section is:

20 (1) \$1,500,000.00 for one or more initial approvals; and

21 (2) \$1,000,000.00 for one or more final approvals.

1 (c) The Council may increase the cap imposed in subdivision (b)(2) of this
2 section by not more than \$500,000.00 upon application by the Governor to,
3 and approval of, the Joint Fiscal Committee.

4 (d) In evaluating the Governor’s request, the Committee shall consider the
5 economic and fiscal condition of the State, including recent revenue forecasts
6 and budget projections.

7 (e) The Council shall provide the Committee with testimony,
8 documentation, company-specific data, and any other information the
9 Committee requests to demonstrate that increasing the cap will create an
10 opportunity for return on investment to the State.

11 (f) The purpose of the enhanced incentive for a business in a qualifying
12 labor market area is to increase job growth in economically disadvantaged
13 regions of the State, as provided in subsection (a) of this section.

14 § 3335. ENHANCED INCENTIVE FOR ENVIRONMENTAL
15 TECHNOLOGY BUSINESS

16 (a) As used in this section, an “environmental technology business” means
17 a business that:

18 (1) is subject to income taxation in Vermont; and

19 (2) seeks an incentive for economic activity in Vermont that the

20 Secretary of Commerce and Community Development certifies is primarily

1 research, design, engineering, development, or manufacturing related to one or
2 more of the following:

3 (A) waste management, including waste collection, treatment,
4 disposal, reduction, recycling, and remediation;

5 (B) natural resource protection and management, including water and
6 wastewater purification and treatment, air pollution control and prevention or
7 remediation, soil and groundwater protection or remediation, and hazardous
8 waste control or remediation;

9 (C) energy efficiency or conservation;

10 (D) clean energy, including solar, wind, wave, hydro, geothermal,
11 hydrogen, fuel cells, waste-to-energy, or biomass.

12 (b) The Council shall consider and administer an application from an
13 environmental technology business pursuant to the provisions of this
14 subchapter, except that:

15 (1) the business's potential share of new revenue growth shall be 90
16 percent; and

17 (2) to calculate qualifying payroll, the Council shall:

18 (A) determine the background growth rate in payroll for the
19 applicable business sector in the award year;

20 (B) multiply the business's full-time payroll for the award year by 20
21 percent of the background growth rate; and

1 (C) subtract the product from the payroll performance requirement
2 for the award year.

3 (c) The purpose of the enhanced incentive for an environmental technology
4 business is to promote the growth of businesses in Vermont that both create
5 and sustain high quality jobs and improve the natural environment.

6 * * *

7 § 3338. CLAIMING AN INCENTIVE; ANNUAL FILING WITH
8 DEPARTMENT OF TAXES

9 (a) On or before April 30 following each year of the utilization period, a
10 business with an approved application shall submit an incentive claim to the
11 Department of Taxes.

12 (b) A business shall include:

13 (1) the information the Department requires, including the information
14 required in section 5842 of this title and other documentation concerning
15 payroll, jobs, and capital investment necessary to determine whether the
16 business earned the incentive specified for an award year and any installment
17 payment for which the business is eligible; and

18 (2) a self-certification or other documentation the Department requires
19 by rule or procedure, by which the business attests to the best of its knowledge
20 that:

1 (A) the business is not a named party to an administrative order,
2 consent decree, or judicial order issued by the State or a subdivision of the
3 State, or if a named party, that the business is in compliance with the terms of
4 such an order or decree; and

5 (B) the business complies with applicable State laws and regulations.

6 (c) The Department may consider an incomplete claim to be timely filed if
7 the business files a complete claim within the additional time allowed by the
8 Department in its discretion.

9 (d) Upon finalizing its review of a complete claim, the Department shall:

10 (1) notify the business and the Council whether the business is entitled
11 to an installment payment for the applicable year; and

12 (2) make an installment payment to which the business is entitled.

13 (e) The Department shall not pay interest on any amounts it holds or pays
14 for an incentive or installment payment pursuant to this subchapter.

15 § 3339. RECAPTURE; REDUCTION; REPAYMENT

16 (a) Recapture.

17 (1) The Department of Taxes may recapture the value of one or more
18 installment payments a business has claimed, with interest, if:

19 (A) the business fails to file a claim as required in section 3338 of
20 this title; ~~or~~

21 (B) during the utilization period, the business experiences:

1 (i) a 90 percent or greater reduction from base employment; or

2 (ii) if it had no jobs at the time of application, a 90 percent or
3 greater reduction from the sum of its job performance requirements; or

4 (C) the Department determines that during the application or claims
5 process the business knowingly made a false attestation that the business:

6 (i) was not a named party to, or was in compliance with, an
7 administrative order, consent decree, or judicial order issued by the State or a
8 subdivision of the State: or

9 (ii) was in compliance with State laws and regulations.

10 (2) If the Department determines that a business is subject to recapture
11 under subdivision (1) of this subsection, the business becomes ineligible to
12 earn or claim an additional incentive or installment payment for the remainder
13 of the utilization period.

14 (3) Notwithstanding any other statute of limitations, the Department
15 may commence a proceeding to recapture amounts under subdivision (1) of
16 this subsection as follows:

17 (A) under subdivision (1)(A) of this subsection, no later than three
18 years from the last day of the utilization period; and

19 (B) under subdivision (1)(B) of this subsection, no later than three
20 years from date the business experiences the reduction from base employment,
21 or three years from the last day of the utilization period, whichever occurs first.

1 (b) Reduction; recapture. If a business fails to make capital investments
2 that equal or exceed the sum of its capital investment performance
3 requirements by the end of the award period:

4 (1) The Department shall:

5 (A) calculate a reduced incentive by multiplying the combined value
6 of the business's award period incentives by the same proportion that the
7 business's total actual capital investments bear to the sum of its capital
8 investment performance requirements; and

9 (B) reduce the value of any remaining installment payments for
10 which the business is eligible by the same proportion.

11 (2) If the value of the installment payments the business has already
12 received exceeds the value of the reduced incentive, then:

13 (A) the business becomes ineligible to claim any additional
14 installment payments for the award period; and

15 (B) the Department shall recapture the amount by which the value of
16 the installment payments the business has already received exceeds the value
17 of the reduced incentive.

18 (c) Tax liability.

19 (1) A person who has the duty and authority to remit taxes under this
20 title shall be personally liable for an installment payment that is subject to
21 recapture under this section.

1 **(b)(1) The Council shall disclose information and materials described in**
2 **subsection (a) of this section:**

3 **(A)** to the Joint Fiscal Office or its agent upon authorization of the
4 Joint Fiscal Committee or a standing committee of the General Assembly, ~~and~~
5 ~~shall also be available; and~~

6 **(B)** to the Auditor of Accounts in connection with the performance of
7 duties under section 163 of this title; ~~provided, however, that the~~

8 **(2)** The Joint Fiscal Office or its agent and the Auditor of Accounts shall
9 not disclose, directly or indirectly, to any person any ~~proprietary business~~
10 information or ~~any information that would identify a business materials~~
11 **received under this subsection** ~~except in accordance with a judicial order or as~~
12 ~~otherwise specifically provided~~ **unless authorized** by law.

13 (c) Nothing in this section shall be construed to prohibit the publication of
14 statistical information, rulings, determinations, reports, opinions, policies, or
15 other information so long as the data are disclosed in a form that cannot
16 identify or be associated with a particular business.

19 Sec. A.2. 32 V.S.A. § 3102 is amended to read:

1 § 3102. CONFIDENTIALITY OF TAX RECORDS

2 (a) No present or former officer, employee, or agent of the Department of
3 Taxes shall disclose any return or return information to any person who is not
4 an officer, employee, or agent of the Department of Taxes except in
5 accordance with the provisions of this section. A person who violates this
6 section shall be fined not more than \$1,000.00 or imprisoned for not more than
7 one year, or both; and if the offender is an officer or employee of this State, he
8 or she shall, in addition, be dismissed from office and be incapable of holding
9 any public office for a period of five years thereafter.

10 * * *

11 (d) The Commissioner shall disclose a return or return information:

12 * * *

13 (5) to the Attorney General, if such return or return information relates
14 to chapter 205 of this title or 33 V.S.A. chapter 19, subchapters 1A and 1B, for
15 purposes of investigating potential violations of and enforcing 7 V.S.A. chapter
16 40, 20 V.S.A. chapter 173, subchapter 2A, and 33 V.S.A. chapter 19,
17 subchapters 1A and 1B;

18 (6) to the Vermont Economic Progress Council, provided that the
19 disclosure relates to a successful business applicant under chapter 105,
20 subchapter 2 of this title and the incentive it has claimed and is reasonably
21 necessary for the Council to perform its duties under that subchapter.

1 (e) The Commissioner may, in his or her discretion and subject to such
2 conditions and requirements as he or she may provide, including any
3 confidentiality requirements of the Internal Revenue Service, disclose a return
4 or return information:

5 * * *

6 (11) To the Joint Fiscal Office or its agent, provided that the disclosure
7 relates to a successful business applicant under chapter 105, subchapter 2 of
8 this title and the incentive it has claimed and is reasonably necessary for the
9 Joint Fiscal Office or its agent to perform the duties authorized by the Joint
10 Fiscal Committee or a standing committee of the General Assembly under that
11 subchapter; to the Auditor of Accounts for the performance of duties under
12 section 163 of this title; and to the Department of Economic Development for
13 the purposes of subsection 5922(f) of this title; ~~and to the Vermont Economic
14 Progress Council, provided that the disclosure relates to a successful business
15 applicant under chapter 105, subchapter 2 of this title and the incentive it has
16 claimed and is reasonably necessary for the Council to perform its duties under
17 that subchapter.~~

19 * * * Rural Economic Development Infrastructure Districts; H.459 * * *

20 Sec. B.1. 24 V.S.A. chapter 138 is added to read:

1 CHAPTER 138. RURAL ECONOMIC DEVELOPMENT

2 INFRASTRUCTURE DISTRICTS

3 § 5701. PURPOSE

4 The purpose of this chapter is to enable formation of special municipal
5 districts to finance, own, and maintain infrastructure that provides economic
6 development opportunities in rural and underresourced communities.
7 Specifically, this chapter provides mechanisms for public and private
8 partnerships, including opportunities for tax-incentivized financing and
9 voluntary citizen engagement, to help overcome density and economic
10 hardship.

11 § 5702. ESTABLISHMENT; GENERAL PROVISIONS

12 (a) Establishment. Upon written application by 20 or more voters within a
13 proposed district, the legislative body of a municipality may establish a rural
14 economic development infrastructure district. The application shall describe
15 the infrastructure to be built or acquired; the plan for financing its acquisition;
16 the anticipated economic benefit; the source of revenues for loan, bond, or
17 lease payments; and plans for retention and disbursement of excess revenues, if
18 any. The application also shall clearly state that the proposed district shall not
19 have authority to levy taxes upon the grand list and may not levy service
20 charges or fees upon any underlying municipality except for services used by
21 such municipality, its own officers, and employees in the operation of

1 municipal functions. Notice of establishment of a district shall be recorded as
2 provided in subsection (e) of this section, posted in at least three public places
3 within the municipality for at least 30 days, and published in a newspaper of
4 general circulation within the municipality not more than 10 days from the date
5 of establishment by the legislative body. Following 40 days from the later of
6 the date of establishment by the legislative body of the municipality or an
7 affirmative vote under subdivision (d)(1) or (2) of this section, the district shall
8 be deemed to be a body politic and corporate, capable of exercising those
9 powers and prerogatives explicitly granted by the legislative body of the
10 municipality in accordance with this chapter and the district's establishment
11 application.

12 (b) Districts involving more than one municipality. Where the limits of a
13 proposed district include two or more municipalities, or portions of two or
14 more municipalities, the application required by this section shall be made to
15 and considered by the legislative body of each such municipality.

16 (c) Alteration of district limits. The legislative body of a municipality in
17 which a district is located may alter the limits of a district upon application to
18 the governing board of the district, provided the governing board gives prior
19 written consent. A district expansion need not involve contiguous property.
20 Notice of an alteration of the limits of a district shall be recorded as provided
21 in subsection (e) of this section, posted in at least three public places within the

1 municipality for at least 30 days, and published in a newspaper of general
2 circulation within the municipality not more than 10 days from the date of the
3 legislative body’s decision to alter the limits of a district.

4 (d)(1) Contestability. If a petition signed by five percent of the voters of
5 the municipality objecting to the proposed establishment or alteration of limits
6 of a district is presented to the municipal clerk within 30 days of the date of
7 posting and publication of the notice required by subsection (a) or (c) of this
8 section, as applicable, the legislative body of the municipality shall cause the
9 question of whether the municipality shall establish or alter the limits of the
10 district to be considered at a meeting called for that purpose. The district shall
11 be established in accordance with the application or the limits altered unless a
12 majority of the voters of the municipality present and voting votes to
13 disapprove such establishment or alteration of limits.

14 (2) If a petition signed by five percent of the voters of the municipality
15 objecting to a legislative body’s decision denying the establishment or the
16 alteration of limits of a district is presented to the municipal clerk within 30
17 days of the legislative body’s decision, the legislative body shall cause the
18 question of whether the municipality shall establish or alter the limits of the
19 district to be considered at an annual or special meeting called for that purpose.

20 (e) Recording. A record of the establishment of a district and any alteration
21 of district limits made by a legislative body shall be filed with the clerk of each

1 municipality in which the district is located, and shall be recorded with the
2 Secretary of State.

3 § 5703. LIMITATIONS; TAXES; INDEBTEDNESS

4 Notwithstanding any grant of authority in this chapter to the contrary:

5 (1) A district shall not accept funds generated by the taxing or
6 assessment power of any municipality in which it is located.

7 (2) A district shall not have the power to levy, assess, apportion, or
8 collect any tax upon property within the district, nor upon any of its underlying
9 municipalities, without specific authorization of the General Assembly.

10 (3) All obligations of the district, including financing leases, shall be
11 secured by and payable only out of revenues or monies in the district,
12 including revenue generated by an enterprise owned or operated by the district.

13 § 5704. GOVERNING BOARD; COMPOSITION; MEETINGS; REPORT

14 (a) Governing board. The legislative power and authority of a district and
15 the administration and the general supervision of all fiscal, prudential, and
16 governmental affairs of a district shall be vested in a governing board, except
17 as otherwise specifically provided in this chapter.

18 (b) Composition. The first governing board of the district shall consist of
19 four to eight members appointed in equal numbers by the legislative bodies of
20 the underlying municipalities. It shall draft the district's bylaws specifying the
21 size, composition, and manner of appointing members to the permanent

1 governing board. The bylaws shall require that a majority of the board shall be
2 appointed annually by the legislative bodies of the underlying municipalities.
3 Board members shall serve staggered, three-year terms, and shall be eligible to
4 serve successive terms. The legislative bodies of the municipalities in which
5 the district is located shall fill board vacancies, and may remove board
6 members at will.

7 (c) First meeting. The first meeting of the district shall be called upon 30
8 days' posted and published notice by a presiding officer of a legislative body
9 in which the district is located. Voters within a municipality in which the
10 district is located are eligible to vote at annual and special district meetings. At
11 the first meeting of the district, and at each subsequent annual meeting, there
12 shall be elected from among board members a chair, vice chair, clerk, and
13 treasurer who shall assume their respective offices upon election. At the first
14 meeting, the fiscal year of the district shall be established and rules of
15 parliamentary procedure shall be adopted. Prior to assuming their offices,
16 officers may be required to post bond in such amounts as determined by
17 resolution of the board. The cost of such bond shall be borne by the district.

18 (d) Annual and special meetings. Unless otherwise established by the
19 voters, the annual district meeting shall be held on the second Monday in
20 January and shall be warned by the clerk or, in the clerk's absence or neglect,
21 by a member of the board. Special meetings shall be warned in the same

1 manner on application in writing by five percent of the voters of the district. A
2 warning for a district meeting shall state the business to be transacted. The
3 time and place of holding the meeting shall be posted in two or more public
4 places in the district not more than 40 days nor less than 30 days before the
5 meeting and recorded in the office of the clerk before the same is posted.

6 (e) Annual report. The district shall report annually to the legislative
7 bodies and the citizens of the municipalities in which the district is located on
8 the results of its activities in support of economic growth, job creation,
9 improved community efficiency, and any other benefits incident to its
10 activities.

11 § 5705. OFFICERS

12 (a) Generally. The district shall elect at its first meeting and at each annual
13 meeting thereafter a chair, vice chair, clerk, and treasurer, who shall hold
14 office until the next annual meeting and until others are elected. The board
15 may fill a vacancy in any office.

16 (b) Chair. The chair shall preside at all meetings of the board and make
17 and sign all contracts on behalf of the district upon approval by the board. The
18 chair shall perform all duties incident to the position and office as required by
19 the general laws of the State.

20 (c) Vice chair. During the absence of or inability of the chair to render or
21 perform his or her duties or exercise his or her powers, the same shall be

1 performed and exercised by the vice chair and when so acting, the vice chair
2 shall have all the powers and be subject to all the responsibilities given to or
3 imposed upon the chair. During the absence or inability of the vice chair to
4 render or perform his or her duties or exercise his or her powers, the board
5 shall elect from among its members an acting vice chair who shall have the
6 powers and be subject to all the responsibilities given or imposed upon the vice
7 chair.

8 (d) Clerk. The clerk shall keep a record of the meetings, votes, and
9 proceedings of the district for the inspection of its inhabitants.

10 (e) Treasurer. The treasurer of the district shall be appointed by the board,
11 and shall serve at its pleasure. The treasurer shall have the exclusive charge
12 and custody of the funds of the district and shall be the disbursing officer of the
13 district. When authorized by the board, the treasurer may sign, make, or
14 endorse in the name of the district all checks and orders for the payment of
15 money and pay out and disburse the same and receipt therefor. The treasurer
16 shall keep a record of every obligation issued and contract entered into by the
17 district and of every payment made. The treasurer shall keep correct books of
18 account of all the business and transactions of the district and such other books
19 and accounts as the board may require. The treasurer shall render a statement
20 of the condition of the finances of the district at each regular meeting of the
21 board and at such other times as required of the treasurer. The treasurer shall

1 prepare the annual financial statement and the budget of the district for
2 distribution, upon approval of the board, to the legislative bodies of district
3 members. Upon the treasurer’s termination from office by virtue of removal or
4 resignation, the treasurer shall immediately pay over to his or her successor all
5 of the funds belonging to the district and at the same time deliver to the
6 successor all official books and papers.

7 § 5706. AUDIT

8 Once the district becomes operational, the board shall cause an audit of the
9 financial condition of the district to be performed annually by an independent
10 professional accounting firm.

11 § 5707. COMMITTEES

12 The board has authority to establish one or more committees and grant and
13 delegate to them such powers as it deems necessary. Members of an executive
14 committee shall serve staggered terms and shall be board members.

15 Membership on other committees established by the board is not restricted to
16 board members.

17 § 5708. DISTRICT POWERS

18 A district created under this chapter has the power to:

19 (1) exercise independently and in concert with other municipalities any
20 other powers which are necessary or desirable for the installation, ownership,
21 operation, maintenance, and disposition of infrastructure promoting economic

1 development in rural communities and matters of mutual concern and that are
2 exercised or are capable of exercise by any of its members;

3 (2) enter into municipal financing agreements as provided by sections
4 1789 and 1821-1828 of this title, or other provisions authorizing the pledge of
5 net revenue, or alternative means of financing capital improvements and
6 operations;

7 (3) purchase, sell, lease, own, acquire, convey, mortgage, improve, and
8 use real and personal property in connection with its purpose;

9 (4) enter into contracts for any term or duration;

10 (5) operate, cause to be operated, or contract for the construction,
11 ownership, management, financing, and operation of an enterprise which a
12 municipal corporation is authorized by law to undertake;

13 (6) hire employees and fix the compensation and terms of employment;

14 (7) contract with individuals, corporations, associations, authorities, and
15 agencies for services and property, including the assumption of the liabilities
16 and assets thereof, provided that no assumed liability shall be a general
17 obligation of either the district or a municipality in which the district is located;

18 (8) contract with the State of Vermont, the United States of America, or
19 any subdivision or agency thereof for services, assistance, and joint ventures;

20 (9) contract with any municipality for the services of any officers or
21 employees of that municipality useful to it;

1 (10) promote cooperative arrangements and coordinated action among
2 its members and other public and private entities;

3 (11) make recommendations for review and action to its members and
4 other public agencies that perform functions within the region in which its
5 members are located;

6 (12) sue and be sued; provided, however, that the property and assets of
7 the district, other than such property as may be pledged as security for a district
8 obligation, shall be subject to levy, execution, or attachment;

9 (13) appropriate and expend monies; provided, however, that no
10 appropriation shall be funded or made in reliance upon any taxing authority of
11 the district;

12 (14) establish sinking and reserve funds for retiring and securing its
13 obligations;

14 (15) establish capital reserve funds and make deposits in them;

15 (16) solicit, accept, and administer gifts, grants, and bequests in trust or
16 otherwise for its purpose;

17 (17) exercise all powers incident to a public corporation, but only to the
18 extent permitted in this chapter; and

19 (18) adopt a name under which it shall be known and shall conduct
20 business.

1 § 5709. DISSOLUTION

2 (a) If the board by resolution approved by a two-thirds vote determines that
3 it is in the best interests of the public, the district members, and the district that
4 such district be dissolved, and if the district then has no outstanding
5 obligations under pledges of communications plant net revenue, long-term
6 contracts, or contracts subject to annual appropriation, or will have no such
7 debt or obligation upon completion of the plan of dissolution, it shall prepare a
8 plan of dissolution and thereafter adopt a resolution directing that the question
9 of such dissolution and the plan of dissolution be submitted to the voters of the
10 district at a special meeting thereof duly warned for such purpose. If a
11 majority of the voters of the district present and voting at such special meeting
12 shall vote to dissolve the district and approve the plan of dissolution, the
13 district shall cease to conduct its affairs except insofar as may be necessary for

6 activity in the financial technology sector that would provide opportunities for
7 employment, tax revenues, and other benefits.

8 (5) Furthermore, it is important for Vermonters that these developments
9 proceed in ways that do not create avoidable risks for individuals and
10 enterprises in the new e-economy.

11 (6) The legislative and regulatory response in Vermont will be critical to
12 our ability to embrace the benefits of financial technology and to avoid
13 challenges it may create.

14 (b)(1) In order to permit the legislature to respond to these developing
15 opportunities and concerns on an informed basis, on or before November 30,
16 2017 the Center for Legal Innovation at Vermont Law School, in consultation
17 with the Commissioner of Financial Regulation, the Secretary of Commerce
18 and Community Development, and the Attorney General, shall submit a report
19 to the General Assembly that includes:

17 (2) Vermont has a tremendous opportunity to systematically advance
18 economic activity that addresses the challenge of climate change by reducing
19 and mitigating carbon impacts, while spurring innovation and creativity,
20 encouraging entrepreneurship, attracting youth, and building jobs for the future.

1 (3) The Vermont Sustainable Jobs Fund, the Vermont Council on Rural
2 Development, and a working group of business, finance, and economic
3 development leaders, are developing the Climate Economy Business
4 Accelerator Program (Accelerator Program) to grow entrepreneurial
5 opportunities and provide a network for businesses to promote their solutions,
6 products, and services that can lead to collaboration and innovation.

7 (4) The Accelerator Program aims to accelerate the creation and growth
8 of entrepreneurs that commercialize business solutions to address the negative
9 impacts of climate change and position our State as the place to come and
10 build businesses that export solutions for a changing climate worldwide.

11 (5) The Accelerator Program selects a cohort of typically early stage
12 businesses to participate together in a time limited series of trainings,
13 mentorships, and investment opportunities. The Accelerator Program exposes
14 promising businesses and technologies to the lessons learned by successful
15 entrepreneurs and investors. It helps early stage businesses clarify the market
16 for their product, evaluate the needs of their management team, define their
17 business model, and articulate their unique value, all with the intention of
18 making them more attractive to the investment capital they need.

16 (b) Purpose. The purpose of Sec. K.2 of this act is to provide funding
17 necessary to most effectively implement the Climate Economy Business
18 Accelerator Program to grow climate economy entrepreneurial and start-up
19 enterprises.

20 Sec. K.2. APPROPRIATION

1 In fiscal year 2018, the amount of \$300,000.00 is appropriated from the
2 General Fund to the Vermont Sustainable Jobs Fund for the purpose of
3 leveraging additional private and philanthropic funding, which the Vermont
4 Sustainable Jobs Fund shall use to implement the Climate Economy Business
5 Accelerator Program.

6 * * * Pathways to Prosperity; H.452 * * *

7 L.1. PATHWAYS TO PROSPERITY

8 The Agencies of Education and Commerce and Community Development,
9 in collaboration with the Department of Labor, shall design and implement the
10 Vermont Pathways to Prosperity, the purpose of which shall be to align
11 educational opportunities with job opportunities in Vermont.

12 * * * Opportunity Economy; Microbusiness Development; Individual
13 Development Accounts; Job Training; H.480 * * *

14 Sec. M.1. MICROBUSINESS DEVELOPMENT PROGRAM; FINDINGS;

15 APPROPRIATION

16 (a) Findings. The General Assembly finds:

17 (1) Since 1989, the Microbusiness Development Program has provided
18 free business technical assistance, including training and counseling, as well as
19 access to capital to Vermonters with low income.

1 (2) The Vermont Community Action Agencies work in conjunction with
2 many partners, including other service providers, State agencies, business
3 technical assistance providers, and both traditional and alternative lenders.

4 (3) Each year the Program:

5 (A) enables the creation or expansion of an average of 145 businesses
6 across Vermont;

7 (B) supports the creation of 84 new jobs; and

8 (C) provides access to more than \$1.1 million in capital.

9 (4) The average cost per job created through the Program is less than
10 \$3,600.00.

11 (b) Intent. Current base funding for the Program is \$300,000.00, and it is
12 the intent of the General Assembly to provide total funding for the Program in
13 fiscal year 2018 of \$500,000.00.

14 (c) Appropriation. In fiscal year 2018, in addition to any other amounts
15 appropriated, the amount of \$200,000.00 is appropriated from the General
16 Fund to the Office of Economic Opportunity for pass through grants to the
17 Community Action Agencies to restore and increase funding for the regional
18 Microbusiness Development Programs pursuant to 3 V.S.A. § 3722.

19 Sec. M.2. INDIVIDUAL DEVELOPMENT SAVINGS PROGRAM;

20 FINDINGS; APPROPRIATION

21 (a) Findings. The General Assembly finds:

1 (1) The Individual Development Savings Program in the Agency of
2 Human Services offers a matched savings and financial education program that
3 helps Vermonters with low income invest in their future by enabling them to
4 build financial assets.

5 (2) Backed by federal dollars leveraged by State funds, participants
6 save, and have their savings matched 2-to-1, to purchase a home, pay tuition
7 for training or postsecondary education, or start a business.

8 (3) Since its inception in 1997:

9 (A) The Program has served 1,335 households.

10 (B) 912 Vermonters have completed their savings period and
11 invested \$2.5 million in their future, much of which has helped support their
12 local economy.

13 (C) 524 participants have invested in businesses, 207 in education,
14 and 181 in first time-home ownership.

15 (b) Intent. Current base funding for the Program is \$135,300.00, and it is
16 the intent of the General Assembly to provide total funding for the Program in
17 fiscal year 2018 of \$250,000.00 in order to assist Vermonters with low income
18 to build their financial assets and achieve economic independence.

19 (c) Appropriation. In fiscal year 2018, in addition to any other amounts
20 appropriated, the amount of \$114,700.00 is appropriated from the General
21 Fund to the Individual Development Matching Grant Special Fund to provide

1 matching funds through the Individual Development Savings Program
2 pursuant to 33 V.S.A. § 1123.

3 Sec. M.3. WORKFORCE DEVELOPMENT AND TRAINING; FINDINGS;

4 APPROPRIATION

5 (a) Findings. The General Assembly finds:

6 (1) The Vermont Community Action Agencies offer a variety of
7 workforce development and training initiatives that:

8 (A) address persistent barriers to employment faced by disadvantaged
9 workers with no, little, or unsuccessful work experience; and

10 (B) build career competencies, including:

11 (i) job seeking skills;

12 (ii) computer literacy;

13 (iii) problem solving and decision making;

14 (iv) interpersonal communication;

15 (v) personal qualities; and

16 (vi) customer service.

17 (2) Specific examples of training programs include:

18 (A) job readiness programs for at-risk youths to obtain their first
19 jobs;

20 (B) life and workplace skills training for incarcerated persons who
21 are reentering the workforce upon release;

1 (C) GED preparation, comprehensive job coaching, and group
2 worksites at parent-child centers;

3 (D) transportation assistance to individuals to enable them to prepare
4 for and attain employment; and

5 (E) skills development, career readiness, and job placement training
6 for underemployed and unemployed Vermonters for food service industry
7 careers.

8 (b) It is the intent of the General Assembly to provide sufficient funding for
9 workforce development and training for Vermonters with low income, in order
10 to increase access to the workforce and ensure a supply of job-ready,
11 dependable workers to enable Vermont employers to maintain and expand
12 their businesses.

13 (c) Appropriation. In fiscal year 2018, in addition to any other amounts
14 appropriated, the amount of \$250,000.00 is appropriated from the General
15 Fund to the Agency of Human Services for pass through grants to the
16 Community Action Agencies to fund and expand access to existing workforce
17 development and training services.

18 Sec. M.4. FINANCIAL EDUCATION, COACHING, AND CREDIT

19 BUILDING SERVICES; FINDINGS; APPROPRIATION

20 (a) Findings. The General Assembly finds:

1 (1) To overcome barriers to financial security, “Financial Capability”
2 education and coaching services empower people to stabilize their finances, set
3 goals and work to achieve them, and sustain successful financial behaviors
4 over time.

5 (2) The knowledge and skills gained by Vermonters with low income
6 enable them better to manage scarce resources, repair or build credit, and
7 establish or strengthen connections to financial institutions.

8 (3) Recent studies show that 10 hours of financial education can yield a
9 savings of \$1,390.00 per year for participants, a substantial sum for families
10 living in poverty.

11 (4) Additionally, a recent national study found that 58 percent of
12 individuals with low-to-moderate income receiving financial coaching and
13 credit building services had their credit score increase as a result.

14 (5) These services in Vermont can and have been customized to meet
15 the particular needs of families participating in Reach Up.

16 (b) It is the intent of the General Assembly to provide sufficient funding to
17 the Community Action Agencies to cover the cost of existing financial
18 education, coaching, and credit building services, and to enable more
19 Vermonters with low income to access these services.

20 (c) Appropriation. In fiscal year 2018, in addition to any other amounts
21 appropriated, the amount of \$200,000.00 is appropriated from the General

1 Fund to the Agency of Human Services for pass through grants to the
2 Community Action Agencies to provide financial education, coaching, and
3 credit building services to Vermonters with low income.

4 Sec. M.5. VERMONT MATCHED SAVINGS ACCOUNT

5 PROGRAM; APPROPRIATION

6 (a) Findings. The General Assembly finds:

7 (1) The Individual Development Savings Program established in
8 33 V.S.A. § 1123, which offers a matched savings and financial education
9 program, has helped Vermonters with low income invest in their future by
10 enabling them to build financial assets.

11 (2) Because the Individual Development Savings Program is funded in
12 part by the federal government it is subject to certain legal restrictions,
13 including federal limitations on the purpose of expenditures from individual
14 development accounts for eligible uses relating to first-time home ownership,
15 education, or entrepreneurial activity.

16 (3) An independent evaluation of individual development accounts in
17 Massachusetts found that every dollar of state funding resulted in savers
18 accumulating \$64.32 in assets, and local government collected an additional
19 \$0.43 in property taxes.

20 (4) Building on the model of the Individual Development Savings
21 Program, Vermonters with low income would benefit from a Vermont

1 Matched Savings Account Program that would provide financial education and
2 coaching, as well as matching funds for an expanded number of eligible
3 expenditures, including vehicle purchase or repair, home repair, paying down
4 debt, dental care, creating an emergency fund, and expenses that support
5 employment or housing success.

6 (b) Intent. It is the intent of the General Assembly to establish a Vermont
7 Matched Savings Account Program with State funds in order to provide
8 financial education and coaching, as well as match the savings of Vermonters
9 with low income for eligible uses.

10 (c) Appropriation. In fiscal year 2018 the amount of \$150,000.00 is
11 appropriated from the General Fund to the Agency of Human Services to
12 create a Vermont Matched Savings Account Program pursuant to 33 V.S.A.
13 § 1124.

14 Sec. M.6. 33 V.S.A. § 1124 is added to read:

15 § 1124. VERMONT MATCHED SAVINGS ACCOUNT PROGRAM

16 (a) As used in this section:

17 (1) “Agency” means the Agency of Human Services.

18 (2) “Approved expanded account program” means a program approved
19 by the Agency and administered by a service provider.

1 (3) “Approved savings plan” means a plan, approved by the service
2 provider and agreed to by the saver, which defines savings goals, program
3 requirements, and anticipated uses of the savings and matching funds.

4 (4) “Eligible use” means a use of funds approved by a service provider
5 and agreed to by a saver that will result in a long-term benefit to his or her
6 personal well-being and financial circumstances, including the purchase or
7 repair of a vehicle, home repair, paying down a debt obligation, dental care,
8 establishing an emergency fund, or investing in tools or training that support
9 employment or housing.

10 (5) “Expanded Individual Development Account” or “expanded
11 account” means a savings account that is held in an insured financial institution
12 that is maintained by the saver as part of an approved account program and an
13 approved savings plan.

14 (6) “Financial institution” means any insured federal- or State-chartered
15 bank, bank and trust company, savings bank, savings and loan association,
16 trust company, or credit union, approved by the service provider for the
17 establishment of an expanded account.

18 (7) “Fund” means the Vermont Matched Savings Account Program
19 Special Fund established by this section.

1 (8) “Minimum savings amount” means the minimum amount of the
2 saver’s earnings established in the approved savings plan that the saver must
3 deposit in order to be eligible for matching funds.

4 (9) “Program” means the Vermont Matched Savings Account Program
5 established by this section.

6 (10) “Public assistance” means financial assistance provided by the
7 Reach Up program or a separate State program established under the authority
8 of section 1121 of this title.

9 (11) “Saver” means an individual who is 18 years of age or older, or
10 who is under 18 years of age if the account is held in the name of a parent or
11 caretaker of the saver, or a family group:

12 (A) who resides in this State;

13 (B) who has applied for and been enrolled in the Program;

14 (C) whose household income at the time of application is within the
15 applicable financial eligibility standards:

16 (i) to receive public assistance;

17 (ii) to claim the federal earned income credit, without regard to
18 any age limitation; or

19 (iii) to participate in a federal savings program administered
20 pursuant to this section; and

1 (D) whose net worth as of the calendar year preceding the
2 determination of eligibility does not exceed \$10,000.00, excluding the primary
3 dwelling unit, one motor vehicle owned by members of the saver’s family in a
4 one-parent family or two motor vehicles owned by members of the saver’s
5 family in a two-parent family, and the tools of the saver’s trade that do not
6 exceed \$10,000.00 in value and that are necessary to continue or seek
7 employment.

8 (12) “Service provider” means a nonprofit organization approved by the
9 Agency that encourages and assists local community-based human service
10 development, and that is an organization described in Section 501(c)(3) of the
11 U.S. Internal Revenue Code which is exempt from taxation under Section
12 501(a) of the Code.

13 (b) The Agency shall establish by rule standards and procedures to
14 implement and administer the Program, consistent with the following:

15 (1) An applicant shall apply to a service provider for a determination of
16 eligibility for enrollment in the Program.

17 (2)(A) The service provider shall develop an approved savings plan with
18 each saver who has been determined eligible and enrolled in the Program.

19 (B) The approved savings plan shall specify a minimum savings
20 amount to be saved and the frequency of deposits to be made by the saver to
21 the savings account during the duration of the plan.

1 (C) The plan shall limit the maximum amount of savings that is the
2 basis for receipt of matching funds to not more than \$500.00 per saver per
3 calendar year and \$1,000.00 per family per calendar year, and to not more than
4 \$2,000.00 per lifetime of the saver and \$4,000.00 per lifetime of members of a
5 family.

6 (D) The application and plan shall be prepared on forms provided
7 and approved by the service provider.

8 (E) The plan shall be a contract between the saver and the service
9 provider.

10 (2) The enrolled saver shall complete a financial management training
11 program approved by the Agency and provided by or through the service
12 provider.

13 (3)(A) An enrolled saver shall open an account in a financial institution
14 that has been approved by the service provider as a depository for the saver's
15 contributions.

16 (B) The saver and the service provider shall jointly own the account,
17 including interest earned, jointly, with the saver as primary owner.

18 (4) An enrolled saver with an approved plan and account monitored by a
19 service provider shall comply with the requirements of the plan for at least one
20 year, but not more than five years, in order to be eligible for matching fund
21 grants.

1 (5)(A) In order to obtain matching funds, the saver shall present
2 evidence satisfactory to the service provider that the amount to be withdrawn
3 will be expended only for an eligible use.

4 (B) A withdrawal from an account for an eligible use shall be made
5 payable to the person who provides the eligible use.

6 (C) The Agency shall pay matching funds only to the person that
7 provides the eligible use and not directly to the saver.

8 (6)(A) The service provider may terminate an approved savings plan for
9 a saver who fails to meet the savings goals set out in the approved plan or who
10 withdraws from the Program, in accordance with standards and procedures
11 established by rule by the Agency.

12 (B) Any funds contributed by the saver shall revert to the sole
13 ownership of the saver, to be used by the saver for any purpose.

14 (7) The Agency shall monitor Program participation, and shall limit
15 additional Program participation when the funds appropriated to carry out the
16 purposes of this section are not sufficient to support additional approved
17 savings plans.

18 (8) The Agency shall establish by rule any other standards and
19 procedures necessary or desirable to implement the Program, including
20 minimum requirements for approval of savings plans, criteria for training and

1 counseling, reporting requirements for participating financial institutions, and
2 matching fund allocation standards.

3 (c)(1) The Vermont Matched Savings Account Program Special Fund is
4 established in the State Treasury and shall be administered by the Agency in
5 accordance with the provisions of 32 V.S.A. chapter 7, subchapter 5, except
6 that interest earned on the Fund shall be retained in the Fund.

7 (2) The Fund shall consist of the proceeds from grants, donations,
8 contributions, appropriations, and any other revenue authorized by law.

9 (3) The Agency shall use the Fund only for the purpose of providing
10 matching funds for the Program and to provide grants to service providers for
11 administrative expenses of administering the Program.

12 (d)(1) The Agency may make grants from the Fund to service providers to
13 provide the match for approved savings plans with enrolled savers.

14 (2) The Agency shall calculate the amount and number of grants
15 quarterly based on the number of savers and the amounts included in their
16 approved plans administered by each service provider to ensure that payment
17 of the maximum match is made for all savers for the period for the approved
18 savings plans without exceeding the balance in the Fund.

19 (3) The Agency may award grants from the Fund to service providers to
20 cover their expenses of training and counseling savers, and to implement and
21 administer the Program.

1 (4) The Agency may approve the use of interest earnings on grant funds
2 as a portion of approved administrative costs.

3 (e) The Agency and service providers, separately or cooperatively, may
4 solicit grants and private contributions for the Fund.

5 Sec. M.7. VOLUNTEER INCOME TAX ASSISTANCE PROGRAM;

6 APPROPRIATION

7 (a) Findings. The General Assembly finds:

8 (1) The Volunteer Income Tax Assistance Program offers free tax
9 preparation for anyone with an annual income of less than \$54,000.00.

10 (2) In fiscal year 2016, the Vermont Community Action Agencies
11 completed 3,536 federal returns and 3,544 State returns, and provided
12 assistance with the Vermont Renter's Rebate application and Homestead
13 Declaration.

14 (3) The Program has a 94 percent accuracy rate—higher than any other
15 tax preparation service.

16 (4) The total refunds and tax credits brought \$4.6 million back into the
17 State economy and helped stabilize households of Vermonters with low
18 income.

19 (b) Intent. It is the intent of the General Assembly to provide \$100,000.00
20 in State funding to the Volunteer Income Tax Assistance Program to leverage

1 \$51,540.00 in federal funding in order to sustain and expand access to the
2 Program for Vermonters with low income.

3 (c) Appropriations. In fiscal year 2018, in addition to any other amounts
4 appropriated, the amount of \$100,000.00 is appropriated from the General
5 Fund to the Agency of Human Services for pass through grants to the
6 Community Action Agencies to sustain and expand access to the Volunteer
7 Income Tax Assistance Program.

8 Sec. X.1. EFFECTIVE DATES

9 (a) This section, Sec. B.1 (rural economic development infrastructure
10 districts), and Secs. J.1–J.3 (tax increment financing districts) shall take effect
11 on passage.

12 (b) The remaining sections of this act shall take effect on July 1, 2017.
