7	Sec. 1. 3 V.S.A. chapter 5, subchapter 5 is added to read:
8	Subchapter 5: Vermont Accreditation Board
9	<u>§ 140 DEFINITIONS</u>
10	(a) For purpose of this subchapter:
11	(1) "Accreditation" means recognition by an independent organization
12	that a Certification Program has met predetermined standards.
13	(2) "Certification" means an official recognition by an organization
14	attesting that an individual has achieved a level of proficiency in a particular
15	field, using a combination of education, training, competency and examination
16	results.
17	<u>§ 141. VERMONT ACCREDITATION BOARD</u>
18	(a) The Vermont Accreditation Board is created within the Office of the
19	Secretary of State.
20	(b) The Board shall be composed of the following members:
21	(1) The Commissioner of Labor or designee;

1	(2) The Secretary of Education or designee;
2	(3) The Secretary of Commerce and Community Development or
3	designee;
4	(4) The Secretary of State or designee;
5	(5) The Superintendent of Career and Technical Education Centers; and
6	(6) Two at-large members appointed by the Governor.
7	(c) The purpose of the Board is to raise the standards and credibility of
8	certifications granted by Vermont Career and Technical Education Centers and
9	the Vermont State Colleges by ensuring that the programs issuing the
10	certifications meet standards of quality adopted by the Board.
11	(d)(1) The Board shall establish criteria to evaluate the ethical and
12	professional strength, viability, and relevance of new and existing
13	certifications, including:
14	(A) educational requirements;
15	(B) experience requirements;
16	(C) testing or examination requirements;
17	(D) annual education or maintenance requirements;
18	(E) accreditation by a credible, recognized third party.
19	(2) In the absence of an accrediting organization, the Board may
20	establish a process by which it will review a certification and issue its own
21	accreditation.

1	(e) The Board shall have the administrative and technical support of the
2	Office of Professional Regulation, which shall maintain the status of
3	certifications and accreditations.
4	(f) The Board shall not have jurisdiction of licensing review or review of
5	degree programs.
6	Sec. 2. 3. V.S.A. § 2703 is added to read:
7	§ 2703. SUPERINTENDENT OF CAREER AND TECHNICAL
8	EDUCATION CENTERS
9	(a)(1) The position of Superintendent of Vermont Career and Technical
10	Education Centers is created within the Agency of Education.
11	(2) The position shall be funded through the Next Generation Initiative
12	Fund created in 16 V.S.A. § 2887.
13	(b) The Superintendent shall report directly to the Secretary of Education
14	and his or her duties shall include:
15	(1) coordinating curriculum development across all Vermont Career and
16	Technical Education Centers; and
17	(2) collaborating with the Agency of Commerce and Community
18	Development, the Department of Labor, and the Agency of Education to
19	determine the needs of Vermont employers; and

1	(3) ensuring that career and technical education opportunities provide
2	Vermont employees with the education and skills necessary to match the needs
3	of Vermont employers.
4	Sec. 3. EFFECTIVE DATE
5	This act shall take effect on July 1, 2017.
