8	§ 5101. DEFINITIONS
9	As used in this chapter:
10	(1) "Agency" means the Agency of Agriculture, Food and Markets.
11	(2) "Invasive species" means any species of vegetation that:
12	(A) is designated as a noxious weed on the Agency's Noxious Weed
13	Rule under chapter 84 of this title;
14	(B) is listed on the Vermont Invasive Exotic Plant Committee Watch
15	<u>List;</u>
16	(C) has been quarantined by the Agency as invasive; or
17	(D) has been determined to be invasive by the Agency of Natural
18	Resources.
19	(3) "Native" refers to perennial vegetation that is native to Vermont.
20	Native perennial vegetation does not include invasive species.

1	(4) "Naturalized" refers to perennial vegetation that is not native to
2	Vermont, but is now considered to be well established and part of Vermont
3	flora. Naturalized perennial vegetation does not include invasive species.
4	(5) "Owner" means a public or private entity that has a controlling
5	interest in the solar site.
6	(6) "Perennial vegetation" means wildflowers, forbs, shrubs, sedges,
7	rushes, and grasses that serve as habitat, forage, and migratory way stations for
8	pollinators.
9	(7) "Pollinator" means bees, birds, bats, and other insects or wildlife that
10	pollinate flowering plants, and includes wild and managed insects.
11	(8) "Solar site" means a ground-mounted solar system for generating
12	electricity and the area surrounding that system under the control of the owner.
13	(9) "Vegetation management plan" means a written document that
14	includes short- and long-term site management practices that will provide and
15	maintain native and naturalized perennial vegetation.
16	§ 5102. BENEFICIAL HABITAT STANDARD
17	(a) This section establishes a standard for owners that intend to claim that,
18	through the voluntary planting and management of vegetation, a solar site
19	provides greater benefits to pollinators and shrub-dependent birds than are
20	provided by solar sites not so managed.

1	(b) In order for the solar site to meet the beneficial habitat standard and for
2	the owner of a solar site to claim that the solar site is beneficial to those species
3	or is pollinator-friendly, all the following shall apply:
4	(1) The owner adheres to guidance set forth by the Pollinator-Friendly
5	Scorecard (Scorecard) published by the University of Vermont (UVM)
6	Extension.
7	(2) The owner shall make the solar site's completed Scorecard available
8	to the public and provide a copy of the completed Scorecard to the UVM
9	Extension.
10	(3) If the site has a vegetation management plan:
11	(A) The plan shall maximize the use of native and naturalized
12	perennial vegetation for foraging habitat beneficial to pollinators consistent
13	with the solar site's Scorecard.
14	(B) The owner shall make the vegetation management plan available
15	to the public and provide a copy of the plan to the UVM Extension.
16	(4) When establishing perennial vegetation and beneficial foraging
17	habitat, the solar site shall use native and naturalized plant species and seed
18	mixes whenever practicable.
19	(c) Nothing in this chapter affects any findings that must be made in order
20	to issue a State permit or other approval for a solar site or the duty to comply
21	with any conditions in such a permit or approval.
