

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on General, Housing and Military Affairs to which was
3 referred House Bill No. 614 entitled “An act relating to the sale and use of
4 fireworks” respectfully reports that it has considered the same and
5 recommends that the bill be amended by striking out all after the enacting
6 clause and inserting in lieu thereof the following:

7 Sec. 1. 20 V.S.A. § 3132 is amended to read:

8 § 3132. PROHIBITIONS; PERMITS

9 (a) Except as provided in this section, it shall be unlawful for any person,
10 firm, co-partnership, or corporation to do any of the following:

11 (1) ~~Offer~~ offer for sale, expose for sale, sell at retail or wholesale, or
12 possess fireworks unless the person has been issued a permit by both the U.S.
13 Bureau of Alcohol, Tobacco, and Firearms and the municipality in which the
14 person offers for sale and stores the fireworks;

15 (2) ~~Use, possess,~~ use or explode any fireworks unless the person has
16 been issued a permit to display fireworks pursuant to subsection (c) of this
17 section;

18 (3) ~~Transport fireworks except in interstate commerce.~~ [Repealed.]

19 (4) ~~Offer~~ offer for sale or sell ~~hand-held~~ handheld sparklers as described
20 in subdivision 3131(1) of this title to a minor;

1 (5) ~~Offer~~ offer for sale or sell sparklers that are not in compliance with
2 ~~the United States~~ U.S. Consumer Product Safety Commission regulations; or

3 (6) ~~Purchase~~ purchase fireworks.

4 (b) The ~~state fire marshal~~ State Fire Marshal shall have power to adopt
5 reasonable rules ~~and regulations~~ for granting permits for supervised public
6 displays of fireworks by municipalities, fair associations, amusement parks,
7 and other organizations or groups of individuals.

8 (c) Any display for which a permit is issued shall be handled by a
9 competent operator to be approved by the chiefs of police and fire departments
10 of the municipality in which the display is to be held and shall be of a
11 character, and so located, discharged, or fired as, in the opinion of the chief of
12 the fire department, or in a municipality with no fire department, the
13 selectboard, after proper inspection, shall not be hazardous to property or
14 endanger any person or persons.

15 (d) Application for permits shall be made to the chief of the fire
16 department, or in municipalities with no fire department, the selectboard, in
17 writing, at least 15 days in advance of the date of the display. After the permit
18 has been granted, sales, ~~possessions~~, use, and distribution of fireworks for the
19 display shall be lawful for that purpose only. No permit granted under this
20 section shall be transferable.

1 (e) A person who sells fireworks at retail shall provide to the purchaser at
2 the time of sale information regarding:

3 (1) the requirement that a permit must be obtained for the use or
4 explosion of fireworks; and

5 (2) the purchaser's obligation to comply with any municipal ordinance
6 regulating use of fireworks.

7 (f)(1) No person shall explode fireworks after 10:00 p.m.

8 (2) A person who violates subdivision (1) of this subsection shall be
9 assessed a civil penalty of not more than \$200.00.

10 (3) Subdivision (1) of this subsection shall not apply:

11 (A) on the following dates: July 3, July 4, December 31, and
12 January 1;

13 (B) to uses permitted by section 3133 of this title; or

14 (C) if the use is permitted by a municipal ordinance.

16 § 1102. JUDICIAL BUREAU; JURISDICTION

18 (b) The Judicial Bureau shall have jurisdiction of the following matters:

20 (28) Violations of 20 V.S.A. § 3132(f), relating to the explosion of
21 fireworks after 10:00 p.m.
