Project Highlights, Council Work, Recent Accomplishments 2013-2017

Domestic Violence Accountability:

- Engaged in long-term planning with Department of Corrections as they reassessed domestic violence specific programming for offenders
- Conducted international review of DV Accountability Curricula
- Collaborated with the Network Against Domestic and Sexual Violence and Center for Court Innovation on study "Domestic Violence Accountability in VT"
- Became versed in national best practice related to Risk Assessment
- Revised and updated the Statewide Standards for DV Accountability Programs
- Provided ongoing technical assistance and support to Programs around the state
- Crafted and implemented plan to meet statutory requirement for DV Accountability Program Certification in absence of DVA Coordinator position

Domestic Violence Homicide Reduction:

- Council became versed in nationally recognized Lethality Assessment Program (LAP) and DV High Risk Team Models
- Participated in Rutland DV Homicide Reduction Demonstration Initiative

DV Fatality Review Commission:

Protection Orders:

- Conducted Statewide Audit of Protection Order Process
- Crafted formal recommendations to VT Judiciary based on Best Practice standards of National Council on Juvenile and Family Court Judges
- Coordinated initiative bringing national training to VT Court Staff
- Supported Development of Pilot Court Observation Project
