3 Subject: Health; health insurance; Department of Financial Regulation;

4 association health plans; short-term, limited-duration health insurance

5 Statement of purpose of bill as introduced: This bill proposes to regulate short-

6 term, limited-duration health insurance coverage, including limiting the

7 duration of the coverage to less than three months, prohibiting renewal, and

8 requiring prominent disclosures regarding the scope of the coverage. It would

9 also provide the Department of Financial Regulation with rulemaking authority

10 to regulate association health plans to the extent permitted under federal law.

11 An act relating to regulation of short-term, limited-duration health insurance
12 coverage and association health plans

13 It is hereby enacted by the General Assembly of the State of Vermont:

14 Sec. 1. 8 V.S.A. § 4062(h)(1) is amended to read:

15 (h)(1) The authority of the Board under this section shall apply only to the
16 rate review process for policies for major medical insurance coverage and shall
17 not apply to the policy forms for major medical insurance coverage or to the
18 rate and policy form review process for policies for specific disease, accident,
19 injury, hospital indemnity, dental care, vision care, disability income, long-
20 term care, student health insurance coverage, Medicare supplemental coverage,

1 short-term, limited-duration insurance, or other limited benefit coverage, or to
2 benefit plans that are paid directly to an individual insured or to his or her
3 assigns and for which the amount of the benefit is not based on potential
4 medical costs or actual costs incurred. Premium rates and rules for the
5 classification of risk for Medicare supplemental insurance policies shall be
6 governed by sections 4062b and 4080e of this title.

7 Sec. 2. 8 V.S.A. § 4079a is added to read:

8 § 4079a. ASSOCIATION HEALTH PLANS

9 (a) As used in this section, “association health plan” means a policy issued
10 to an association; to a trust; or to one or more trustees of a fund established,
11 created, or maintained for the benefit of the members of one or more
12 associations or a contract or plan issued by an association or trust or by a
13 multiple employer welfare arrangement as defined in the Employee Retirement
14 Income Security Act of 1974, 29 U.S.C. § 1001 et seq.

15 (b) In order to protect Vermont consumers and promote the stability of
16 Vermont’s health insurance markets, the Commissioner may adopt rules
17 pursuant to 3 V.S.A. chapter 25 regulating association health plans to the
18 extent permitted under federal law, including rules regarding licensure,
19 solvency and reserve requirements, and rating requirements.

1 Sec. 3. 8 V.S.A. § 4084a is added to read:

2 § 4084a. SHORT-TERM, LIMITED-DURATION HEALTH INSURANCE

3 (a) As used in this section, “short-term, limited-duration health insurance”
4 means health insurance **that provides medical, hospital, or major medical**
5 **expense benefits** coverage **provided** pursuant to a policy or contract with an
6 insurer and that has an expiration date specified in the policy or contract that is
7 less than three months after the original effective date of the policy or contract.

8 (b) An insurer shall not provide short-term, limited-duration health
9 insurance coverage unless the insurer has a certificate of authority from the
10 Commissioner to offer health insurance as defined in subdivision 3301(a)(2) of
11 this title or is licensed or registered with the Commissioner as a nonprofit
12 hospital or medical service corporation, health maintenance organization, or
13 managed care organization, unless the insurer is exempted by subdivision
14 3368(a)(4) of this title.

15 (c) A short-term, limited-duration health insurance policy or contract shall
16 be nonrenewable.

17 (d) A policy or contract for short-term, limited-duration health insurance
18 coverage shall display prominently in the policy or contract and in any
19 application materials provided in connection with enrollment in that coverage,
20 in at least 14-point type, **such certain** disclosures **as the Commissioner may**
21 **require** regarding the scope of short-term, limited-duration coverage,

1 including the types of benefits and consumer protections that are and are not
2 included. **The Commissioner shall determine the specific disclosure**
3 **language that shall be used in all short-term, limited-duration insurance**
4 **policies, contracts, and application materials and shall provide the**
5 **language to the insurers offering that coverage.**

6 (e) The Commissioner shall adopt rules pursuant to 3 V.S.A. chapter 25:

7 (1) establishing the minimum financial, marketing, service, and other
8 requirements for registration of an insurer to provide short-term, limited-
9 duration health insurance coverage to individuals in this State;

10 (2) requiring an insurer seeking to provide short-term, limited-duration
11 health insurance coverage to individuals in this State to file its rates, forms, and
12 advertising materials with the Commissioner for his or her approval; and

13 (3) establishing such other requirements as the Commissioner deems
14 necessary to protect Vermont consumers and promote the stability of
15 Vermont’s health insurance markets.

17 § 1802. DEFINITIONS

18 As used in this subchapter:

19 * * *

20 (3) “Health benefit plan” means a policy, contract, certificate, or
21 agreement offered or issued by a health insurer to provide, deliver, arrange for,

1 pay for, or reimburse any of the costs of health services. This term does not
2 include coverage only for accident or disability income insurance, liability
3 insurance, coverage issued as a supplement to liability insurance, workers’
4 compensation or similar insurance, automobile medical payment insurance,
5 credit-only insurance, coverage for on-site medical clinics, or other similar
6 insurance coverage where benefits for health services are secondary or
7 incidental to other insurance benefits as provided under the Affordable Care
8 Act. The term also does not include stand-alone dental or vision benefits;
9 long-term care insurance; short-term, limited-duration insurance; specific
10 disease or other limited benefit coverage, Medicare supplemental health
11 benefits, Medicare Advantage plans, and other similar benefits excluded under
12 the Affordable Care Act.

14 Sec. 5. 33 V.S.A. § 1811 is amended to read:

15 § 1811. HEALTH BENEFIT PLANS FOR INDIVIDUALS AND SMALL

16 EMPLOYERS

17 (a) As used in this section:

18 (1) “Health benefit plan” means a health insurance policy, a nonprofit
19 hospital or medical service corporation service contract, or a health
20 maintenance organization health benefit plan offered through the Vermont
21 Health Benefit Exchange or a reflective silver plan offered in accordance with

1 section 1813 of this title that is issued to an individual or to an employee of a
2 small employer. The term does not include coverage only for accident or
3 disability income insurance, liability insurance, coverage issued as a
4 supplement to liability insurance, workers' compensation or similar insurance,
5 automobile medical payment insurance, credit-only insurance, coverage for on-
6 site medical clinics, or other similar insurance coverage in which benefits for
7 health services are secondary or incidental to other insurance benefits as
8 provided under the Affordable Care Act. The term also does not include stand-
9 alone dental or vision benefits; long-term care insurance; short-term, limited-
10 duration insurance; specific disease or other limited benefit coverage,
11 Medicare supplemental health benefits, Medicare Advantage plans, and other
12 similar benefits excluded under the Affordable Care Act.
