5 Mountain Care Board; health information exchange

6 Statement of purpose of bill as introduced: This bill proposes to require the  
7 Department of Vermont Health Access and the Vermont Information  
8 Technology Leaders, Inc. (VITL) to submit to the General Assembly a work  
9 plan, a contingency plan, and bimonthly progress reports regarding their efforts  
10 to implement systemic improvements to health information technology and  
11 health information exchange in Vermont. It would also require them to  
12 provide testimony on their progress to the Health Reform Oversight  
13 Committee. It would shift responsibility for Vermont’s Health Information  
14 Technology Plan from the Agency of Administration to the Department of  
15 Vermont Health Access and require approval by the Green Mountain Care  
16 Board. The bill would extend a portion of the health care claims tax that is  
17 dedicated to health information technology through July 1, 2019. In the  
18 absence of contrary legislative action during the 2019 legislative session, it  
19 would also sunset VITL’s statutory authority on July 1, 2019, including  
20 VITL’s role as operator of the State’s health information exchange network  
21 and its eligibility to use funds from the Health IT-Fund.

1 An act relating to health information technology and health information  
2 exchange

3 It is hereby enacted by the General Assembly of the State of Vermont:

4 Sec. 1. HEALTH INFORMATION TECHNOLOGY; HEALTH  
5 INFORMATION EXCHANGE; PROGRESS REPORTS

6 (a) On or before May 1, 2018, the Department of Vermont Health Access  
7 and the Vermont Information Technology Leaders, Inc. (VITL) shall submit to  
8 the House Committees on Appropriations, on Health Care, and on Ways and  
9 Means; the Senate Committees on Appropriations, on Health and Welfare, and  
10 on Finance; and the Green Mountain Care Board a work plan detailing the  
11 process by which the Department and VITL shall implement the  
12 recommendations of the health information technology report submitted to the  
13 General Assembly in accordance with 2017 Acts and Resolves No. 73, Sec. 15  
14 (Act 73 report). The work plan shall be informed by stakeholder and consumer  
15 input and by technology options and opportunities, **and. The Plan** shall  
16 identify **proposed resolutions regarding potential steps for addressing**  
17 issues of data ownership and **issues of** intellectual property. It shall also set  
18 forth both a timeline of tasks to be completed and a list of clear objectives to  
19 assist the General Assembly in evaluating the success or failure of the parties'  
20 work.

21 (b) On or before September 1, 2018, the Department of Vermont Health  
22 Access and VITL shall submit to the House Committees on Appropriations, on

1 Health Care, and on Ways and Means; the Senate Committees on  
2 Appropriations, on Health and Welfare, and on Finance; the Health Reform  
3 Oversight Committee; and the Green Mountain Care Board a contingency plan  
4 for health information technology to be used if the Department and VITL are  
5 unable to implement the recommendations from the Act 73 report. The  
6 contingency plan shall contain the following:

7 (1) a description of the health information exchange services that would  
8 need to be replaced;

9 (2) a process for determining the manner in which the services would be  
10 replaced and the mechanism for acquiring the replacement services, such as a  
11 request for proposals;

12 (3) an assessment of the State’s ownership interests in hardware  
13 systems, software systems, applications, data, and other physical and  
14 intellectual property that would need to be licensed to a future operator of  
15 Vermont’s health information exchange;

16 (4) a plan for transitioning operations from VITL to the new operator or  
17 operators; and

18 (5) the impacts of the change on health care providers, health care  
19 consumers, State government, and Vermont’s health care reform initiatives.

20 (c) On or before October 15, 2018, the Department of Vermont Health  
21 Access shall submit to the House Committees on Appropriations, on Health

1 Care, and on Ways and Means; the Senate Committees on Appropriations, on  
2 Health and Welfare, and on Finance; the Health Reform Oversight Committee;  
3 and the Green Mountain Care Board the results of an evaluation, which shall  
4 be conducted by an independent entity with expertise in health information  
5 technology, of the work plan, the contingency plan, and the Department's and  
6 VITL's progress toward implementing the recommendations in the Act 73  
7 report.

8 (d) On or before May 1, July 1, September 1, and November 1, 2018 and  
9 January 1, 2019, the Department of Vermont Health Access and VITL shall  
10 provide to the House Committees on Appropriations, on Health Care, and on  
11 Ways and Means; the Senate Committees on Appropriations, on Health and  
12 Welfare, and on Finance; the Health Reform Oversight Committee; and the  
13 Green Mountain Care Board written updates on their progress toward  
14 implementing the recommendations contained in the Act 73 report.

15 (e) In addition to the written updates required by subsection (d) of this  
16 section, the Department of Vermont Health Access and VITL shall provide  
17 testimony on their progress toward implementing the recommendations  
18 contained in the Act 73 report at a meeting of the Health Reform Oversight  
19 Committee at least once every two months or more frequently if so requested  
20 by the Committee. The testimony at the Committee's first meeting after the  
21 General Assembly has adjourned in 2018 shall also include information

1 regarding the work plan required by subsection (a) of this section, and the  
2 testimony at the Committee’s first meeting after September 1, 2018 shall also  
3 include information regarding the contingency plan required by subsection (b)  
4 of this section.

6 § 9351. HEALTH INFORMATION TECHNOLOGY PLAN

7 (a)(1) ~~The Secretary of Administration or designee~~ Department of Vermont  
8 Health Access, in consultation with the Department’s Health Information  
9 Exchange Steering Committee, shall be responsible for the overall  
10 coordination of Vermont’s statewide Health Information Technology Plan.  
11 The Plan shall be revised annually and updated comprehensively every five  
12 years to provide a strategic vision for clinical health information technology.

13 (2) The Department shall submit the proposed Plan to the Green  
14 Mountain Care Board annually on or before November 1. The Green  
15 Mountain Care Board shall approve, **modify, or request modifications to** the  
16 Plan within 45 days following its submission; if the Board has taken no action  
17 **to approve, modify, or reject the Plan** after 45 days, the Plan shall be  
18 deemed to have been approved.

19 (3) ~~The Secretary or designee~~ Department, in consultation with the  
20 Steering Committee, shall administer the Plan, which shall include the  
21 implementation of an integrated electronic health information infrastructure for

1 the sharing of electronic health information among health care facilities, health  
2 care professionals, public and private payers, and patients. The Plan shall  
3 include standards and protocols designed to promote patient education, patient  
4 privacy, physician best practices, electronic connectivity to health care data,  
5 and, overall, a more efficient and less costly means of delivering quality health  
6 care in Vermont.

8 (c) ~~The Secretary of Administration or designee may update the Plan~~  
9 Department of Vermont Health Access, in consultation with the Steering  
10 Committee and subject to Green Mountain Care Board approval, may propose  
11 updates to the Plan in addition to the annual updates as needed to reflect  
12 emerging technologies, the State’s changing needs, and such other areas as the  
13 ~~Secretary or designee~~ Department deems appropriate. The ~~Secretary or~~  
14 ~~designee~~ Department shall solicit recommendations from ~~Vermont Information~~  
15 ~~Technology Leaders, Inc. (VITL) and other entities~~ interested stakeholders in  
16 order to ~~update~~ propose updates to the Health Information Technology Plan  
17 pursuant to subsection (a) of this section and to this subsection, including  
18 applicable standards, protocols, and pilot programs, and following approval of  
19 the proposed updates by the Green Mountain Care Board, may enter into a  
20 contract or grant agreement with ~~VITL or other~~ appropriate entities to update  
21 some or all of the Plan. Upon approval ~~by the Secretary~~ of the updated Plan by

1 the Green Mountain Care Board, the Department of Vermont Health Access  
2 shall distribute the updated Plan ~~shall be distributed~~ to the Secretary of  
3 Administration; the Commissioner of Information and Innovation; the

16 (c)(1) Health information exchange operation. VITL shall be designated in  
17 the Health Information Technology Plan approved by the Green Mountain  
18 Care Board pursuant to section 9351 of this title to operate the exclusive  
19 statewide health information exchange network for this State. The Plan shall  
20 determine the manner in which Vermont's health information exchange  
21 network shall be managed. ~~After the~~ The Green Mountain Care Board

1 ~~approves~~ shall have the authority to approve VITL's ~~core activities and~~ budget  
2 pursuant to chapter 220 of this title, ~~the Secretary of Administration or~~  
3 ~~designee shall enter into procurement grant agreements with VITL pursuant to~~  
4 ~~8 V.S.A. § 4089k.~~ Nothing in this chapter shall impede local community  
5 providers from the exchange of electronic medical data.

6 (2) Notwithstanding any provision of 3 V.S.A. § 2222 or 2283b to the  
7 contrary, upon request of the Secretary of Administration, the Department of  
8 Information and Innovation shall review VITL's technology for security,  
9 privacy, and interoperability with State government information technology,  
10 consistent with the State's health information technology plan required by  
11 section 9351 of this title.

12 (d) Privacy. The standards and protocols implemented by VITL shall be  
13 consistent with those adopted by the statewide Health Information Technology  
14 Plan pursuant to subsection 9351(e) of this title.

15 (e) Report. ~~No later than~~ On or before January 15 of each year, VITL shall  
16 file a report with the Green Mountain Care Board; the Secretary of  
17 Administration; the Commissioner of Information and Innovation; the  
18 Commissioner of Financial Regulation; the Commissioner of Vermont Health  
19 Access; the Secretary of Human Services; the Commissioner of Health; the  
20 Commissioner of Mental Health; the Commissioner of Disabilities, Aging, and  
21 Independent Living; the Senate Committee on Health and Welfare; and the



1 House Committee on Health Care. The report shall include an assessment of  
2 progress in implementing health information technology in Vermont and  
3 recommendations for additional funding and legislation required. In addition,  
4 VITL shall publish minutes of VITL meetings and any other relevant  
5 information on a public website. The provisions of 2 V.S.A. § 20(d)  
6 (expiration of required reports) shall not apply to the report to be made under  
7 this subsection.

8 (f) Funding authorization. VITL is authorized to seek matching funds to  
9 assist with carrying out the purposes of this section. In addition, it may accept  
10 any and all donations, gifts, and grants of money, equipment, supplies,  
11 materials, and services from the federal or any local government, or any  
12 agency thereof, and from any person, firm, foundation, or corporation for any  
13 of its purposes and functions under this section and may receive and use the  
14 same, subject to the terms, conditions, and regulations governing such  
15 donations, gifts, and grants. VITL shall not use any State funds for health care  
16 consumer advertising, marketing, or similar services unless necessary to  
17 comply with the terms of a contract or grant that requires a contribution of  
18 State funds.

19 (g) Waivers. The Secretary of ~~Administration~~ Human Services or  
20 designee, in consultation with VITL, may seek any waivers of federal law, of  
21 rule, or of regulation that might assist with implementation of this section.

1 (h) [Repealed.]

2 (i) Certification of meaningful use and connectivity.

3 (1) To the extent necessary to support Vermont’s health care reform  
4 goals or as required by federal law, VITL shall be authorized to certify the  
5 meaningful use of health information technology and electronic health records  
6 by health care providers licensed in Vermont.

7 (2) VITL, in consultation with health care providers and health care  
8 facilities, shall establish criteria for creating or maintaining connectivity to the  
9 State’s health information exchange network. VITL shall provide the criteria  
10 annually ~~by~~ on or before March 1 to the Green Mountain Care Board  
11 established pursuant to chapter 220 of this title.

12 (j) Scope of activities. VITL and any person who serves as a member,  
13 director, officer, or employee of VITL with or without compensation shall not  
14 be considered a health care provider as defined in subdivision 9432 of this title  
15 for purposes of any action taken in good faith pursuant to or in reliance upon  
16 provisions of this section relating to VITL’s:

17 (1) governance;

18 (2) electronic exchange of health information and operation of the  
19 statewide Health Information Exchange Network as long as nothing in such  
20 exchange or operation constitutes the practice of medicine pursuant to  
21 26 V.S.A. chapter 23 or 33;

- 1 (3) implementation of privacy provisions;
- 2 (4) funding authority;
- 3 (5) application for waivers of federal law;
- 4 (6) establishment and operation of a financing program providing
- 5 electronic health records systems to providers; or
- 6 (7) certification of health care providers' meaningful use of health

18 In order to ensure successful implementation of the Act 73 report  
19 recommendations as set forth in the work plan developed pursuant to Sec. 1 of  
20 this act, and in the absence of 2019 legislative action to the contrary, 18 V.S.A.  
21 § 9352 is repealed on July 1, 2019.

2 § 10301. HEALTH IT-FUND

3 (a) The Vermont Health IT-Fund is established in the State Treasury as a  
4 special fund to be a source of funding for Medical Health Care Information  
5 Technology Programs and initiatives such as those outlined in the Vermont  
6 Health Information Technology Plan administered by the ~~Secretary of~~  
7 ~~Administration or designee~~ Department of Vermont Health Access. One  
8 hundred percent of the Fund shall be disbursed for the advancement of health  
9 information technology adoption and utilization in Vermont as appropriated by  
10 the General Assembly, less any disbursements relating to the administration of  
11 the Fund. The Fund shall be used for loans and grants to health care providers  
12 pursuant to section 10302 of this chapter and for the development of programs  
13 and initiatives sponsored by ~~VITL~~ and State entities designed to promote and  
14 improve health care information technology, including:

15 (1) a program to provide electronic health information systems and  
16 practice management systems for health care and human service practitioners  
17 in Vermont;

18 (2) financial support ~~for VITL~~ to build and operate the health

1 be using the system to less than its full capacity shall be provided with an
