

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Human Services to which was referred Senate Bill No.
3 95 entitled “An act relating to sexual assault nurse examiners” respectfully
4 reports that it has considered the same and recommends that the House propose
5 to the Senate that the bill be amended by striking out all after the enacting
6 clause and inserting in lieu thereof the following:

7 Sec. 1. 13 V.S.A. chapter 167, subchapter 5 is amended to read:

8 Subchapter 5. Sexual Assault Nurse Examiners

9 § 5431. DEFINITION; CERTIFICATION

10 (a) As used in this subchapter, “SANE” means a sexual assault nurse
11 examiner.

12 (b) A person licensed under 26 V.S.A. chapter 28 (nursing) may obtain a
13 specialized certification from the SANE Program as a sexual assault nurse
14 examiner if he or she demonstrates compliance with the requirements for
15 specialized certification as established by the SANE Board.

16 § 5432. SANE BOARD

17 (a) The SANE Board is created for the purpose of ~~regulating sexual assault~~
18 ~~nurse examiners~~ advising the Sexual Assault Nurse Examiners Program.

19 (b) The SANE Board shall be composed of the following members:

20 (1) the Executive Director of the Vermont State Nurses Association or
21 designee;

- 1 (2) the President of the Vermont Association of Hospitals and Health
2 Systems;
- 3 (3) the Director of the Vermont Forensic Laboratory or designee;
- 4 (4) the Director of the Vermont Network Against Domestic and Sexual
5 Violence or designee;
- 6 (5) an attorney with experience prosecuting sexual assault crimes,
7 appointed by the Attorney General;
- 8 (6) the Executive Director of the Vermont Center for Crime Victim
9 Services or designee;
- 10 (7) a law enforcement officer assigned to one of Vermont’s special units
11 of investigation, appointed by the Commissioner of Public Safety;
- 12 (8) a law enforcement officer employed by a municipal police
13 department, appointed by the Executive Director of the Vermont Criminal
14 Justice Training Council;
- 15 (9) three sexual assault nurse examiners, appointed by the Attorney
16 General;
- 17 (10) a ~~physician~~ health care provider as defined in 18 V.S.A. § 9402
18 whose practice includes the care of victims of sexual assault, appointed by the
19 ~~Vermont Medical Society~~ Commissioner of Health;

1 (11) a pediatrician whose practice includes the care of victims of sexual
2 assault, appointed by the Vermont Chapter of the American Academy of
3 Pediatrics;

4 (12) the Coordinator of the Vermont Victim Assistance Program or
5 designee;

6 (13) the President of the Vermont Alliance of Child Advocacy Centers
7 or designee;

8 (14) the Chair of the Vermont State Board of Nursing or designee; ~~and~~

9 (15) the Commissioner for Children and Families or designee; and

10 (16) the Commissioner of Health or designee.

11 (c) The SANE Board shall advise the SANE Program on the following:

12 (1) statewide program priorities;

13 (2) training and educational requirements;

14 (3) a standardized sexual assault protocol and kit to be used by all
15 physicians and hospitals in this State when providing forensic examinations of
16 victims of alleged sexual offenses; and

17 (4) statewide policy development related to sexual assault nurse
18 examiner programs.

19 § 5433. SANE PROGRAM CLINICAL COORDINATOR

20 ~~A grant program shall be established by~~ A clinical coordinator position shall
21 be funded by either the Vermont Center for Crime Victim Services, subject to

1 ~~available funding, to fund a clinical coordinator position~~ or through other
2 identified State funding options for the purpose of staffing the SANE ~~program~~
3 Program. The position shall be contracted through the Vermont Network
4 Against Domestic and Sexual Violence. The Clinical Coordinator shall consult
5 with the SANE Board in performing the following duties:

6 (1) overseeing the recruitment and retention of SANEs in the State of
7 Vermont;

8 (2) administering a statewide ~~training~~ educational program, including:

9 (A) the initial SANE certification training;

10 (B) ongoing training to ensure currency of practice for SANEs; and

11 (C) advanced training programs as needed;

12 (3) providing consultation ~~and~~, technical assistance, and training to
13 SANEs and acute care hospitals regarding the ~~standardized sexual assault~~
14 ~~protocol~~ standards of care for sexual assault patients; and

15 (4) providing training and outreach to criminal justice and community-
16 based agencies as needed; and

17 (5) coordinating and managing a system for ensuring best practices;

18 (6) granting certifications, pursuant to section 5431 of this title, to
19 candidates who demonstrate compliance with the requirements for specialized
20 certification as established by the SANE Board.

1 § 5434. ~~SANE BOARD DUTIES~~

2 ~~(a) A person licensed under 26 V.S.A. chapter 28 (nursing) may obtain a~~
3 ~~specialized certification as a sexual assault nurse examiner if he or she~~
4 ~~demonstrates compliance with the requirements for specialized certification as~~
5 ~~established by the SANE Board by rule.~~

6 ~~(b) The SANE Board shall adopt the following by rule:~~

7 ~~(1) educational requirements for obtaining specialized certification as a~~
8 ~~sexual assault nurse examiner and statewide standards for the provision of~~
9 ~~education;~~

10 ~~(2) continuing education requirements and clinical experience necessary~~
11 ~~for maintenance of the SANE specialized certification;~~

12 ~~(3) a standardized sexual assault protocol and kit to be used by all~~
13 ~~physicians and hospitals in this State when providing forensic examinations of~~
14 ~~victims of alleged sexual offenses;~~

15 ~~(4) a system of monitoring for compliance; and~~

16 ~~(5) processes for investigating complaints, revoking certification, and~~
17 ~~appealing decisions of the Board.~~

18 ~~(c) The SANE Board may investigate complaints against a sexual assault~~
19 ~~nurse examiner and may revoke certification as appropriate. [Repealed.]~~

1 § 5435. ACCESS TO A SEXUAL ASSAULT NURSE EXAMINER

2 (a) On or before September 1, 2017, the Vermont Association of Hospitals
3 and Health Systems (VAHHS) and the Vermont SANE Program shall enter
4 into a memorandum of understanding (MOU) to ensure improved access to
5 sexual assault nurse examiners (SANE) for victims of sexual assault in
6 underserved regions. Improved access may include all acute care hospitals to
7 provide patients with care from a paid employee who is also a certified sexual
8 assault nurse examiner or access to a shared regional staffing pool that includes
9 certified sexual assault nurse examiners.

10 (b) The Vermont SANE Program shall develop and offer an annual training
11 regarding standards of care and forensic evidence collection to emergency
12 department appropriate health care providers at acute care hospitals in
13 Vermont. Personnel who are certified sexual assault nurse examiners shall not
14 be subject to this subsection.

15 (c) On or before January 1, 2018, the SANE Program shall report to the
16 General Assembly on training participation rates pursuant to subsection (b) of
17 this section.

18 Sec. 2. SEXUAL ASSAULT EVIDENCE KITS; STUDY COMMITTEE

19 (a) Creation. There is created the Sexual Assault Evidence Kit Study
20 Committee for the purpose of conducting a comprehensive examination of
21 issues related to sexual assault evidence kits.

1 (b) Membership. The Committee shall be composed of the following six
2 members:

3 (1) the Director of the Vermont Forensic Laboratory or designee;

4 (2) the Executive Director of the Vermont Center for Crime Victims
5 Services or designee;

6 (3) the Commissioner of Health or designee;

7 (4) a representative of the Vermont Sexual Assault Nurse Examiners
8 (SANE) Program;

9 (5) a representative of the county special investigative units appointed
10 by the Executive Director of the State’s Attorneys and Sheriffs; and

11 (6) a law enforcement professional appointed by the Commissioner of
12 Public Safety.

13 (c) Powers and duties. The Committee shall address the following issues:

14 (1) the current practices for kit tracking;

15 (2) the effectiveness and cost of a system allowing for the online
16 completion of sexual assault evidence kit documentation with electronic
17 notification after reports are submitted;

18 (3) the feasibility and cost of a web-based tracking system to allow
19 agencies involved in the response and prosecution of sexual assault to track
20 sexual assault evidence kits, pediatric sexual assault evidence kits, and
21 toxicology kits using a bar code number uniquely assigned to each kit;

1 (4) the effectiveness and challenges of the current system of police
2 transport of evidence kits from hospitals to the Vermont Forensic
3 Laboratory; and

4 (5) the feasibility and cost of alternative methods of transport of sexual
5 assault evidence kits such as mail, delivery service, or courier.

6 (d) Assistance. The Center for Crime Victim Services shall convene the
7 first meeting of the Committee and provide support services.

8 (e) Report. On or before November 1, 2017, the SANE Program, on behalf
9 of the Committee, shall submit a written report to the House and Senate
10 Committees on Judiciary, the House Committee on Human Services, and the
11 Senate Committee on Health and Welfare.

12 (f) Meetings.

13 (1) The Center for Crime Victim Services shall call the first meeting of
14 the Committee to occur on or before August 1, 2017.

15 (2) The Committee shall select a chair from among its members at the
16 first meeting.

17 (3) A majority of the membership shall constitute a quorum.

18 (4) The Committee shall cease to exist on January 15, 2018.

19 Sec. 3. EFFECTIVE DATE

20 This act shall take effect on July 1, 2017.
