- 12 grounds or lands owned or leased for the use of such institution, without the
- 13 approval of the warden or superintendent of the institution, to injure another
- shall be imprisoned not more than two years or fined not more than \$200.00
- 15 \$2,000.00, or both. It shall be a felony punishable by not more than 10 years
- or a fine of \$25,000.00, or both, if the person intends to injure multiple
- persons.
