- Over 50% of the detainees on February 4, 2018 were held without bail.
- 7 People were held pending Release to a Responsible Adult (RTRA). Of those, 6 had additional bail amounts ranging from \$250 – \$100,000
- 1 person was held pending an approved residence by the court and \$500 bail

- Lengths of stay are similar for the groups with cash/bond only and the HWOB group
- 31-90 days is the highest percentage LOS at 26% for both groups
- 7% of the cash only group stays over a year.
- 11% of the HWOB group stays are over a year

 - of those 12% (26) have been detained over a year
- 94% (336) of detainees are charged with a felony
 - of those, 10% have been detained over a year
- 6% (23) are charged with a misdemeanor
 - of those, 0% have been detained over a year

- 80% (286) of the detainee population is white, 13% (46) is black. (The breakdown of the entire incarcerated population is 84% white, 11% black)
- 12% (23) of the HWOB group is black
- 50% of black detainees are HWOB
- 57% (165) of white detainees are HWOB

- The highest percentage (16%) of detainees are from Rutland County
 - Of those, 16% (9) are charged with Aggravated Domestic Assault; 9% (5) are charged with a sexual assault
- 10% of detainees have an out of state address
 - Of those, 16% (6) are charged with Aggravated Domestic Assault; 11% (4) are charged with Burglary of an Occupied Dwelling; 11% (4) are charged with a drug crime.

Chart 1: Age Trends for the Incarcerated Population (All Statuses)

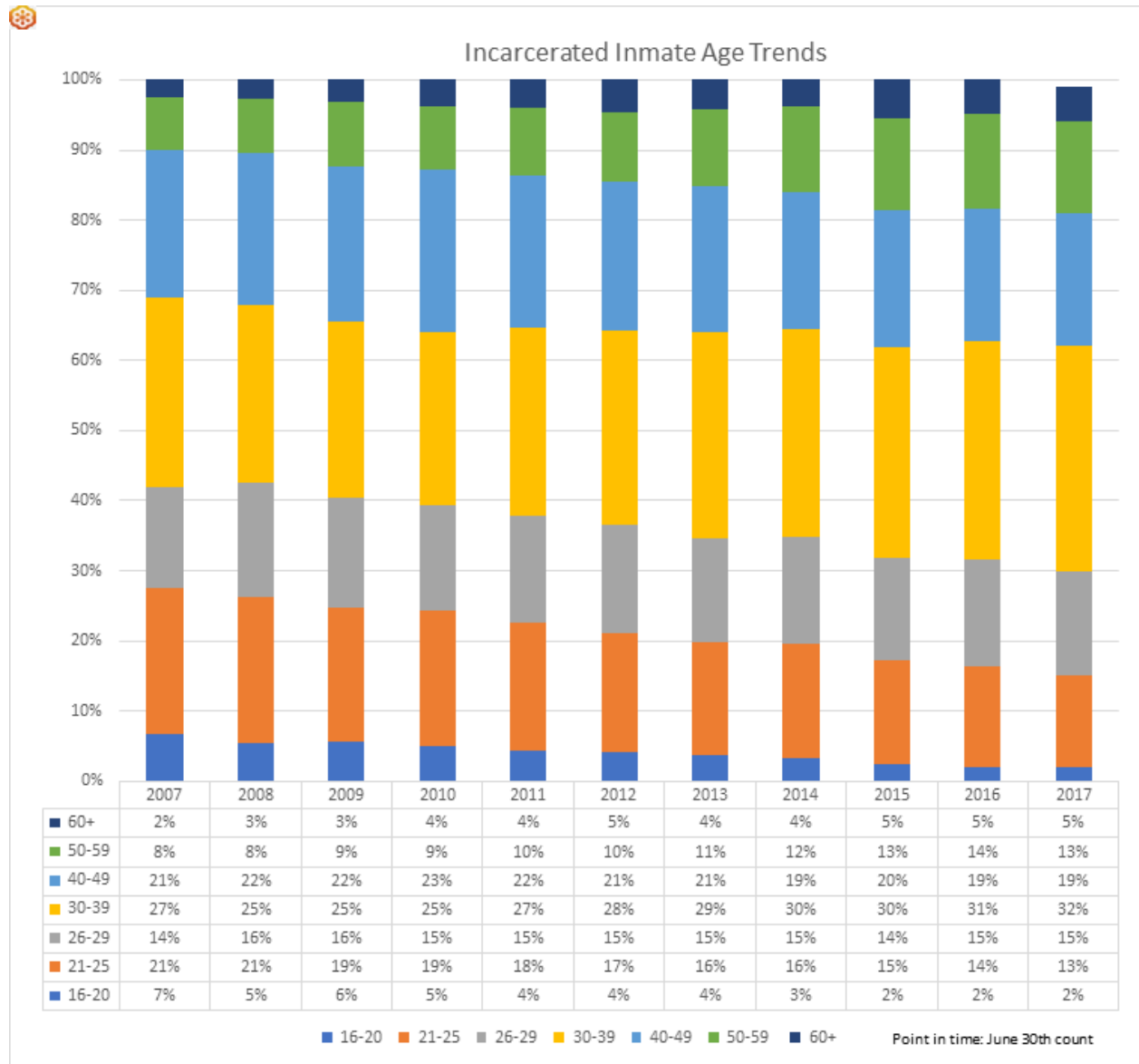


Chart 1 Analysis
