

VERMONT STATE AND FEDERAL COURTS



VERMONT SUPERIOR COURT

EXAMPLES OF CASES IN VARIOUS DIVISIONS

Civil Division

- Evictions and Landlord/Tenant
- Mortgage Foreclosures
- Debt Collection
- Contract Disputes
- Stalking Orders
- Personal Injury Cases

Family Division

- Divorce (including custody and child support)
- Parentage/Paternity
- Abuse Protection
- Abuse & Neglect
- Juvenile Delinquency

Probate Division

- Administering Estates of People Who Die With or Without a Will
- Guardianship of Minors
- Guardianship of Adults (voluntary and involuntary)
- Name Changes
- Gender Marker Changes

Criminal Division

- Driving Under the Influence
- Disorderly Conduct
- Drug Charges
- Felony and Misdemeanor Charges

Environmental Division

- Appeals from Municipal Zoning Decisions
- Appeals from Act 250 Rulings by District Environmental Commissions
- Enforcement of Certain Municipal Ordinances and Environmental Regulations

VERMONT SMALL CLAIMS COURT

- Claims for money (damages) up to \$5,000
- Only includes claims for money.
- Intended to be more "user-friendly"
- Appeals to the Superior Court, civil division

VERMONT JUDICIAL BUREAU

- Traffic violations (tickets)
- Municipal ordinance violations
- Fish and wildlife violations
- Lead hazard abatement violations
- Non-criminal marijuana violations
- Burning and waste disposal violations

EXAMPLES OF STATE AGENCY MATTERS DECIDED FIRST IN EXECUTIVE BRANCH BEFORE COURT APPEAL

- Department of Labor: unemployment, workers' compensation, wage and hour disputes
- Department of Children and Families: benefits like 3SquaresVT, fuel assistance, Reach Up
- Department of Vermont Health Access: Medicaid
- Public Service Board: renewable energy siting
- Department of Taxes State Appraiser (certain property valuation appeals)

EXAMPLES OF MATTERS DECIDED FIRST BY MUNICIPAL BODIES BEFORE COURT APPEAL

- Board of Civil Authority: property appraisal for tax purposes
- Development Review Board: zoning determinations
- District Environmental Commission: Act 250 permits
