17	is excused in writing by the superintendent or a majority of the school
18	directors. In case of such enrollment, the person, and the teacher, child,
19	superintendent, and school directors shall be under the laws and subject to the
20	penalties relating to the <u>school</u> attendance of children between the ages of six

6	who lawfully stopped attending school prior to that date.
