16	§ 2453. PRACTICES PROHIBITED; ANTITRUST AND CONSUMER
17	PROTECTION
18	(a) Unfair methods of competition in commerce and unfair or deceptive
19	acts or practices in commerce are hereby declared unlawful.

1	(b) It is the intent of the Legislature Vermont General Assembly that in
2	construing subsection (a) of this section, the courts of this State will be guided
3	by the construction of similar terms contained in Section $5(a)(1)$ of the Federal
4	Trade Commission Act as from time to time amended by the Federal Trade
5	Commission and the courts of the United States.
6	(c) The Attorney General shall make rules and regulations, when necessary
7	and proper to carry out the purposes of this chapter, relating to unfair methods
8	of competition in commerce and unfair or deceptive acts or practices in
9	commerce. The rules and regulations shall not be inconsistent with the rules,
10	regulations, and decisions of the Federal Trade Commission and the federal
11	courts interpreting the Federal Trade Commission Act.
12	(d) Violation of a rule or regulation as made by the Attorney General is
13	prima facie proof of the commission of an unfair or deceptive act in commerce.
14	(e) The provisions of subsections (a), (c), and (d) of this section shall also
15	be applicable to real estate transactions.
16	(f) The Attorney General, in consultation with the Commissioner of Public
17	Service, shall adopt privacy and data security rules applicable to
18	telecommunications service providers subject to the jurisdiction of the Public
19	Service Board under 30 V.S.A. § 203(5), including broadband Internet access
20	service providers. The rules shall be modeled after, and not more or less

1	restrictive than, the Federal Communications Commission's 2016 Privacy
2	Order, 47 C.F.R. part 64, subpart U. As such, the rules shall include:
3	(1) disclosure requirements pertaining to a provider's privacy policies;
4	(2) opt-in or opt-out procedures for obtaining customer approval to use
5	and share sensitive or nonsensitive customer proprietary information,
6	respectively; and
7	(3) data security and data breach notification requirements.
