

1 TO THE HONORABLE SENATE:

2 The Committee on Finance to which was referred Senate Bill No. 52
3 entitled “An act relating to the Public Service Board and its proceedings”
4 respectfully reports that it has considered the same and recommends that the
5 bill be amended by striking out all after the enacting clause and inserting in
6 lieu thereof the following:

7 * * * Preapplication Submittals; Energy Facilities * * *

8 Sec. 1. 30 V.S.A. § 248(f) is amended to read:

9 (f) However, plans for the construction of such a facility within the State
10 must be submitted by the petitioner to the municipal and regional planning
11 commissions no less than 45 days prior to application for a certificate of public
12 good under this section, unless the municipal and regional planning
13 commissions shall waive such requirement.

14 (1) ~~Such~~ The municipal or regional planning commission may take one
15 or more of the following actions:

16 (A) ~~hold~~ Hold a public hearing on the proposed plans. The planning
17 commission may request that the petitioner or the Department of Public
18 Service, or both, attend the hearing. The petitioner and the Department each
19 shall have an obligation to comply with such a request. The Department shall
20 consider the comments made and information obtained at the hearing in
21 making recommendations to the Board on the application and in determining

1 whether to retain additional personnel under subdivision (1)(B) of this
2 subsection.

3 (B) Request that the Department of Public Service exercise its
4 authority under section 20 of this title to retain experts and other personnel to
5 review the proposed facility. The Department may commence retention of
6 these personnel once the petitioner has submitted proposed plans under this
7 subsection. The Department may allocate the expenses incurred in retaining
8 these personnel to the petitioner in accordance with section 21 of this title.
9 Granting a request by a planning commission pursuant to this subdivision shall
10 not oblige the Department or the personnel it retains to agree with the position
11 of the commission.

12 (C) ~~Such commissions shall make~~ Make recommendations, if any, to
13 ~~the Public Service Board and to the petitioner at least seven days~~ prior to filing
14 of the petition with the Public Service Board.

15 (D) Once the petition is filed with the Public Service Board, make
16 recommendations to the Board by the deadline for submitting comments or
17 testimony set forth in the applicable provision of this section, Board rule, or
18 scheduling order issued by the Board.

19 (2) The petitioner's application shall address the substantive written
20 comments related to the criteria of subsection (b) of this section received by
21 the petitioner within 45 days of the submittal made under this subsection and

1 the substantive oral comments related to those criteria made at a public hearing
2 under subdivision (1) of this subsection.

5 Sec. 2. 30 V.S.A. § 246 is amended to read:

6 § 246. TEMPORARY SITING OF METEOROLOGICAL STATIONS

7 (a) As used in this section, a “meteorological station” consists of one
8 temporary tower, which may include guy wires, and attached instrumentation
9 to collect and record wind speed, wind direction, and atmospheric conditions.

10 (b) The Public Service Board shall establish by rule or order standards and
11 procedures governing application for, and issuance or revocation of, a
12 certificate of public good for the temporary installation of one or more
13 meteorological stations under the provisions of section 248 of this title. A
14 meteorological station shall be deemed to promote the public good of the State
15 if it is in compliance with the criteria of this section and the Board rules or
16 orders. An applicant for a certificate of public good for a meteorological
17 station shall be exempt from the requirements of subsection 202(f) of this title.

18 (c) In developing rules or orders, the Board:

19 (1) Shall develop a simple application form and shall require that
20 ~~completed applications be filed~~ the applicant first file the application with the
21 Board, and that, within two business days of notification from the Board that
22 the application is complete, the applicant serve copies of the complete

1 application on the Department of Public Service, the Agency of Natural
2 Resources, the Agency of Transportation, and the municipality in which the
3 meteorological station is proposed to be located.

4 (2) Shall require that if no objections are filed within 30 days of the
5 Board's receipt of a complete application date of service of the complete
6 application under subdivision (1) of this subsection, and the Board determines
7 that the applicant has met all of the requirements of section 248 of this title, the
8 certificate of public good shall be issued for a period that the Board finds
9 reasonable, but in no event for more than five years. Upon request of an
10 applicant, the Board may renew a certificate of public good. Upon expiration
11 of the certificate, the meteorological station and all associated structures and
12 material shall be removed, and the site shall be restored substantially to its
13 preconstruction condition.

14 (3) May waive the requirements of section 248 of this title that are not
15 applicable to meteorological stations, including criteria that are generally
16 applicable to public service companies as defined in this title. The Board shall
17 not waive review regarding whether construction will have an undue adverse
18 effect on aesthetics, historic sites, air and water purity, the natural
19 environment, and the public health and safety.

20 (4) Shall seek to simplify the application and review process, as
21 appropriate, in conformance with this section.

1 Sec. 3. 30 V.S.A. § 248(a)(4) is amended to read:

2 (4)(A) With respect to a facility located in the State, the Public Service
3 Board shall hold a nontechnical public hearing on each petition for such
4 finding and certificate in at least one county in which any portion of the
5 construction of the facility is proposed to be located.

6 (B) The Public Service Board shall hold technical hearings at
7 locations which it selects.

8 (C) ~~At the time of filing its application with the Board, copies shall~~
9 ~~be given by the petitioner to~~ Within two business days of notification from the
10 Board that the petition is complete, the petitioner shall serve copies of the
11 complete petition on the Attorney General and the Department of Public
12 Service, and, with respect to facilities within the State, the Department of
13 Health, Agency of Natural Resources, Historic Preservation Division, Agency
14 of Transportation, Agency of Agriculture, Food and Markets, and to the chair
15 or director of the municipal and regional planning commissions and the
16 municipal legislative body for each town and city in which the proposed

18 (D) Notice of the public hearing shall be published and maintained
19 on the Board's website for at least 12 days before the day appointed for the

1 will be located, and the notice shall include an Internet address where more
2 information regarding the proposed facility may be viewed.

5 (2) Any party seeking to proceed under the procedures authorized by
6 this subsection shall file a proposed certificate of public good and proposed
7 findings of fact with its petition. The Within two business days of notification
8 by the Board that the filing is complete, the party shall serve copies of the
9 complete filing on the parties specified in subdivision (a)(4)(C) of this section
10 and the Board shall give written notice of the proposed certificate and its
11 determination that the filing is complete to the those parties specified in
12 subdivision (a)(4)(C) of this section, to any public interest organization that
13 has in writing requested notice of applications to proceed under this
14 subsection, and to any other person found by the Board to have a substantial
15 interest in the matter. Such notice also shall be published on the Board's

12 § 231. CERTIFICATE OF PUBLIC GOOD; ABANDONMENT OF
13 SERVICE; HEARING

14 (a) A person, partnership, unincorporated association, or previously
15 incorporated association, ~~which~~ that desires to own or operate a business over
16 which the Public Service Board has jurisdiction under the provisions of this
17 chapter shall first petition the Board to determine whether the operation of
18 such business will promote the general good of the State, and shall at that time
19 file a copy of any such petition with the Department. The Department, within
20 12 days, shall review the petition and file a recommendation regarding the
21 petition in the same manner as is set forth in subsection 225(b) of this title.

22 Such recommendation shall set forth reasons why the petition shall be accepted

1 without hearing or shall request that a hearing on the petition be scheduled. If
2 the Department requests a hearing on the petition, or, if the Board deems a
3 hearing necessary, it shall appoint a time and place in the county where the
4 proposed corporation is to have its principal office for hearing the petition, ~~and~~
5 ~~shall make an order for the publication of the substance thereof and the time~~

11 in which the hearing will occur. The website notice shall be maintained
12 through the date of the hearing. The newspaper notice shall include an Internet
13 address where more information regarding the petition may be viewed. The
14 Director for Public Advocacy shall represent the public at ~~such~~ the hearing. If
15 the Board finds that the operation of such business will promote the general
16 good of the State, it shall give such person, partnership, unincorporated
17 association, or previously incorporated association a certificate of public good
18 specifying the business and territory to be served by such petitioners. For good
19 cause, after opportunity for hearing, the Board may amend or revoke any
20 certificate awarded under the provisions of this section. If any such certificate
21 is revoked, the person, partnership, unincorporated association, or previously
22 incorporated association shall no longer have authority to conduct any business

1 which is subject to the jurisdiction of the Board whether or not regulation
2 thereunder has been reduced or suspended, under section 226a or 227a of this
3 title.

9 (h) The Department shall investigate when it receives a complaint that there
10 has been noncompliance with section 246, 248, 248a, or 8010 of this title, any
11 rule adopted pursuant to those sections, or any certificate of public good issued
12 pursuant to those sections, including a complaint of such noncompliance
13 received pursuant to section 208 of this title or the complaint protocol
14 established under 2016 Acts and Resolves No. 30, Sec. 5c.

15 Sec. 8. 30 V.S.A. § 30 is amended to read:

16 § 30. PENALTIES; AFFIDAVIT OF COMPLIANCE

17 * * *

18 (h) In accordance with the process set forth in this subsection, the
19 Department may issue an administrative citation to a person the Department
20 believes violated section 246, 248, 248a, or 8010 of this title, any rule adopted
21 pursuant to those sections, or any certificate of public good issued pursuant to
22 those sections.

1 (1) An administrative citation, whether draft or final, shall:

2 (A) state each provision of statute and rule and each condition of a
3 certificate of public good alleged to have been violated;

4 (B) include a concise statement of the facts giving rise to the alleged
5 violation and the evidence supporting the existence of those facts;

6 (C) request that the person take the remedial action specified in the
7 notice or pay a civil penalty of not more than \$5,000.00 for the violation, or
8 both; and

9 (D) if remedial action is requested, state the reasons for seeking the
10 action.

11 (2) The Department shall initiate the process by issuing a draft
12 administrative citation to the person and sending a copy to each municipality in
13 which the person's facility is located, each adjoining property owner to the
14 facility and, for alleged violations of the facility's certificate of public good,
15 each party to the proceeding in which the certificate was issued.

16 (A) At the time the draft citation is issued, the Department shall file a
17 copy with the Board and post the draft citation on its website.

18 (B) Commencing with the date of issuance, the Department shall
19 provide an opportunity of 30 days for public comment on the draft citation.

20 The Department shall include information on this opportunity in the draft
21 citation.

1 (C) Once the public comment period closes, the Department may file
2 a revised draft citation with the Board. The revised draft citation may be
3 accompanied by a stipulation or agreed settlement with a request for Board
4 approval.

5 (D) The Board may on its own initiative open a proceeding to
6 investigate the violation alleged in the draft citation. The Board shall take any
7 such action within 15 days of the close of the public comment period, or the
8 filing of a revised draft citation, whichever is later. Such a Board proceeding
9 shall supersede the draft citation.

10 (3) If the Board has not opened a proceeding pursuant to subdivision
11 (2)(D) of this subsection, the Department may issue a final administrative
12 citation to the person. Within 30 days of receipt of a final administrative
13 citation, the person shall respond in one of the following ways:

14 (A) Request a hearing before the Board on the existence of the
15 alleged violation, the proposed penalty, and the proposed remedial action.

16 (B) Pay any civil penalty set forth in the notice and agree to
17 undertake such remedial action as is set forth in the notice and submit to the
18 Department for its approval a plan for compliance. In such a case, the final
19 administrative citation shall be enforceable in the same manner as an order of
20 the Board.

21 (C) Decline to contest the existence of the alleged violation and
22 request a hearing on either the proposed penalty or remedial action, or both.

1 When exercising this option, a person may agree to either the proposed penalty
2 or remedial action and seek a hearing only on the penalty or action with which
3 the person disagrees.

4 (4) When a person requests a hearing under subdivision (3) of this
5 subsection, the Board shall open a proceeding and conduct a hearing in
6 accordance with the provisions of this section on the alleged violation and such
7 remedial action and penalty as are set forth in the notice. If the Board
8 determines that the alleged violation may merit a penalty under this section
9 greater than \$5,000.00, it shall so notify the alleged violator and provide an
10 additional opportunity to be heard before rendering a final decision.

11 (5) If a person pays the civil penalty set forth in a final administrative
12 citation, then the Department shall be precluded from seeking and the Board
13 from imposing additional civil penalties for the same alleged violation unless
14 the violation is continuing or is repeated.

15 (6) If a person agrees to undertake the remedial action set forth in a final
16 administrative citation, failure to undertake the action or comply with a
17 compliance plan approved by the Department shall constitute a separate
18 violation.

2 Sec. 9. 30 V.S.A. § 3 is amended to read:

3 § 3. ~~PUBLIC SERVICE BOARD~~ UTILITY COMMISSION

4 (a) The Vermont Public Service Board Utility Commission shall consist of
5 a Chair and two members. The Chair and each member shall not be required to
6 be admitted to the practice of law in this State.

7 (b) The Chair shall be nominated, appointed, and confirmed in the manner
8 of a Superior judge.

9 (c) Members of the ~~Board~~ Commission other than the Chair shall be
10 appointed in accordance with this subsection. Whenever a vacancy occurs,
11 public announcement of the vacancy shall be made. The Governor shall
12 submit at least five names of potential nominees to the Judicial Nominating
13 Board for review. The Judicial Nominating Board shall review the candidates
14 in respect to judicial criteria and standards only and shall recommend to the
15 Governor those candidates the Board considers qualified. The Governor shall
16 make the appointment from the list of qualified candidates. The appointment

6 and signing the findings, orders, decrees, and judgments therein. A retiring
7 Chair shall also remain a member for the purpose of certifying questions of law
8 if appeal is taken. For such service, he or she shall receive a reasonable
9 compensation to be fixed by the remaining members of the ~~Board~~ Commission
10 and necessary expenses while on official business.

6 When preparing the Vermont Statutes Annotated for publication, the Office
7 of Legislative Council shall make the following revisions throughout the
8 statutes as needed for consistency with Secs. 9–11 of this act, as long as the
9 revisions have no other effect on the meaning of the affected statutes:

10 (1) replace “Public Service Board” with “Public Utility
11 Commission”; and

12 (2) replace “Board” with “Commission” when the existing term “Board”
13 refers to the Public Service Board.

14 Sec. 13. RULES; NAME CHANGE

15 (a) The rules of the Public Service Board in effect on July 1, 2017 shall
16 become rules of the Vermont Public Utility Commission (the Commission).

17 (b) In those rules, the Commission is authorized to change all references to
18 the Public Service Board so that they refer to the Commission. Unless
19 accompanied by one or more other revisions to the rules, such a change need
20 not be made through the rulemaking process under the Administrative
21 Procedure Act.

2 Sec. 14. PLAN; CITIZENS' ACCESS TO PSB HEARINGS FROM
3 REMOTE LOCATIONS; SPENDING AUTHORITY

4 (a) On or before December 15, 2017, the Division for Telecommunications
5 and Connectivity within the Department of Public Service, in consultation with
6 relevant organizations such as the Vermont Access Network and Vermont
7 access management organizations, shall submit to the House Committee on
8 Energy and Technology and the Senate Committees on Finance and on Natural
9 Resources and Energy a plan to achieve citizen access to hearings and
10 workshops of the Public Service Board from remote locations across the State.
11 The access shall include interactive capability and the ability to use multiple
12 remote locations simultaneously. The plan may build on the Department's
13 Vermont Video Connect proposal described in the Report to the General
14 Assembly by the Vermont Interactive Technologies Working Group dated
15 Dec. 9, 2015, submitted pursuant to 2015 Acts and Resolves No. 58,
16 Sec. E.602.1.

17 (b) The plan shall include each of the following:

- 18 (1) assessment of cost-effective interactive video technologies;
19 (2) identification of at least five locations across Vermont that are
20 willing and able to host the access described in subsection (a) of this section;
21 (3) the estimated capital costs of providing such access; and
22 (4) the estimated operating costs for hosting and connecting.
