8	§ 5401. DEFINITIONS	
9	As used in this subchapter:	
10	* * *	
11	(15)(A) "Conviction" means a judgment of guilt following a verdict or	
12	finding of guilt, a plea of guilty, a plea of nolo contendere, an Alford Plea, or a	
13	judgment of guilt pursuant to a deferred sentence.	
14	(B) A sex offender whose sentence is deferred shall have no duty to	
15	register after successful completion of the terms of the deferred sentence	
16	agreement for the duration specified in the agreement unless:	
17	(i) the offender violates the terms of the deferred sentence	
18	agreement and is sentenced on the conviction, in which case the offender's	
19	name shall remain on the registry for the period of time required by subsection	
20	5407(e) or (f) of this title; or	

(ii) the court finds that the interests of justice warrant placing the

offender's name on the registry during the period when the sentence is

1	deferred, in which case the offender's name shall be removed from the registry		
2	upon his or her successful completion of the deferred sentence agreement.

5	§ 5411A. ELECTRONIC POSTING OF THE SEX OFFENDER REGISTRY

7	(e) Information regarding a sex offender shall not be posted electronically		
8	if the conduct that is the basis for the offense is criminal only because of the		
9	age of the victim and the perpetrator is within 38 months of age of the victim.		
10	(f) Information regarding a sex offender shall not be posted electronically		
11	prior to the offender reaching the age of 18, but such information shall be		
12	otherwise available pursuant to section 5411 of this title.		
13	* * *		
14	(m) Information regarding a sex offender whose sentence is deferred shall		
15	not be posted electronically unless the offender violates the terms of the		
16	deferred sentence agreement and is sentenced on the conviction.
