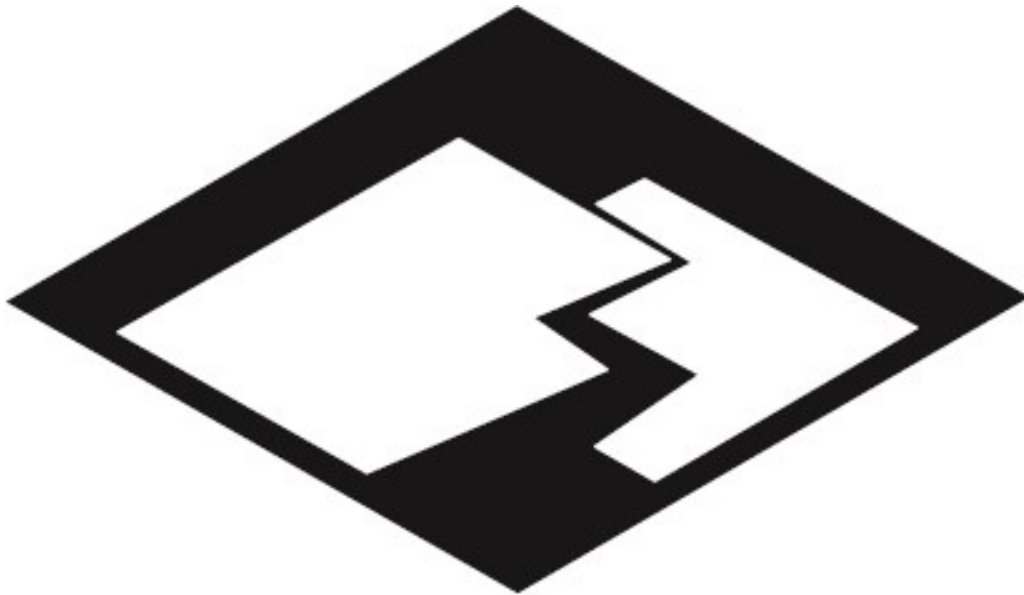

## PROGRAM SERVICES

### WORKSHOPS

There were **102** workshop offerings provided during calendar year 2017, many of which were similar in nature to courses that have been offered by Vermont Local Roads in previous years.

## ADDITIONAL WORKSHOPS

- **1,265** participants (1,131 municipal employees and 134 VTrans & ANR employees)

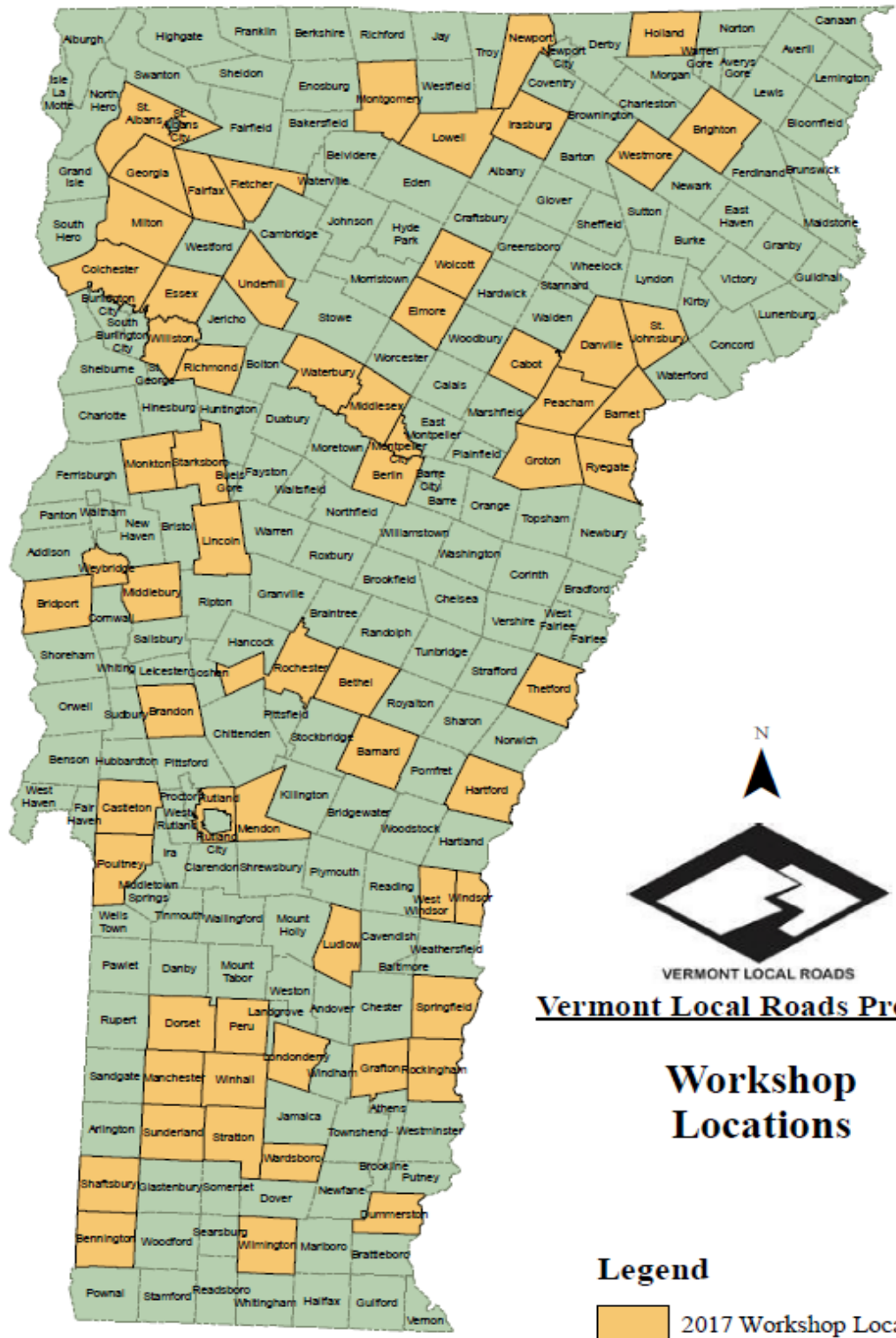
## TECHNICAL ASSISTANCE

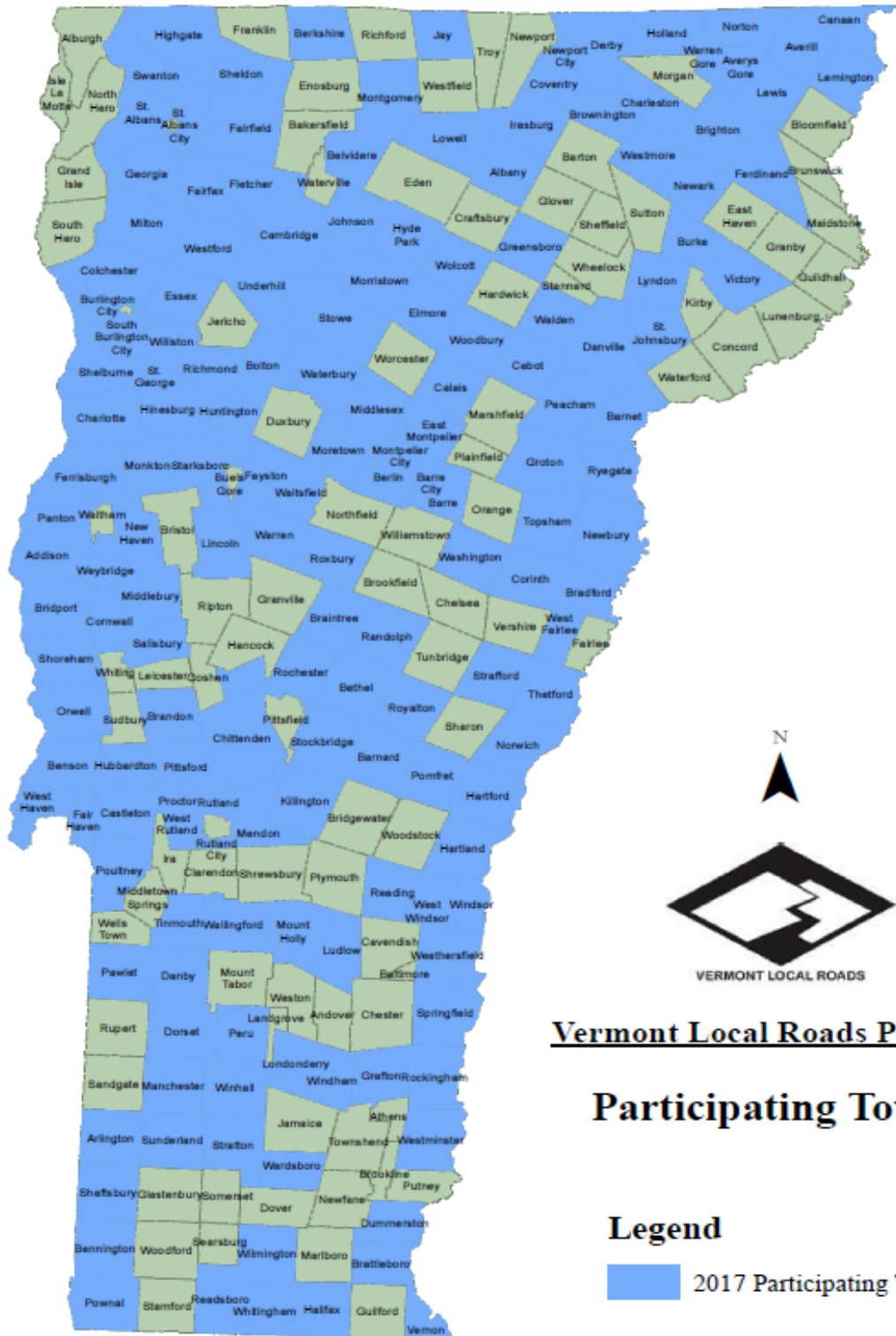

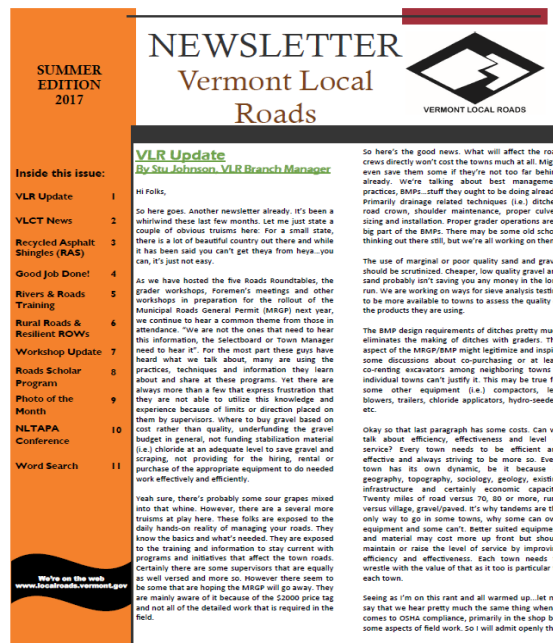

**Newsletter** – We continue to produce newsletters periodically and have been exploring other distribution methods. The newsletter is also available electronically via the VLR website and distributed on our listserv.



**Listserv** – Subscribers have increased from **459 to 514** in calendar year 2017 with weekly activity on the site. The Listserv is the most efficient way to quickly inform municipalities of workshop opportunities, highlight municipal equipment for sale as well as state surplus equipment, and advertise municipal employment opportunities. It serves as a discussion forum for the subscribers to collaborate with each other. This service allows towns to communicate with each other as well as have open discussions and share or ask questions to other communities for their input on any particular town highway related subject. We also partner with the National Weather Service in Burlington to put out Hazardous Weather Alerts and updates.

On June 9, 2017, Vermont Local Roads attended the Colchester 2025 - Turning our Vision into Reality Summit to present three Master Roads Scholar awards to staff from the Colchester Public Works. An appreciation award was given to Floyd Sheesley during the luncheon for his dedicated efforts and support of the Vermont Local Roads Stakeholder Group. Bios are below for the Colchester crew that received their Masters awards.

Tom grew up in Essex. He worked for the City of Winooski for several years before coming to work for the Town of Colchester. He is a 1-ton snow plow driver in the winter and works with the asphalt patching crew in the summer.

Scott has been with the Town of Colchester for over 30 years. He has been Crew Leader for the past 10 years and leads the most important programs such as snow removal, street sweeping and roadside mowing.

Dane grew up in Colchester. He is one of the main line plow drivers in the winter and operates the Street Sweeper and Line Stripping Equipment in the Spring/Summer months.

## Partnerships

Establishing and maintaining partnerships are high priorities of VLR, FHWA, and NLTAPA. Below is a list of key partners:

### National Local Technical Assistance Program Association (NLTAPA)

VLR staff will continue to look for opportunities to collaborate, learn and/or share best practices with their neighboring state LTAP centers. VLR staff participate in workgroups consisting of communications, safety and training resources.

### Center for Local Aid Support (CLAS)

The Center provides national leadership and direction in the administration of the LTAP Centers to advance innovative practices in these communities.

The Center works collaboratively with a diverse mix of partners including LTAP Centers. The programs provided are designed to put good policies in place and provide models for other agencies, as well as inform the federal transportation discussion.

VLR staff will continue to work with CLAS providing feedback on the new reporting processes for the Program Assistance Report (PAR).

### Regional Planning Commissions (RPC's) & Road Foreman Groups

- Collaborate with RPC staff on outreach assistance
- To organize road foremen meetings
- Provide agenda topics and attend the road foreman meetings
- Attend Transportation Planning Initiative (TPI) monthly meetings periodically

### Vermont League of Cities and Towns (VLCT)

- VLR communicates with VLCT to prevent duplicity of workshops and maintain open collaboration regularly
- VLCT is a member of the VLR Key Stakeholder group
- VLR will exhibit at the VLCT Municipal Town Fair and attend the Annual meeting
- Partner with VLCT on joint training for municipalities like the Municipal Road Management for Decision Makers workshop

## Better Roads Program (BR)

The relationship between VLR and BR continues to grow in the following areas:

- Increased communication between BR and VLR tech requests
- Publish BR information in VLR newsletter and listserv
- Provide training and best management practices at workshops
- VLR holds a seat on the Grant Selection Committee
- VLR is partnering with BR to help provide updated information on the grant process

## VT Department of Environmental Conservation (DEC)

- VLR participated on the Act 64 required Municipal Roads General Permit (MRGP) “core”, “foreman”, and “technical” committees for the development of the permit
- VLR will continue to understand the changes in best management practices to meet new water quality standards for municipalities and incorporate them into trainings
- VLR will provide training and resources for DEC to municipalities

- VLR will provide administrative assistance and publicity for the annual Field Day

## Key Stakeholder Group

VLR established a key stakeholder group which meets quarterly to gather feedback and validate the direction of the program.

This group consists of:

- 3 VLR staff members
- VTTC Program Manager
- 4 municipal members (Colchester, Groton, North Bennington & West Windsor)
- 1 VLCT member
- 1 BR member
- 1 RPC member

## ADDITIONAL ACCOMPLISHMENTS:

- Held the 30<sup>th</sup> Annual Northeast Regional LTAP Meeting in May of 2017 with 29 attendees from the Northeast Region.
- More workshop sessions were brought directly to individual towns in their regional locations.
- VLR Circuit Rider has achieved his certification to instruct the OSHA 10 training which will create further cost savings for future workshops.
- VLR has developed reporting and certification within the Learning Management System (LMS) and went live October 1, 2017. The LMS provides more robust tools and a much more stable platform to store our information. If desired, a municipal employee can now have access to their own training records. This new system will allow significant improvements and data collection on training evaluations and in the future be leveraged for e-Learning capabilities including TC3 online training.

## 2018 GOALS

- Training will be provided to municipalities on the use of the Learning Management System.
- Continue to build and provide relevant curriculum to fill knowledge gaps in the municipal workforce.
- Continue to expand the heavy equipment training including loader & excavator.
- VLR will work with the foreman group leaders to provide training, discussion and networking.
- Collaborate with VT DEC on the Municipal Roads General Permit and provide workshops that pertain to the upcoming changes.
- Assist NLTAPA conference committee with preparations for the 2019 National Conference that will be held in Burlington, VT in July of 2019.
