16	Sec. 1. DETERMINATION OF AVERAGE DAILY MEMBERSHIP FOR

5	(3) "Criminal record check" shall mean the criminal record check
6	required under 16 V.S.A. § 255.
7	(4) "Equalized pupils" shall have the same meaning as used in

10	<u>16 V.S.A. § 4001(15).</u>

15	(b) Notwithstanding the time frame in 16 V.S.A § 4010(a), on or before
16	February 15, 2017, the Secretary of Education shall determine the average
17	daily membership of each school district for the 2016–2017 school year. The
18	Secretary shall include in the average daily membership each prekindergarten
19	child who attended a prequalified program as of January 13, 2017 that fulfilled
20	required criminal record checks after the end of the census period. Any
21	determination by the Secretary of average daily membership on or before

- 1 December 1, 2016 for the 2016–2017 school year, as required by 16 V.S.A
- 2 <u>§ 4010(a), shall be considered a preliminary determination.</u>
- 3 (c) Notwithstanding the time frame in 16 V.S.A § 4010(h), the Secretary
- 4 <u>shall determine the count of equalized pupils for fiscal year 2018 on or before</u>
- 5 February 16, 2017, which shall be final for that year. Any determination by
- 6 the Secretary of the count of equalized pupils for fiscal year 2018 on or before
- 7 December 15, 2016 for the 2018 fiscal year, as required by 16 V.S.A
