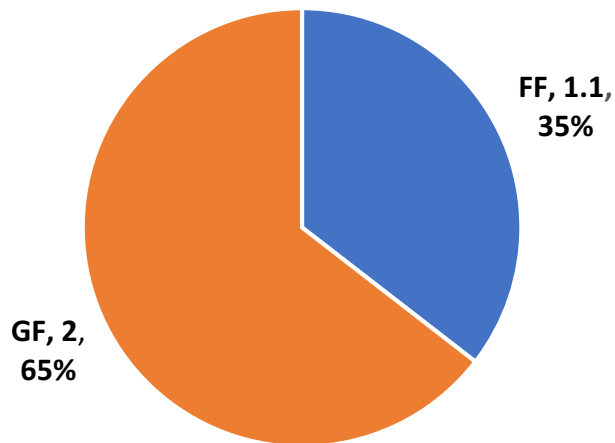

Executive Summary

Guided by [22 V.S.A. §601-635](#), the mission of the Department of Libraries (VTLIB) is to provide, administer, and maintain access to information in a variety of formats to the three branches of State government, libraries statewide, the general public, and Vermonters with special needs; to support, strengthen, and foster new means for statewide cooperation and resource sharing among all types of libraries and government agencies; to lead a service of advice and consultation to all libraries, in order to assist them in realizing their potential; and to increase public awareness of libraries and their services.

Inherent in this mission is the belief that libraries are essential to the general enlightenment of citizens in a democracy and that every citizen of the State of Vermont should have access to the educational, cultural, recreational, informational, and research benefits of libraries.

- The Vermont Department of Libraries collections, currently located on the 2nd floor of the Pavilion Building in Montpelier, will be moving to our new home in the summer of 2018. VTLIB provides reference

service and houses special collections with a focus on Vermont legislative history, Vermontiana, Title 29 holdings, and library science, serving State Government, local libraries, and citizens. In FY16 the Department transferred law library duties to the Vermont Law School library and provides an annual grant to the Vermont Law School library to provide public access to legal reference, the law library collection, and electronic resources;

- VTLIB administers a program of minimum standards for public libraries, certification of public librarians, and continuing education for library staff and trustees;
- VTLIB offers grants to qualifying libraries to strengthen their capacity to deliver quality library service, build partnerships, and to strengthen community services and improve access to information;
- VTLIB enables statewide resource sharing (interlibrary loan) among all types of libraries. In 2017 the Department launched a new statewide shared online library catalog, providing citizens easy access to the holdings of libraries statewide. VTLIB also provides courier services to libraries willing to share costs with the Department of Libraries to increase access to holdings across the state;
- VTLIB administers out of state interlibrary loan services for all public libraries and state employees;

- VTLIB supports 21st century library service to Vermont citizens via their local libraries through collaborative efforts and partnerships that support (among others) digital literacy, financial literacy, and agricultural literacy and provide access to digital tools and resources providing high-speed, high capacity broadband;
- VTLIB provides programs and services for children, teens, and families to support early literacy, STEM learning, the love of reading, and a path to success in school and lifelong learning;
- VTLIB provides all Vermonters who have qualifying visual and physical disabilities access to quality library services, and the special format materials they need for reading, to engage in lifelong learning, and to improve their economic self-sufficiency.

DEPARTMENT DIVISIONS AND PROGRAMS

In 2016 the Department of Libraries worked with Himmel & Wilson Library Consultants to study its organizational structure during a time of significant change, including the loss of a quarter of VTLIB staff positions, the closing of the state law library, and the changing role of libraries in the digital age. The final [Vermont Department of Libraries Reorganization Study](#) includes a set of recommendations that were used as a guide in restructuring the Department.

The listing below is based on the Department's new organization chart which created in mid 2017. VTLIB has 18 employees, including 8 librarians with a master's degree in Library Science (MLS) or a PhD in the field.

- Administers budget and federal LSTA (Library Services and Technology Act) funds;
- Administers grants to libraries;
- State Librarian is Secretary of the Vermont Board of Libraries, an advisory body to the State Librarian, and responsible for geographic naming in Vermont;
- Administers the Vermont Public Library Foundation;
- National library policy, trends, and legislation via participation with COSLA (Chief Officers of State Library Agencies);
- Builds collaborative partnerships, and major program initiatives;
- Pursuit and management of grants;
- Leads PIVOT program assessment and measurement.
- Provide data and statistics on programs and services from Vermont's libraries to state and federal stakeholders.

- Consulting services for public library personnel and library trustees;
- Continuing education and Certification programs for public library employees;
- There are currently 111 libraries in Vermont serving populations less than 2,500, requiring us to rearrange our consulting structure, our Continuing Education program, and our Certification program.
- "Job Hunt Helpers" program (partnership with Community College of Vermont) places CCV students in 12 public libraries to provide one-on-one computer training for citizens, with a focus on careers, employment, job advancement, and small business development;
- Library for the Blind & Physically Handicapped;
 - Local recording program at the Library for the Blind & Physically Handicapped trains volunteers to read and edit digital recordings of Vermont books/authors for uploading to blind readers across the U.S.;
- Local recording booth available to state government employees;
- Library services to three state institutions;

- Programs for youth and families:
 - Vermont Early Learning Initiative (VELI)
 - Vermont Early Literacy Initiative – STEM (3-year National Leadership for Libraries grant) introduces physical science/science inquiry in library programs for young children and families. National model pilot project in 25 public libraries. (Partnership with the Vermont Center for the Book and the Montshire Museum of Science);
 - National Leadership Grant from IMLS (VELI-STEM)
 - Three statewide youth book awards.
 - Statewide Summer Reading Program reaches children and teens to encourage the love of reading and to help prevent the "summer slide," the loss of reading skills when out of school;

- State Library collections and reference service;
- Information service for state government;
- Statewide digital resources for citizen access;

- New statewide resource sharing network and shared library catalog. Implementation of the new system was in Summer 2017;
- Vermont Online Library collection of subscription-based licensed digital content available universally to all Vermonters;
- Interlibrary loan courier delivery service in 93 public libraries. VTLIB issued an RFP for interlibrary loan courier service and is negotiating a contract that will go into effect early 2018;
- Grant to the Green Mountain Digital Archive to digitize and upload digital content of academic and special libraries to the Digital Public Library of America;
- Digitizing Vermont newspaper collection in partnership with VSARA and Newspapers.com to increase accessibility of the collection.
- Wide Area Network for 42 FiberConnect libraries;
 - Expanded public library videoconference network by adding equipment and training to nine FiberConnect libraries, and purchased subscription videoconferencing software. We offer this network to state government, but it requires individual agreements with the libraries in the network.
- Cataloging and bibliographic services for Vermont libraries;
- IT planning and support services for local libraries;

- Participation in multi-state purchasing contracts for library books and supplies;
- Digitization project planning and support;
- Distribution of state statutes/state publications.

VERMONT BOARD OF LIBRARIES

The Vermont Board of Libraries is a seven-member citizen board which serves in an advisory capacity to the State Librarian. Board members are appointed by the Governor. (22 V.S.A. § 602) The Board is also responsible for geographic naming. (10 V.S.A. § 151-154)

Budget Highlights for FY2019:

- Department fully staffed with new organization chart in place;
- Provided grants to small rural libraries to “migrate” to the new statewide shared integrated library system in FY17, improving citizen access to library holdings statewide;
- Robust interlibrary loan courier delivery service will improve citizen access to library materials borrowed from Vermont libraries across the state;
- Strengthen VTLIB services to state government, including an information needs assessment of state employees and library collections (print, digital) and services to meet those needs;
- Build digital collections and platforms to take into account the new service model and the recent reduction of space;

- Library Advancement Division will modernize the (1) *Minimum Standards for Vermont Public Libraries* program and (2) Librarian Certification program;
- Develop training program for VTLIB employees with a focus on tech skills, instructional design for presenting online learning, data collection, measurement and assessment.

VTLIB has the responsibility to meet the needs of our various customers:

(1) State Government

- VTLIB houses specialized library collections (including information databases) to meet the research and information needs of state government.
- State employees and legislators have access to the digital content in the Vermont Online Library and are eligible to receive a Vermont Department of Libraries borrower's card and free interlibrary loan service.
- VTLIB provides access to a local recording studio and recording software.
- VTLIB is working with CAPS to include leadership and management materials for state employees. We currently offer professional development courses online through Universal Class that cover topics from Accounting to Writing Skills.

- VTLIB is working with Department of Labor and ACCD on PIVOT goals that utilize VT library resources throughout the state.
- VTLIB is actively reaching out to agencies and departments to understand the information needs of state government to improve access to state government services and to provide platforms for other agencies and departments to get information into the hands of Vermonters.

(2) Public Libraries

Vermont's 183 public libraries are independent and funded almost entirely locally. In FY16 there were only 66 MLS (Master's degree in library science) librarians working in Vermont public libraries and many libraries are headed by individuals with no formal library training. Libraries circulated over 4.5 million items in FY16 and reported 3.1 million on-site visits. Each year more Vermonters take advantage of library downloadable e-books and e-audiobooks, and in FY16 there was a 2% increase in library program attendance.

VTLIB services to public libraries:

- Library consulting to library staff and trustees (66 librarians in our state, with 183 public libraries);
- Professional development and continuing education training for library personnel and library trustees;
- Interlibrary Loan/Resource Sharing System

New statewide resource sharing system and interlibrary loan courier delivery service enhances service for citizens and provide a cost savings for local libraries;

- Motion Picture Performance License
Statewide motion picture performance license for public libraries. The VTLIB vendor contract allows Vermont schools to purchase the license at a 50% discount;
- Summer Reading Program
VTLIB is a member of the [Collaborative Summer Library Program](#) which contracts for artwork for posters, bookmarks, and reading records, based on an annual theme. VTLIB purchases these materials and distributes them to libraries across the state. Summer Reading theme for children in 2018 is Space: "A Universe of Stories."
- Vermont Early Literacy Initiative (VELI)
VTLIB, in partnership with the Vermont Center for the Book, coordinates the VELI program in more than 60 public libraries, designed to strengthen programs for young children, parents, and childcare providers. Trainings for local librarians have included pre-reading skills, introducing basic math concepts, social/emotional development, and the Vermont Early Learning Standards.
- "First Wednesdays" Program
VTLIB is a supporting sponsor of the Vermont Humanities Council's [First Wednesdays](#) series with a state grant to VHC, as well as grants to the nine participating libraries.
- Supplement Collections of Public Libraries

As required by 22 V.S.A. § 605 (4), and as part of our relocation plans and reduced capacity to house physical collections, the Department of Libraries supplements library collections throughout the state through our new Interlibrary Loan system, courier system, and digital offerings.

(3) School and Academic Libraries

VTLIB offers services to school and college libraries:

- Statewide resource sharing network;
- Vermont Online Library access to databases
- Three statewide child-selected book awards (K12 schools)
 - Red Clover Book Award
 - Dorothy Canfield Fisher Book Award
 - Green Mountain Book Award
- Letters About Literature Program (Library of Congress) (K12 schools)
- Green Mountain Digital Archive (academic libraries). Grant support.

(4) Vermont Citizens

VTLIB provides direct service to citizens:

- Vermont State Library is open to the public;
- "Ask a Librarian" e-mail reference service;
- Department of Libraries books and materials available via interlibrary loan;
- Department of Libraries grants collection and the Foundation Center's database to research grant opportunities;

- Library for the Blind & Physically Handicapped (Berlin) provides free "talking books" by mail and downloadable audiobooks to qualified disabled citizens;
- Vermont Online Library (VOL) includes full-text periodical databases, e-reference books, homework-help for students of all ages, foreign language learning, current health and medical information, Career Transitions databases, Small Business Resource Center, Chilton's Auto Repair, and a variety of other electronic resources. VOL is available to citizens and students via all Vermont academic, school, and public libraries.
- Universal Class online learning, and genealogy databases are available to all citizens via their local public libraries.
- Digital Literacy Training
In FY18 VTLIB plans to continue digital literacy training and assistance for citizens at selected libraries via the Job Hunt Helpers program (grant to CCV), as well as the subscription to online career and testing databases (Learning Express Library) available in several of the state's busiest public libraries.

DEPARTMENT OF LIBRARIES FUNDING

Federal Funds

VTLIB receives federal LSTA (Library Services and Technology Act) funds, administered by the Institute of

Museum and Library Services (IMLS). The FFY17 Vermont "Grants to States" allotment was \$910,722 which must be spent by 9/30/18. At this writing the FY18 allotment has not yet been announced. LSTA funding is used to pay partial salaries/benefits for over 50% of VTLIB employees and every major statewide project we are involved in. Reductions in VTLIB state funds put at risk VTLIB's ability to meet required Maintenance of Effort (MOE) and the 34% Match.

Federal LSTA funding supports:

- Consulting services to local libraries;
- Library for the Blind & Physically Handicapped;
- Summer Reading Program for youth;
- Vermont Early Literacy Initiative (VELI);
- Continuing education for local library personnel;
- Vermont Online Library information databases;
- Statewide resource sharing network;
- Interlibrary Loan Courier delivery program;
- Scholarships for local library staff to attend national and regional conferences;
- Supplementing E-book purchases for public libraries.

VTLIB's *Vermont LSTA 5-Year Plan, 2018-2022* was approved by the Institute of Museum and Library Services in June 2017. The independent evaluation report of the current Vermont 5-Year Plan is available to VTLIB website.

Special Funds

- The Elva S. Smith Trust (bequest) "aid[s] in the development and maintenance of library service to

the children of Vermont." These funds are used for partial salary for the Youth Services Consultant, grants to public libraries, and the Vermont Early Literacy Initiative (VELI). This bequest is part of the trust left by Elva Smith, a nationally-known librarian who was born in Vermont.

Inter-Agency Transfers

- Westlaw legal databases. VTLIB manages the State's Westlaw contract which provides access to licensed electronic legal resources. Attorneys throughout state government purchase individual accounts to the Westlaw databases.

VERMONT PUBLIC LIBRARY FOUNDATION

During the 2000 legislative session, the State Librarian was authorized to form the Vermont Public Library Foundation (22 V.S.A. § 610) to enhance local public library services through private fundraising. The State Librarian serves as President of the Foundation. VPLF was started with an endowment from the Freeman Family Foundation. In FY2007, the Foundation established the Winnie Belle Learned Fund with financial contributions from Dr. Burnett Rawson, a retired physician from Essex. Since his death, the Foundation receives an annual distribution from the Rawson Family Trust. VPLF offers competitive grant awards to Vermont public libraries.

a. What are your programs?

Authorized by 22 V.S.A. §601-635, the Vermont Department of Libraries administers these programs:

- **Library Advancement Division:** Consulting services statewide to public library staff and trustees; continuing education and professional development for library personnel; librarian certification program (public libraries); *Minimum Standards for Public Libraries* program, administer grants to states funds from federal Institute of Museum and Library Services; Administer federal Erate funds to libraries; and annual public library statistics data collection and report.

- **Library for the Blind & Physically Handicapped** serves all eligible Vermont citizens with “talking books” in digital format and braille by mail; large print book collection; library services to three state institutions. The local recording program, with trained volunteers reading and editing digital recordings of books by Vermont authors (or on Vermont-related topics), uploads digital recordings in the national catalog for the blind and physically handicapped. In FY16 we purchased and installed a portable recording studio at the Midstate Library Service Center (Berlin). A newly reclassified position of Library Consultant to Special Populations will expands work to advance library services for vulnerable and underserved populations.
- **Library Services to Children, Teens and Families**
Consulting and professional development for personnel in public libraries; Vermont Early Literacy Initiative (VELI) in public libraries; Children’s literature book collections (Montpelier and Berlin); statewide summer reading program for children and teens in public libraries; three statewide child-selected book awards. In FY16 we received a National Leadership for Libraries grant from the Institute of Museum and Library Services to implement the 3-year [VELI-STEM program](#) in 25 Vermont public libraries, introducing science inquiry and physical science (STEM) activities and learning for young children and their families. This project is designed to be a model for small and rural libraries across the country and will include training of state library staff from 22 states in October 2017.

- **Information and Access Services Division:** cataloging support and training for local libraries; assistance with library automation projects; FiberConnect wide area network for 42 public libraries; statewide resource sharing network; Interlibrary Loan; Government Services Librarian for library services to state government; Vermont Online Library; community videoconference service in 23 public libraries.

In January 2017, we begin implementation of a new statewide resource sharing system to replace the out-dated Vermont Automated Library System (VALS). This system will enhance the ability of Vermont citizens to easily discover library holdings and borrow items from local libraries across the state via interlibrary loan.

Interlibrary loan courier delivery service in 93 public libraries. VTLIB issued an RFP for interlibrary loan courier service and is negotiating a contract that will go into effect early 2018;

- **The Vermont Online Library (VOL)**, a collection of electronic subscription-based licensed information databases for citizens via all Vermont public, school, and academic libraries, includes full-text periodical articles, medical/health information, homework help, car repair information, foreign language learning, business, employment, and other resources. In 2017, we eliminated the cost-share requirement for libraries making this a universally-available resource for all Vermonters.
- **Vermont State Library:**

The Vermont State Library has seen major changes in the past 2 years, with the closing of the state law library and the elimination of the position of state law librarian. By the summer of 2017, we will be moving into our new home in Barre at the Vermont Historical Society building. This requires a reduction of 2/3 of our current collections. In 2016 the Library's collection of state documents and publications was transferred to Vermont State Archives and Records Administration (VSARA). In 2017, The Vermont newspapers on microfilm were also transferred to VSARA in order to streamline access for Vermonters looking to research VSARA and State Library materials. Also in 2017, an "on-call" librarian replaced a fully-staff reference desk.

The Library's resources (including electronic databases) and reference service serve the three branches of state government and the public. Universal Class, Learning Express, geo-

authenticated access to our online databases for all Vermonters, Heritage Quest access from all of our libraries. Library collections: Library Science, Vermontiana, General Reference, Vermont legislative history and law, children's literature, and the Foundation Center's grants database and a collection of supporting materials. The State Library is a partial Federal documents depository. The Library handles public inquiries via the State of Vermont Information Line and "Ask a Librarian" e-mail reference service.

The Department provides an annual grant to the library at the Vermont Law School to provide public access to the law library collection, WESTLAW legal databases, and reference service provided by a law librarian on-site, via phone, and via the "Ask a Law Librarian" e-mail service.

Our Statewide Interlibrary Loan services (ILL) and courier system replaces the general collections at both the Midstate Library Service Center (Berlin) and a majority of general collections housed in the Pavilion building. Our large print collection will serve to supplement the collections of schools and public libraries. We also supplement e-book and audiobook collections through Recorded Books and support of the Overdrive resources by partnering with the Green Mountain Library Consortium.

- **Sale, Distribution, and Storage of state publications** (53 V.S.A. § 1115 – 1193a)
- **Vermont Board of Libraries and Geographic Naming** (10 V.S.A. § 151-154)
Note: naming of transportation entities was moved to the State Transportation Board, effective March 2016.

b. How do these programs meet your core mission?

Guided by [22 V.S.A. §601-635](#), the mission of the Department of Libraries (VTLib) is to provide, administer, and maintain access to information in a variety of formats to the three branches of State government, libraries statewide, the general public, and Vermonters with special needs; to support, strengthen, and foster new means for statewide cooperation and resource sharing among all types of libraries and government agencies; to lead a service of advice and consultation to all libraries, in order to assist them in realizing their potential; and to increase public awareness of libraries and their services.

Inherent in this mission is the belief that libraries are essential to the general enlightenment of citizens in a democracy and that every citizen of the State of Vermont should have access to the educational, cultural, recreational, informational, and research benefits of libraries.

We provide consultation, training and other services to librarians and public library board members and we offer resources, services, and grants to libraries to strengthen their capacity to deliver quality library service to citizens and to foster new means for statewide cooperation and resource sharing through education and awareness of available resources.

We support resource sharing between all types of libraries making it possible for citizens to borrow books and other materials from across the state and the country. We assist public libraries and library employees to adopt 21st century skills and practices, including library automation and networking.

We provide all Vermonters with qualifying visual and physical disabilities access to the special format materials they need to enjoy recreational reading, to engage in lifelong learning, and to improve their economic self-sufficiency; we manage a "local recording" program of volunteers who record Vermont books and authors in digital format so that our visually impaired citizens will have access to recordings of local and regional interest not available from the National Library Service (NLS) catalog. We support library service at three state institutions: Vermont Veteran's Home, Woodside Juvenile Rehabilitation Center, and the State Psychiatric Care Hospital. We also have begun to use general and federal funds to improve government services to underserved populations throughout the state.

Inherent in our mission is the Department's advocacy of the right of Vermont citizens to read and have full access to information by ensuring that libraries and their resources are readily accessible to all Vermonters regardless of their geographic location, their level of income or education, access to technology, or disability. Priority programs for FY19: (1) Improve training program and certification program delivery for librarians, trustees and staff; (2) continue to support the local recording program for the visually impaired; (3) continue digital literacy and financial literacy programs to help citizens with workforce and career-related computer assistance/training.

- a. **What does success in each program look like to Vermonters, both those served by the program and the general population?**

Much of our work involves direct service to public libraries, with the goal that our libraries will provide quality service to citizens. We also work with academic and school libraries and provide services directly to citizens – and to state government, via State Library services such as interlibrary loan, negotiating statewide movie licensing, and providing statewide access to the Vermont Online Library.

One of our goals is to improve access to state government services and programs for Vermonters through pathfinders, partnerships, and training of library staff regarding state government services and programs. In order for the Department of Libraries to succeed in this goal, we have begun to partner with other agencies and departments in an effort to highlight the services of state government and to leverage state government access through our readily accessible public libraries.

Success means providing Vermonters with library services that match or exceed the services that they find in libraries in other states. Success means creating sustainable programs and services that improve access to materials and information. Success means creating partnerships with other agencies and departments in which the Department of Libraries provides access to information and provides platforms for state government to reach Vermonters. Our ability to support state government and provide a bridge between local and state entities is a valuable asset that we plan to encourage and grow.

Success looks (or will look) like this:

- Vermont state government services and programs held in our library community centers.
- Digital connections to state services through public libraries.
- Equal access to library services and programs throughout Vermont.
- Combat the digital divide that exists between rural and urban populations in regards to library service standards.
- The Vermont State Library will assess the information and research needs of state government and provide library resources and a Government Services Librarian to respond to both basic and complex information inquiries, with an emphasis on information databases and other digital resources.

- The library workers in our public libraries are trained, tech-savvy, knowledgeable, good managers, and provide quality service to their local communities. They have skills that support community partnerships and collaboration and they adapt library services to the changing needs of their communities and to changes in the technology and information marketplace. They possess – and they support the same in Vermont citizens – the 21st century skills necessary to live and work in today's world.
- Parents read to their children and have books and other reading materials in the home. Children develop a love for reading and learning from a very early age and have success in school. They use their local school and public libraries as places of learning and discovery, including STEM-related learning. Vermont's small and rural libraries offer a national model for STEM-related programs for young children and their families.
- All Vermonters have access to the information and reading materials they need for their recreational, educational, informational, and aspirational pursuits. Libraries provide services and programs that enhance lives and allow citizens to grow and prosper – and provide resources in both print and digital formats.
- Libraries are important community centers, offering space, materials, and expertise for public programs, civic engagement, and lifelong learning. They also play a critical community role in disaster situations, providing information, safe havens, and technology.
- Vermonters are finding jobs, creating businesses, engaging in online distance learning, connecting with their community, and exploring new ideas and opportunities at their local public libraries.
- Libraries in Vermont are on a path of sustainability with adequate funding, sound fiscal management, and visionary strategic planning. The Department of Libraries has a strong interest in looking at new models for library governance and funding for Vermont public libraries.
- All Vermonters have free access to computers and the Internet, books and digital library resources, and the assistance of a trained library professional, no matter their age, income or economic status, educational attainment, ability or disability, or where they live. Citizens have free access to the wealth of ideas, viewpoints, and opinions necessary to be critical thinkers, informed citizens, and active participants in our democracy.
- Vermonters have access to their libraries from home and office via virtual and online library services, and a robust statewide resource sharing system.

- Vermont libraries and other collecting institutions work in partnership to preserve the written record and cultural heritage of Vermont in digital formats and work to provide access to these treasures via the Digital Public Library of America (DPLA).

b. What performance measures are used to determine progress and what baseline data is available (current and proposed budget, # served, etc.)?

In 2017 we completed a new LSTA 5-Year Plan (federal program) with revised outcomes. In February, 2017 we received the report from QualityMetrics, Inc., an independent evaluation firm, hired to do the federally required assessment of our work on the current LSTA 5-Year Plan. This report is posted on our website.

VTLIB Goals and Objectives:

- Expand services for learning and access to information and educational resources in a variety of formats, in all types of libraries, for individuals of all ages to support such individuals' needs for business development and creation, workforce development, digital literacy, and lifelong learning.
- Establish and enhance electronic linkages and improve coordination among and between agencies, departments, and outside organizations to make information more accessible to vulnerable, underserved, and remote populations.
- Increase the capacity of VTLib to provide services and programs by improving our organizational framework and supporting a well-trained and empowered workforce.
- Increase the capacity of the Vermont Public Library Foundation to support public libraries.
- Provide access to resources available statewide through interconnected platforms that share content/collections across libraries.
- Provide libraries opportunities to strengthen their capacity to provide quality services and resources to all citizens.
- Enhance workforce readiness programs, including entrepreneurial endeavors, using materials and services available through libraries.

- By 2022, VTLib will increase the number of individuals and groups participating in classes or programs will indicate through surveys that they learned something by participating in the activity and that they are confident about using what they have learned.
- By 2022, a majority of library staff and library trustees participating in training provided by the State Library and its partners will indicate through surveys that they learned something by participating in the training activity; are confident about using what they have learned and that they are likely to apply what they have learned to help improve library services to the public.
- By 2022, a majority of library and library system staff and library trustees participating in training provided by VTLib and its partners will indicate through surveys that they are better able to anticipate and meet changing customer needs and better able to measure their progress toward achieving service excellence because of such training.
- By 2022, partners find that the Job Hunt Helpers program has increased their ability to provide services and has resulted in a positive partnership for their organization.
- By 2022, a majority of participants in the job hunt helper program and its partners will indicate through surveys that they learned something by participating in the training activity; are confident about using what they have learned and that they are likely to apply what they have learned to help improve workforce readiness or have helped with their entrepreneurial endeavors.
- By 2022, a majority of library staff and patrons who are surveyed will indicate that they are more aware of the applicable resources and services available to them through VTLib, their libraries, and state government.

- By 2021, a majority of library staff will indicate through surveys that they are better equipped to provide strong summer reading programs for their communities and that they use materials provided by the Vermont Department of Libraries for this purpose.
- By 2021, a majority of staff at libraries who participated in VELI and VELI-STEM training will report increased confidence in applying skills to improve early literacy services for families with young children in their communities.
- By 2021, a majority of staff at libraries who participated in VELI and VELI-STEM early childhood training will say that they have applied what they learned to offer new or enhanced early literacy services.
- By 2021, a majority of staff at libraries who participated in VOL training will say that they have applied what they learned to offer new or enhanced library services.
- By 2021, a majority of staff at libraries who participated in Library for the Blind and Physically Handicapped and Services to Underserved Populations programs will say that they have applied what they learned to offer new or enhanced library services.
- By 2022, partners find that the partnerships created with the Department of Libraries have increased their ability to provide services and has resulted in a positive partnership for their organization.
- By 2022, partners find that the Writer's project has increased the involvement of their community in literacy and community based writer's projects. They will show an improved knowledge in this service provided and the skills that it takes to become part of a community of writers.

Note: In 2018-2019 we will begin the process of revising the *Vermont Minimum Standards for Public Libraries*, the Librarian Certification program, and partner with ADS to begin to provide digital solutions to our Continuing Education program and the way that we capture, store and present internal and external library data for better transparency.

3. Is there a better way?

Yes. And we continue to move in the right direction. In 2016 we received the final report from Himmel and Wilson Library Consultants which has helped us restructure the Department and create a new organization chart. We have finished reclassifying positions and are one position short of recruiting to fill vacancies that were left open during the restructuring process.

In FY18 and FY19 we will:

- Build partnerships to support the work of the legislature and the agency of administration;
- Leverage the people and facilities available through libraries of all kinds in tackling the major issues faced by state government;
- Focus on digital services to state employees and focus on supporting libraries through digital offerings of databases, materials, and training opportunities;
- Overhaul our Library Standards and Librarian Certification programs;
- Continued use of LEAN and RBA performance assessment to set outcomes and measure success;
- Focus on statewide services that have the greatest impact for VT citizens;
- Work to preserve our full allotment of federal LSTA funding.

Department of Libraries

Department Strategic Mission Statement

Guided by [22 V.S.A. §601-635](#), the mission of the Department of Libraries (VTLib) is to provide, administer, and maintain access to information in a variety of formats to the three branches of State government, libraries statewide, the general public, and Vermonters with special needs; to support, strengthen, and foster new means for statewide cooperation and resource sharing among all types of libraries and government agencies; to lead a service of advice and consultation to all libraries, in order to assist them in realizing their potential; and to increase public awareness of libraries and their services.

Inherent in this mission is the belief that libraries are essential to the general enlightenment of citizens in a democracy and that every citizen of the State of Vermont should have access to the educational, cultural, recreational, informational, and research benefits of libraries.

The services and programs we offer bring together the core concept that libraries are social and community centers that provide equal access to quality information designed to increase the level of knowledge in a community. Libraries represent social capital, supporting community engagement and the means for citizen self improvement and personal enrichment.

In 2016 the Department of Libraries (VTLIB) received the [final report](#) from Himmel and Wilson Library Consultants with recommendations for Department reorganization. This followed FY16 budget cuts which resulted in a 26% reduction of VTLIB staff positions and the loss of the Vermont State Law Library in Montpelier. The changes wrought by budget reductions, combined with the changing landscape of libraries, and innovations in digital technology, made this the perfect time for a thorough examination of the Department. The Himmel and Wilson report resulted in adoption of a new organization chart and has paved the way for the Department to create a new strategic plan and to implement programs and services designed to provide the greatest impact for libraries and the citizens they serve. We have moved to a model in which we support library efforts to achieve the core concept outline above. Our services are now designed to reinforce and support various approaches to literacy, support state government efforts to provide access to state information and resources, and make library services more accessible to vulnerable and underserved populations.

The Department receives federal Library Services & Technology (LSTA) funding from the "Grants to States" program of the Institute of Museum and Library Services (IMLS). The Department created a new 5-Year LSTA Plan for submission to IMLS in June 2017. The Department hired Quality Metrics, Inc. to conduct the federally required independent evaluation of the current 5-Year Plan, and their report helped to inform the new 5-Year Plan.

Current Plan:

Vermont Department of Libraries: Library Services and Technology Act, Five-Year Plan, 2018-2022

- GOAL 1. Vermonters will have access to resource available statewide through interconnected platforms that share content/collections across libraries.
- GOAL 2. Vermont libraries will have opportunities to strengthen their capacity to provide quality services and resources to all citizens.
- GOAL 3. Vermont libraries will enhance workforce readiness programs, including entrepreneurial endeavors, using materials and services available through libraries.
- GOAL 4. Vermont libraries will build partnerships, programs and services that enhance access to early childhood and family literacy, digital literacy, and lifelong learning library resources, particularly to populations facing barriers to traditional library services.

Indicators:

The new 5-Year Plan relies on improved data collection and analysis and carefully chosen measures for success. Traditional indicators and measurements (e.g., the number of books circulated from our library collections) are no longer sufficient to show the impact of our programs on the lives of Vermont citizens. Because much of the Department's work is focused on direct services to libraries, we are also challenged to help local libraries improve program delivery, local assessment, data collection, and reporting. In FY18 we will revise our continuing education and Certification programs for local public librarians, and in the first quarter of 2017, the Department will submit a report to IMLS which includes data about the operations of our state library agency, including budget and expenditures, library collections, staffing, and programs.

Market:

VTLIB is part of the Agency of Administration and provides a variety of library and information services to the three branches of state government, libraries statewide, the public, and Vermonters with special needs. The Department also offers consulting, training, grants, and a variety of programs and services for libraries, library staff, and library trustees.

Current programs focus on these outcomes for Vermont citizens:

Jobs and Job Skills

The “Job Hunt Helpers” program places CCV students in 12 public libraries to help individuals learn bridge the digital divide regarding digital literacy so that they have the skills they need to find employment, advance in jobs, engage in distance learning, and start new businesses. (Partnership with Community College of Vermont and the Vermont Department of Labor).

Early Childhood Learning

The Vermont Early Literacy Initiative (VELI) program in over 60 public libraries and the Vermont Early Literacy Initiative-STEM (VELI-STEM) federal grant project in 25 libraries train local librarians so they have the skills and expertise to work with young children, their parents, and local childcare providers to advance pre-reading skills, introduce basic math and science into library programming, support social and emotional development in children, and apply the Vermont Early Learning Standards. (Partnership with the Vermont Center for the Book).

Lifelong Learning: Citizen Access to Books and Library Resources Not Available Locally

In 2017 the Department will replace the outdated Vermont Automated Library System (VALS) with a new statewide resource sharing system (interlibrary loan) and shared library catalog. Citizens will be able to easily locate and request books and other materials from libraries across Vermont to meet their recreational, informational, and educational needs. To support this new system, the Department will launch a new statewide interlibrary loan courier delivery service to transport books requested through the resource sharing system.

Citizen Access to High Quality Electronic and Digital Resources

Beginning in January 2017, the Vermont Online Library, a robust collection of online subscription-based electronic content on health, business, full-text magazine and newspaper articles, foreign language learning, and much more, is available for the first time to *all* Vermonters through their local public, school, and academic libraries. In addition, the Department purchases downloadable e-books and e-audiobooks for two library consortia that make these resources available to citizens in over 150 communities across the state. The Department is also working with academic and special libraries to compile their own digital repositories so that the content can be made available globally via the Digital Public Library of America. Finally, we moved our microfilmed newspaper collection to VSARA for better storage and in anticipation of our move to Barre. We are also working with VSARA to digitize our Vermont Newspaper collection and to make them available to all Vermonters through free online digital services.

State Government: A New Model for Library Service

The Vermont State Library is shifting focus from housing print collections to providing virtual information service designed to reach state employee computer desktops. A new Government Services Librarian will assess the information needs of state employees and help develop new library collections, with an emphasis on electronic resources, to meet those needs.

Resources:

In FFY17 our allotment of federal LSTA (Library Services and Technology Act) funding comes with a required State Maintenance of Effort (MOE) of over \$1,200,000. LSTA also requires a 34% Match (general and special funds) of expenditures on programs outlined in VTLIB's LSTA Five-Year Plan. The Department's general fund budget must always be designed with MOE and Match requirements at the center. If we are unable to maintain Match and MOE, the federal funds will be split evenly among other states that are able to maintain Match and MOE, causing Vermont to fall further behind in terms of library funding and reciprocal services to Vermonters.

In FY2018 we will be spending down carry-forward funds that have been earmarked for special projects. The lion's share of these carry forward funds, that were previously earmarked for services (such as the new Interlibrary Loan system) are now going to the move to Barre.

Programmatic Changes:

In FY18 the Department will be fully staffed, after an extended period of staff vacancies and budget reductions.

How we are going to achieve the desired outcomes:

- Revised employee job descriptions, reclassified positions, and staff professional development will improve organizational effectiveness to carry forward the work that will be outlined in our new 5-Year Plan (June 2017);
- Continue current partnerships with selected state agencies and other organizations, and new collaboration and grant funding when possible to increase our capacity;
- Increase the number of continuing education workshops for the library workforce and introduce training opportunities for local library directors;
- Create a culture of excellence in government service. We expect to be an example of efficiency and excellence in customer service by holding ourselves accountable and thoroughly assessing our programs, services, and interactions with partners, state employees, and members of the public;
- Focus our services on those programs which emphasize partnerships and measurement for outcomes and impact, particularly to citizens (via their local libraries) and state government;

Measuring Productivity and Efficiency:

- Continue to monitor and evaluate programs and services, as well as Department workflow, policies, and procedures to make the best use of time, staff, and money. Train all staff on RBA and LEAN principles. Eliminate or redesign programs when necessary. Apply RBA and LEAN tools;
- Look at opportunities for relocating programs to other agencies or organizations, or developing new partnerships for sharing programs and services;
- Use survey tools to determine information needs of state government;
- Use survey tools, forums, and focus groups to determine needs and to measure success of programs delivered to libraries (and, therefore, to citizens);
- Improve techniques used to gather and report data. Establish internal controls to help with program evaluation (e.g., RBA);

Capital Needs for the Program:

- **Interlibrary Loan Delivery System:** Beginning in January 2016, VTLIB, in partnership with the Green Mountain Library Consortium (GMBA), has managed a pilot interlibrary loan courier delivery service for 81 public libraries. GMBA has contracted with Green Mountain Messenger to provide the service which will end on 6/30/17. Based on data collected from the pilot project, VTLIB issued an RFP for a statewide, state-managed courier service. GMBA and VTLIB have purchased bins and bags for libraries; VTLIB has provided grants to pilot libraries to pay a portion of the library courier service costs during the pilot period.

Statewide interlibrary loan courier service is a core service of many state library agencies across the country. This frees up space required to maintain collections to supplement collections of libraries throughout the state. It also creates a robust, discoverable system of material lending that catapults Vermont into the 21st century in regards to how materials are moved and discovered both nationally and locally.

- **Office/Space renovation and moving.**
In FY2018 we will be moving to our new home in Barre, by leasing space at the Vermont Historical Society building. This reduces our fee for space costs by half and allows for partnerships with the Vermont Historical Society regarding programs and services. We have worked with the Department of Buildings and General Services on both the lease and the budget for moving which required us to earmark nearly \$1 million dollars of carry forward funds to this project.

Organizational Chart

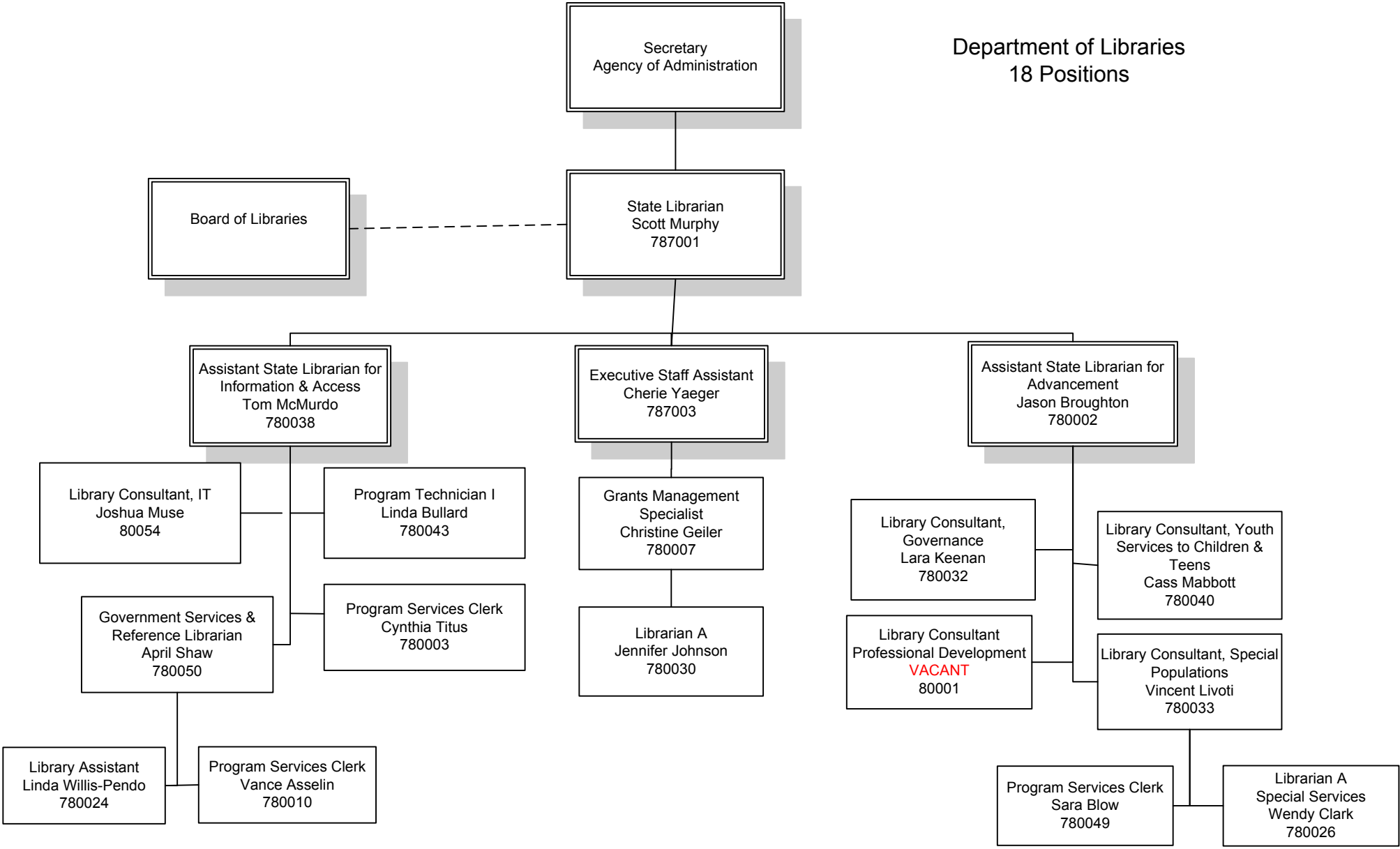
