These bills are not needed. The current network has led to significant growth in Vermont craft beer and Vermont wine brands. I have seen first hand what the current laws bring, and that is more competition, and more choices for consumers, and more growth for the wholesale industry leading to more growth and room in the market all the way down to the vineyards.

These bills try to fix a problem that doesn't exist - craft brewers and Vermont wineries being able to get their products to consumers.
