Leonard Berliner was appointed to Labor Relations Board in ^{October} of 2006. His earlier career was in the field of education in Hartford, Conn. where he worked as a teacher, and Principal for over thirty years. He was President of the Hartford Principal's and Supervisors Associaton, AFL-CIO for a total of twelve years representing over 130 administrators. He served as a chief negotiator for numerous administrative contracts in the State of Conn. for over twenty years. He served as Vice President of the Conn. State Federation of Administrators, AFL-CIO and as National Vice President of the American Federation of School Administrators, AFL-CIO from 1989 through 1997. He retired from the Hartford Conn. School System in 1994. Since 1994 he has worked in various interim administrative positions . Most recently Mr. Berliner has served as President of the Quechee Lakes Landowners as President and CEO (1998-2001) capping off an 11 year term as a member of the Board of Trustees. He has also been employed as the Executive Director of the Claremont N.H. Chamber of Commerce. Since 2000, Berliner has been elected to the Hartford, VT Board of Selectman, where he now serves as Chairman since March 2006. Mr. Berliner received his B.S. from Central Conn.
