12	It is hereby enacted by the General Assembly of the State of Vermont:
13	Sec. 1. 32 V.S.A. § 9241 is amended to read:
14	§ 9241. IMPOSITION OF TAX
15	(a) An operator shall collect a tax of nine percent of the rent of each
16	occupancy plus a \$2.00 charge for each night of the occupancy.

1	Sec. 2. 10 V.S.A. chapter 22B is added to read:
2	CHAPTER 22B. WORKFORCE AND SUPPORTIVE HOUSING
3	§ 547. WORKFORCE AND SUPPORTIVE HOUSING FUND
4	(a) The Workforce and Supportive Housing Fund is established, to be
5	managed in accordance with 32 V.S.A. chapter 7, subchapter 5 and
6	administered by the Vermont Housing and Conservation Board.
7	(b) The Board shall use the Fund for the following purposes:
8	(1) to create and preserve permanently affordable housing, including
9	workforce housing and supportive housing for the homeless, seniors, victims
10	of domestic or sexual violence, and other vulnerable populations;
11	(2) to fund infrastructure in support of affordable and workforce
12	housing;
13	(3) to provide rental assistance and other forms of housing-related
14	financial assistance for the homeless, seniors, victims of domestic or sexual
15	violence, and other vulnerable populations; and
16	(4) to provide housing-related supportive services for the homeless,
17	seniors, victims of domestic or sexual violence, and other vulnerable
18	populations.
19	(c) The Fund shall comprise the following:
20	(1) the receipts from the occupancy charge imposed by 32 V.S.A.
21	§ 9241;

1	(2) any State or federal funds as may be appropriated by the General
2	Assembly; and
3	(3) any gifts, grants, or other contributions to the Fund.
4	(d) The monies deposited in the Fund during the prior fiscal quarter shall
5	be allocated as follows:
6	(1) to the Agency of Human Services:
7	(A) 30 percent for rental and other forms of housing-related
8	assistance, including assistances for rental arrearages, rapid rehousing, and
9	homelessness prevention; and
10	(B) 10 percent for housing-related supportive services.
11	(2) to the Vermont Housing and Conservation Board:
12	(A) 50 percent to support a revenue bond and other expenditures
13	furthering the development of permanently affordable workforce and
14	supportive housing for Vermonters with low income; and
15	(B) 10 percent for infrastructure in support of workforce housing
16	pilot projects.
17	(3) Of the amounts appropriated in subdivisions (1)(A) and (1)(B) of
18	this subsection, 25 percent or more of the funding shall be used to provide
19	assistance to victims of domestic or sexual violence.
20	(e) The Commissioner of Finance and Management may draw warrants for
21	disbursements from this Fund in anticipation of receipts.

3	Sec. 3. FISCAL YEAR 2018 OCCUPANCY CHARGE ALLOCATIONS
4	(a) In fiscal year 2018, of the amount of the occupancy charge imposed by
5	32 V.S.A. § 9241 allocated to the Agency of Human Services from the
6	Workforce and Supportive Housing Fund in 10 V.S.A. § 547(d)(1)(A), the
7	funds shall be appropriated as follows:
8	(1) 30 percent to the Department for Children and Families for the
9	Vermont Rental Subsidy Program;
10	(2) 25 percent to the Office of Economic Opportunity for the Housing
11	and Opportunity Grant Program;
12	(3) 15 percent to the Department of Mental Health for the Homeless
13	Housing Subsidy Plus Care Program; and
14	(4) 30 percent to the Vermont State Housing Authority for "project
15	based" rental assistance for permanently affordable supportive housing funded
16	by the Vermont Housing and Conservation Board.
17	(b) In fiscal year 2018, of the amount of the occupancy charge imposed by
18	32 V.S.A. § 9241 allocated to the Agency of Human Services from the
19	Workforce and Supportive Housing Fund in 10 V.S.A. § 547(d)(1)(B), the
20	funds shall be appropriated as follows:

1	(1) 20 percent to the Office of Economic Opportunity for the Family
2	Supportive Housing Program;
3	(2) 30 percent to the Office of Economic Opportunity for the Housing
4	and Opportunity Grant Program;
5	(3) 25 percent to the Secretary of the Agency of Human Services for
6	direct service and service coordination grants; and
7	(4) 25 percent to the Department of Disabilities, Aging, and Independent
8	Living for the Assistive Community Care Services Program.
