

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Corrections and Institutions to which was referred  
3 House Bill No. 777 entitled “An act relating to Clean Water State Revolving  
4 Loan Fund” respectfully reports that it has considered the same and  
5 recommends that the bill be amended by striking out all after the enacting  
6 clause and inserting in lieu thereof the following:

7 Sec. 1. 24 V.S.A. § 4751 is amended to read:

8 § 4751. DECLARATION OF POLICY

9 It is hereby declared to be in the public interest to foster and promote timely  
10 expenditures by municipalities for water systems, ~~water pollution abatement~~  
11 ~~and control facilities~~ clean water projects, and solid waste management, each  
12 of which is declared to be an essential governmental function when undertaken  
13 and implemented by a municipality. It is also declared to be in the public  
14 interest to promote expenditures for certain existing privately owned public  
15 water systems and certain privately owned ~~wastewater and public and~~ potable  
16 water supply systems to bring those systems into compliance with federal and  
17 State standards and to protect public health and the environment. Additionally,  
18 it is declared to be in the public interest to promote public-private partnerships  
19 and expenditures by private entities for clean water projects to protect and  
20 improve the quality of waters of the State.

7           natural resources project over the life of the loan.

8           § 4753. REVOLVING LOAN FUNDS; AUTHORITY TO SPEND; REPORT

9           (a) There is hereby established a series of special funds to be known as:

10           (1) The Vermont Environmental Protection Agency (EPA) Pollution  
11           Control Revolving Fund, which shall be used, consistent with federal law, to  
12           provide loans to ~~municipalities and State agencies~~ for planning and  
13           construction of ~~water pollution abatement and control facilities~~ clean water  
14           projects, including acquisitions of project-related easements, land, options to  
15           purchase land, and temporary or permanent rights-of-way, and for  
16           implementing related management programs.

A municipality may apply for a loan, the proceeds of which shall be used to acquire, design, plan, construct, enlarge, repair, or improve ~~a publicly owned water pollution abatement and pollution control facility~~ a clean water project, public water supply systems as defined in subdivision 4752(9) of this title, or a solid waste handling and disposal facility, or certain privately owned ~~wastewater systems~~ clean water projects as described in section 4763 of this title, or to implement a related management program. In addition, the loan proceeds shall be used to pay the outstanding balance of any engineering planning advances made to the municipal applicant under this chapter and determined by the Secretary to be due and payable following construction of the improvements to be financed by the proceeds of the loan. The Bond Bank may prescribe any form of application or procedure required of a municipality for a loan hereunder. ~~Such~~ The application shall include such information as the Bond Bank shall deem necessary for the purpose of implementing this chapter.

1        § 4780. ELIGIBILITY AND LOAN APPLICATION

2            (a) The Vermont Economic Development Authority (VEDA) is authorized  
3        to make loans on behalf of the State to private entities for a clean water project;  
4        provided, however, that no State funds are used. Such loans shall be issued  
5        and administered by VEDA pursuant to this subchapter.

6            (b) A private entity may apply to VEDA for a loan from the Vermont  
7        Environmental Protection Agency Pollution Control Revolving Fund,  
8        established in section 4753 of this title, for a clean water project. The loan  
9        proceeds shall be used to acquire, design, plan, construct, enlarge, repair,  
10       improve, or implement a clean water project. Loan proceeds shall not be used  
11       for operation and maintenance expenses or laboratory fees for monitoring.

12           (c) The Secretary and VEDA may prescribe any form of application or  
13        procedure for a loan hereunder, request from an applicant any information  
14        deemed necessary to implement this subchapter, and impose an application fee  
15        and an administrative fee determined reasonable and necessary to cover  
16        administrative costs. Fee proceeds shall be deposited in the administrative fee  
17        account established in subsection 4755(a) of this chapter.

18        § 4782. CONDITIONS OF LOAN AGREEMENT

19           (a) VEDA may make loans to applicants on behalf of the State for one or  
20        more of the purposes set forth in subsection 4781(b) of this title. Each loan  
21        shall be made subject to the following conditions:

1           (1) The loan shall be evidenced by a note payable over a term not to  
2           exceed 30 years. Repayment shall commence not later than one year after  
3           completion of the project for which loan funds have been issued.

4           (2) The loan shall be secured with assets as determined by VEDA.  
5           VEDA may also require that the applicant assign all or a portion of any  
6           revenues from the clean water project as security for the loan or may require  
7           the establishment of a reserve fund.

8           (3) The rate of interest charged for loans shall be set by the State  
9           Treasurer, taking into consideration prevailing borrowing rates available to  
10           similarly situated applicants from private lenders and the administrative fees to  
11           be charged to applicants. VEDA, in cooperation with the Secretary, shall  
12           periodically recommend interest rates to be set by the State Treasurer that are  
13           the lowest practicable rates consistent with maintaining the long-term integrity  
14           of the Fund. The interest rate set by the State Treasurer may be less than the  
15           prevailing borrowing rates available to similarly situated applicants from  
16           private lenders, but not less than zero percent.

17           (b) The loan agreement shall specify the terms and conditions of the loan  
18           and its repayment by the applicant, as well as other terms and conditions  
19           determined necessary by the Secretary and VEDA.

20           (c) Disbursement of loan proceeds shall be based on certification to the  
21           Secretary and VEDA by the loan recipient demonstrating that the costs for

1 which reimbursement is requested have been incurred and paid by the  
2 recipient. The recipient shall provide supporting evidence of payment upon  
3 the request of VEDA. Partial disbursements of loan proceeds shall be made  
4 not more frequently than monthly.

5 (d) Interim financing charges or short-term interest costs may constitute an  
6 allowable cost of a project for which a loan is extended, provided VEDA  
7 approved in advance the terms, conditions, interest rate, and other related  
8 matters concerning the financing or interest cost. In the event short-term  
9 financing is unavailable to the applicant, VEDA may make interim loan  
10 disbursements not more frequently than monthly to the applicant and its  
11 general contractor as co-payees upon submission of a certified request for  
12 payment supported by actual invoices or other evidence satisfactory to VEDA  
13 of costs incurred.

14 (e) VEDA shall have the right prior to making any disbursement of the loan  
15 proceeds to require confirmation from an independent registered professional  
16 engineer that any work has been performed according to project plans and  
17 specifications approved by the Secretary.

18 (f) VEDA may require as part of the loan agreement that the applicant  
19 cause an audit of the project costs to be prepared and approved by VEDA prior  
20 to VEDA's making final payment of the loan amount.

1       (g) In the event of default, any amounts owed upon the loan shall be  
2       considered a debt for the purposes of 32 V.S.A. § 5932(4). VEDA may  
3       recover such debt pursuant to the setoff debt collection remedy established  
4       under 32 V.S.A. §§ 5933 and 5934.

5       § 4783. QUALIFICATIONS FOR ELIGIBILITY; CERTIFICATION

6       No loan to an applicant shall be made under this subchapter until:

7             (1) The applicant has certified all of the following to VEDA:

8                     (A) all State and federal permits and licenses necessary to undertake  
9       the project for which financing has been sought will be obtained prior to the  
10       expenditure of construction funds under the loan;

11                    (B) the applicant has sufficient means to pay the principal and  
12       interest on the loans and to pay any anticipated costs of operating and  
13       maintaining the financed project;

14                    (C) if the applicant is subject to the jurisdiction of the Public Utility  
15       Commission under 30 V.S.A §§ 102 and 203(6), the applicant has obtained the  
16       following approvals, if such approvals are necessary for the project, and has  
17       provided VEDA with copies of those approvals:

18                    (i) the certificate of public good issued by the Public Utility  
19       Commission pursuant to 30 V.S.A. § 231 (public good) and 30 V.S.A. § 108  
20       (approving the loan); and

1                    (ii) the decision and order of the Public Utility Commission  
2                    approving rates that are to be charged by the applicant.

3                    (D) the municipality or municipalities in which the clean water  
4                    project is located have provided a letter of support for the project.

5                    (2) The Secretary has certified to VEDA that the applicant and the

7                    that the project has priority for receipt of financial assistance.

9                    (a) The Secretary shall at least annually prepare and certify to VEDA a list  
10                    of privately owned clean water projects, ranked in priority order, that are  
11                    eligible for financial assistance under this subchapter.

12                    (b) In determining financing ability for clean water projects under this  
13                    subchapter, the Secretary shall apply the criteria adopted pursuant to 10 V.S.A.  
14                    § 1628; provided, however:

15                    (1) No privately owned clean water project authorized under this  
16                    subchapter shall be prioritized above a municipal clean water project.

6         Upon default of a loan, VEDA shall have the right to petition the Superior  
7     Court in the county in which the clean water project is located, or the Public  
8     Utility Commission for projects subject to the jurisdiction of the Commission,  
9     to appoint a receiver.

10    § 4787. LOAN CONSOLIDATION

11        Loans, or the outstanding balance of loans, made for the purpose of  
12    preparing engineering plans for a project may be consolidated with any

17        (a) Neither the Vermont Economic Development Authority (VEDA) nor

19    applications for loans to private entities under 24 V.S.A. chapter 120,  
20    subchapter 4 submitted after June 30, 2023. However, VEDA and the  
21    Secretary shall continue to review and act on initial applications submitted on

1 or before June 30, 2023, as well as any amendments to timely initial  
2 applications.

(a) Findings. The General Assembly finds that the State shall protect Vermont's lakes, rivers, and streams from pollution by implementing programs to prevent sewage spills to Vermont waters and by requiring emergency planning to limit the damage from spills which do occur. In addition, the General Assembly finds it to be cost-effective and generally beneficial to the environment to continue State efforts to ensure energy efficiency in the operation of treatment facilities.

(b) Planning requirement. Effective July 1, 2007, the Secretary of Natural Resources shall as part of a permit issued under section 1263 of this title, require a pollution abatement facility, as that term is defined in ~~section 1251~~ of this ~~title~~ section, to prepare and implement an operation, management, and emergency response plan for those portions of each pollution abatement facility that include the treatment facility, the sewage pumping stations, and the

1 sewer line stream crossing. As used in this section, “pollution abatement  
2 facility” means municipal sewage treatment plants, pumping stations,  
3 interceptor and outfall sewers, and attendant facilities as prescribed by the  
4 Department to abate pollution of the waters of the State.

5 (c) Collection system planning. As of July 1, 2010, the Secretary of  
6 Natural Resources, as part of a permit issued under section 1263 of this title,  
7 shall require a pollution abatement facility, as that term is defined in ~~section~~
