**Our Data:**

Making Recovery Easier @ Marble Valley Rutland Correctional Facility (MVRCF)-began 6/20/2016-weekly groups (6 wk. rotation)

- Have had 478 total participants (average 11 people per group)-**6/20/16 thru 6/30/17 (first year)** with 12 certificates of completion earned in first year **(6/16-6/30/17)**
- Have had 234 participants (average 9 per group)-since **7/1/17 to present** with 16 certificates earned **7/1/17-present** - \*many continue to participate even after completion

SMART Recovery @ MVRCF-began 6/16/16-weekly groups (10 wk. rotation)

- Have had 485 total participants (average 10 people per group)-**6/16/16 thru 6/30/17** with 7 certificates of completion earned-6/16/17-6/30/17
- Have had 334 participants (average 12 per group)-**7/1/17-present** 12 certificates of completion earned

Turning Point Center Presentations at MVRCF (rotates between TPC of Addison County, Rutland County, and Bennington County)

- Monthly presentations which began 11/25/2015
- 168 attendees total through 12/2016

SMART Recovery groups at Mandala House

- Weekly groups since 9/26/16
- 7 Certificates of Completion earned
- 2-5 participants each group

SMART Recovery at Sanctuary House

- Weekly groups since 5/2016
- 2-6 participants each group
- 12 Certificates of Completion earned

#### Recovery Coaching at MVRCF-offered continuously to participants in Re-Entry program

- We provided recovery coaching weekly at MVRCF from 6/2016 to 1/1/18 who coached 6-8 individuals weekly, this was done as a volunteer position.
- We hired a Recovery Coach as of 1/1/18 to provide coaching 8 hours/week in MVRCF after being awarded Bowse Health trust funding for the Corrections recovery program. There have been 19 unique individuals coached since 7/1/2017 and these coaching sessions may go on for months with the individuals.

We are developing a tracking sheet to follow individuals post release to Rutland County for two years which will consist of tracking involvement with our program pre and post release, relapse and any new charges they may incur. Received funding through Bowse Health Trust as of 1/1/18 to fund the program for 3 years. We will be working closer with Drug Court, Probation and Parole and DOC transitional programs such as Homeless Prevention Center, Mandala and Sanctuary Houses. We currently have 13 unique individuals who we are maintaining contact with post-release since 7/2017.

#### Shared Supervision with Re-Entry Support Specialist Pilot program with Homeless Prevention Center (HPC)

- HPC hired one of our Recovery Coaches in this role to provide recovery support to HPC's DOC transitional housing participants.
- I provide co-supervision for the recovery coach through an MOU agreement with HPC.

Our center has been providing Bi-Monthly presentations to local Drug Court on services available at Turning Point Center of Rutland. We are developing an orientation program to be provided at our center for Drug Court participants. This will hopefully encourage more individuals to become involved with the center and utilize our recovery support programs. In the future, our plan is to have our groups of Making Recovery Easier and/or SMART become part of a requirement for Drug Court.
