Does Vermont law regulate the purchase of firearms at gun shows?	No	Several states have enacted laws to regulate firearms sales at gun shows, typically by requiring background checks. In addition, federal law requires FFLs to do background checks on any of their sales to non-licensees, at gun shows or anywhere else.
