NOTICE OF REFERRAL
WINDSOR RAPID ACCOUNTABILITY PROGRAM (WRAP)

I, on behalf of the State of Vermont, intend to refer the above-captioned case to the Windsor Rapid Accountability Program instead of filing a charge in criminal court.

Successful resolution of this case through WRAP is subject to: (1) an agreement to participate in the program under the terms set by the WRAP Pre-Charge Monitor, and (2) completion of your WRAP contract within 180 days. If you decide not to accept this referral, or do not successfully complete the program, a charge may be filed and the case may proceed to Court.

As a condition of referral, the State of Vermont requires, at minimum, satisfaction of the terms listed on Page 2 of this document. The Pre-Charge Monitor will incorporate these terms into your WRAP Contract and may require that you fulfill additional terms.

The purpose of WRAP is to assist you in addressing any underlying issues that, if left unchecked, could cause you to be arrested or cited by the police in the future. I wish you good luck with this process. Let's not see one another in court.

CONDITIONS OF WRAP REFERRAL BY STATE'S ATTORNEY

- Participant must engage in a risk assessment and needs screening, and must follow WRAP Pre-Charge Monitor's recommendations in light of the assessment and screening.
- Participant must have at least **1 contact** with the WRAP Pre-Charge Monitor per week.
- Participant must engage in substance abuse treatment. This may include residential or intensive outpatient treatment.
- Participant must sign releases so that WRAP Pre-Charge Monitor may have unrestricted conversation with treatment providers about progress in treatment.
- Participant must make restitution to the victim in the amount of _____.
- Participant must make restitution to the victim to the satisfaction of the WRAP Pre-Charge Monitor
- Participant must take all reasonable steps to obtain employment unless participant provides proof that he/she is enrolled full time in school or is fully disabled. If participant does not obtain employment or provide proof of full time schooling or full disability, participant must provide proof of at least five job interviews.
- Participant must complete _____ hours of community service
- Participant must complete a Restorative Justice Panel
