

The Mapping Section produces 319 individual Town Highway Maps of each municipality in Vermont.








National Highway System and Functional Classification of Highways








Route Logs – Straight Line Diagrams





Standard Map Production






Mapping produces a series of standard maps that are available on-line, including the Town & County Map Series, Federal Urban Area Maps, State Highway Map, District Map, and more.







Additional Mapping Related Projects

Mapping has worked on the statewide acquisition of lidar data, which is high resolution terrain data, with the Vermont Center for Geographic Information (VCGI), US Geologic Survey, and a group of stakeholders. Currently all of Vermont has been acquired, and delivered. The Missisquoi Basin, Addison County, and **Bennington County have** been acquired at the 0.7 meter resolution.


