8	Statement of purpose of bill as introduced: This bill proposes to exempt from
9	the Vermont criminal history record check fee individuals earning at or below
10	200 percent of the federal poverty level and the organizations that serve them.

12	It is hereby enacted by the General Assembly of the State of Vermont:
13	Sec. 1. 20 V.S.A. § 2063 is amended to read:
14	§ 2063. CRIMINAL HISTORY RECORD FEES; CRIMINAL HISTORY
15	RECORD CHECK FUND
16	(a) Except as otherwise provided for in this section, the cost of each check
17	for a criminal history record as defined in section 2056a of this title or a
18	criminal conviction record as defined in section 2056c of this title based on

name and date of birth shall be \$30.00. Out-of-state criminal history record

1	checks shall include any additional fees charged by the state from which the
2	record is requested.
3	(b) Requests made by criminal justice agencies for criminal justice
4	purposes or other purposes authorized by State or federal law shall be exempt
5	from all <u>criminal history</u> record check fees. The following types of requests
6	shall be exempt from the Vermont criminal <u>history</u> record check fee:
7	(1) Requests made by any individual, organization, or governmental
8	body doing business in Vermont that has one or more individuals performing
9	services for it within this State and is a qualified entity that provides care or
10	services to children, elders, or persons with disabilities as defined in 42 U.S.C.
11	§ 5119c.
12	(2) Requests made by researchers approved by the Vermont Crime
13	Information Center to conduct research related to the administration of
14	criminal justice. A fee, however, may be charged by the The Center may
15	charge a fee, which shall reflect the cost of generating the requested
16	information.
17	(3) Requests made by individuals to review their own <u>criminal history</u>
18	record at the Vermont Crime Information Center; however, copies of the

individual's record are not exempt from the <u>criminal history</u> record check fee.

(4) Requests made by the Vermont State Housing Authority and other

2	the Agency of Natural Resources.
3	(6) Requests made by an organization that, as its primary function,
4	serves individuals who are at or below 200 percent of the federal poverty level.
5	(7) Requests made by an individual who receives public benefits and
6	completes a notarized certification attesting that the individual's income is at
7	or below 200 percent of the federal poverty level.
8	(c)(1) The Criminal History Record Check Fund is established and shall be
9	managed by the Commissioner of Public Safety in accordance with the
10	provisions of 32 V.S.A. chapter 7, subchapter 5. The fees paid each year under
11	this section shall be placed in the Fund and used for personal services and
12	operating costs related to the processing, maintenance, and dissemination of
13	criminal history records. The Commissioner of Finance and Management may
14	draw warrants for disbursements from this Fund in anticipation of receipts.
15	(2) At the end of each fiscal year, any undesignated surplus in the Fund
16	shall be transferred to the General Fund.
17	(d) The Department of Public Safety shall have the authority, with the
18	approval of the Secretary of Administration, to establish limited service
19	positions as are necessary to provide criminal history record checks in a timely
20	manner, provided that there are sufficient funds in the Criminal History Record

Check Fund to pay for the costs of these positions.
