Statement of purpose of bill as introduced: This bill proposes to approve
amendments to the charter of the City of Barre.

An act relating to approval of amendments to the charter of the City of
Barre

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. CHARTER AMENDMENT APPROVAL

The General Assembly approves the amendments to the charter of the City
of Barre as set forth in this act. Voters approved the proposals of amendment
on November 6, 2018.

Sec. 2. 24 App. V.S.A. chapter 1 is amended to read:

CHAPTER 1. CITY OF BARRE

* * *

1 § 103. WARDS ESTABLISHED

2 There shall be three wards for the City of Barre and the boundaries of the
3 wards shall be fixed from time to time by the Board of Civil Authority subject
4 to the approval of the City Council. The boundaries shall be fixed so as to
5 provide equal or near equal distribution of population among the three wards in
6 accordance with the most recent federal census.

7 § 104. GENERAL CORPORATE POWERS

8 (a) The City shall have all the powers granted to towns and municipal
9 corporations by the Constitution and laws of this State together with all the
10 implied powers necessary to carry into execution all the powers granted; it may
11 enact ordinances not inconsistent with the Constitution and laws of the State of
12 Vermont or with this charter, and impose penalties for violation of those
13 ordinances ~~not in excess of a fine of \$500.00, together with~~ as allowed in 24
14 V.S.A. § 1974a, in addition to the costs of prosecution, ~~or imprisonment for~~
15 ~~not more than 60 days, or both.~~

16 (b) The City may purchase real property, or interest in real property, within
17 or without its corporate limits, for the public benefit. The City may acquire
18 real property by gift, devise, lease, or condemnation and may sell, lease,
19 mortgage, hold, manage, and control such property as its interest may require.

3 § 107. ~~{Same—}~~ INTRODUCTION; FIRST AND SECOND READINGS;
4 PUBLIC HEARING ORDINANCES; ADOPTION PROCESS

5 (a) Every ordinance shall be introduced in writing. The enacting clause of
6 all ordinances shall be “The Council of the City of Barre hereby ordains. . . .”
7 If the Council passes the proposed ordinance upon first reading, it shall cause it
8 to be published in the form passed in a newspaper of general circulation in the
9 City ~~in the form passed~~ or such other manner of publication as acceptable in
10 State law, at least once, together with a notice of the time and place when and
11 where there will be a public hearing to consider the same for final passage.
12 The first such publication shall be at least three days prior to the date of the
13 public hearing.

14 (b) After the public hearing, the Council may finally pass the ordinance
15 with or without amendment. If the Council amends the proposed ordinance,
16 then it shall cause the amended ordinance to be published at least once together
17 with a notice of the time and place of the public hearing, at which such
18 amended ordinance will be further considered and which publication shall be at
19 least three days prior to the public hearing. Once the ordinance is adopted by
20 the Council, the City Clerk shall cause the ordinance as adopted to be
21 published in a newspaper of general circulation within the City or such other

1 manner of publication as acceptable in State law, and said ordinance shall take
2 effect ~~20~~ 14 days after the date of the publication.

4 § 527. POWERS

5 The Housing Board of Review shall have ~~the~~:

6 (1) the power to decide disputes related to security deposits;

7 (2) all other powers as outlined in 24 V.S.A. §§ 5001–5008; and

8 (3) all powers related to landlord and tenant issues as designated by the

9 City Council through ordinance.
