| 15 | Statement of purpose of bill as introduced: This bill proposes to: (1) require |
| 16 | the Agency of Education to oversee and hire a consultant to conduct periodic |
| 17 | capital needs assessments of State school buildings, and (2) end the period of |
| 18 | suspension of State aid for school construction projects beginning with |
| 19 | consolidation projects. |

| 5 | Sec. 1. 16 V.S.A. § 3441 is added to read: |

| 7 | (a) On or before June 30, 2022, and once every five years thereafter, the |
| 8 | Secretary of Education shall oversee a capital needs assessment, including an |
| 9 | assessment of deferred maintenance, of all school buildings in the State. The |
| 10 | Secretary is authorized to hire a consultant to conduct the assessments |
| 11 | described in this subsection. The Secretary shall issue a report on the results of |
| 12 | the capital needs assessment on or before September 30 following the due date |
| 13 | of each assessment under this section and submit the report to the House |
| 14 | Committees on Education and on Corrections and Institutions and the Senate |

(7) Award of construction aid. Awards.

(A) Except as provided in other subdivisions of this subdivision (7) and elsewhere in law, the <u>The</u> amount of an award shall be 30 percent of the approved cost of the project.

(B) The amount of an award for the incremental costs associated with the installation of a space heating, water heating, cooling, or refrigeration system that uses biomass, a geothermal ground-source, wind, or solar energy as the primary heating or cooling source shall be 75 percent of the approved cost of those elements of the project specifically related to the renewable fuel source being used; provided that those elements may include the costs of necessary equipment, a chimney, air quality technology, and additional square footage necessary to house the heating unit and fuel; and further provided that those elements shall not include the costs of staff areas, site improvements relating to fuel delivery, and other ancillary costs as determined by the Secretary.

(C) The amount of an award shall be 50 percent of the approved cost of a project or applicable portion of a project that results in consolidation of two or more school buildings and that will serve the educational needs of students in a more cost effective and educationally appropriate manner as compared to individual projects constructed separately. A decision of the Secretary as to eligibility for aid under this subdivision (C) shall be final. This
