15	Subject: Vermont Housing and Conservation Trust Fund; Rural Economic
16	Development Initiative; designation of funds; barn restoration
17	Statement of purpose of bill as introduced: This bill proposes to limit the
18	expenditure of the Vermont Housing and Conservation Trust Fund solely to
19	the goals of affordable housing, natural resource conservation and protection,
20	and agricultural and historic preservation as designated under 10 V.S.A.
21	chapter 15. This act proposes to establish a minimum allocation requirement

1	for Fund expenditure to conservation and protection of Vermont's natural
2	resources. This act also proposes to expand the Historic Barns Preservation
3	Grant Program to those barns located on designated State Scenic Roads and
4	Byways.
5 6	An act relating to the Vermont Housing and Conservation Trust Fund and the Historic Barns Preservation Grant Program
7	It is hereby enacted by the General Assembly of the State of Vermont:
8	Sec. 1. FINDINGS
9	The General Assembly finds:
10	(1) Historically, the Vermont Housing and Conservation Trust Fund has
11	not received the minimum allocation of funds derived from 50 percent of the
12	property transfer tax under 32 V.S.A. chapter 231 as required by 10 V.S.A.
13	<u>§ 312.</u>
14	(2) The Fund is necessary to support the Vermont Housing and
15	Conservation Board's statutory obligations under 10 V.S.A. chapter 15,
16	including the conservation and protection of Vermont's important natural
17	areas, forestland, and historic properties.
18	(3) Vermont's working landscapes serve as gateways to the tourism
19	economy of small, rural communities.

1	Sec. 2. LEGISLATIVE INTENT
2	It is the intent of the General Assembly that:
3	(1) Full funding be granted to the Vermont Housing and Conservation
4	Trust Fund as required by 10 V.S.A. § 312, with a minimum of \$22,000,000.00
5	allocated to the Fund in fiscal year 2020.
6	(2) The Fund is for the sole use of the Vermont Housing and
7	Conservation Board to institute the goals, purpose, and policies established
8	under 10 V.S.A. chapter 15.
9	(3) The Board increase the proportion of allocated funds toward the
10	conservation and protection of Vermont's natural resources and support
11	projects with the purpose of natural resource restoration.
12	(4) The Board provide increased grant opportunities to organizations
13	developing and maintaining Vermont's trail networks.
14	(5) The Board prioritize village center revitalization when funding
15	housing projects and historic building renovation.
16	(6) The Board expand the Farm and Forest Viability Program to serve
17	more farm and forest enterprises with one-on-one financial planning and
18	business assistance, to include outdoor recreation enterprises and to provide
19	access to farm and forestland for new owners.

1	(7) A pilot program be created under the Historic Barns Preservation
2	Grant Program to assist farmers and barn owners in renovating barns along
3	designated scenic travel corridors.
4	Sec. 3. 10 V.S.A. § 312 is amended to read:
5	§ 312. CREATION OF VERMONT HOUSING AND CONSERVATION
6	TRUST FUND
7	(a) There is created a special fund in the State Treasury to be known as the
8	"Vermont Housing and Conservation Trust Fund." The Fund shall be
9	administered by the Board and expenditures therefrom shall only be made to
10	implement and effectuate the policies and purposes of this chapter. The Fund
11	shall be comprised composed of 50 percent of the revenue from the property
12	transfer tax under 32 V.S.A. chapter 231 and any monies from time to time
13	appropriated to the Fund by the General Assembly or received from any other
14	source, private or public, approved by the Board. Unexpended balances and
15	any earnings shall remain in the Fund for use in accord with the purposes of
16	this chapter.
17	(b) It is the intent of the General Assembly that the Fund and its revenue
18	source shall remain intact and inviolate for the purposes set out in this section.
19	No portion of the revenues dedicated to the Fund shall ever be available to use
20	for another governmental purpose.

3	(a) Creation. There is established an a Historic Barns Preservation Grant
4	Program which that shall be administered by the Division for Historic
5	Preservation in the Agency of Commerce and Community Development.
6	Grants shall be made available to barn owners for:
7	(1) restoring historic barns; and
8	(2) restoring and maintaining barns located on a State Scenic Road or
9	Byway as designated under 19 V.S.A. § 2501.
10	(b) Grant Requests. A request under this section shall not exceed 75
11	percent of the total project cost or \$15,000.00, whichever is less.
